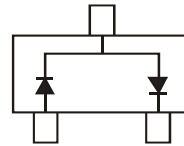

Top View



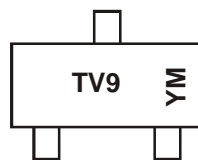
Top View

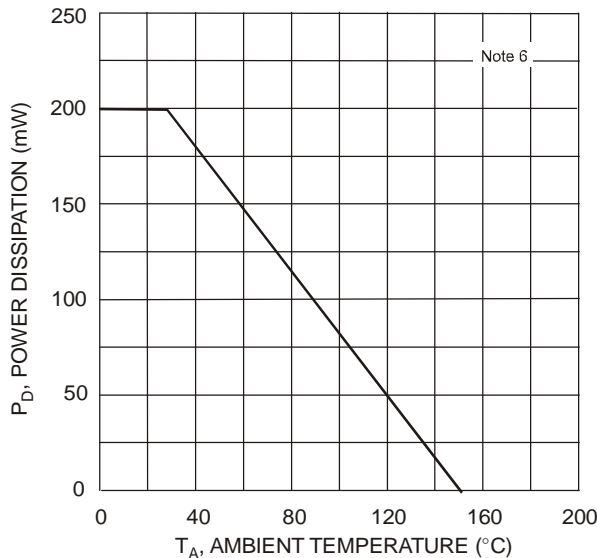


Fig. 1 Power Derating Curve, Total Package

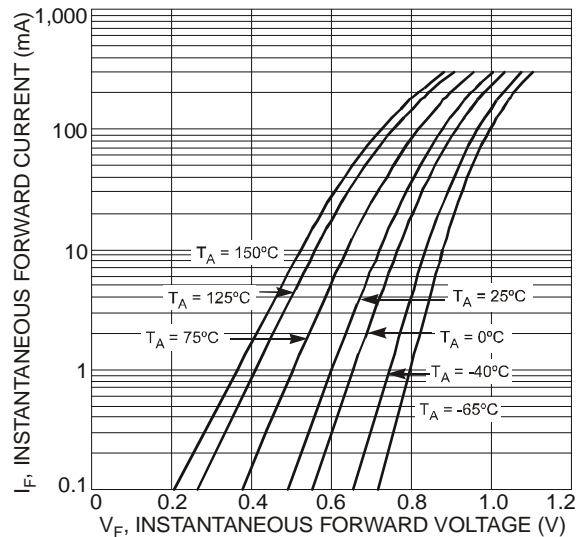
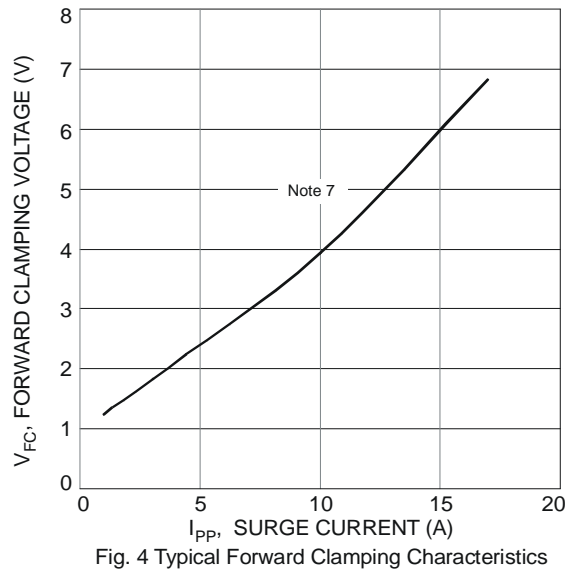
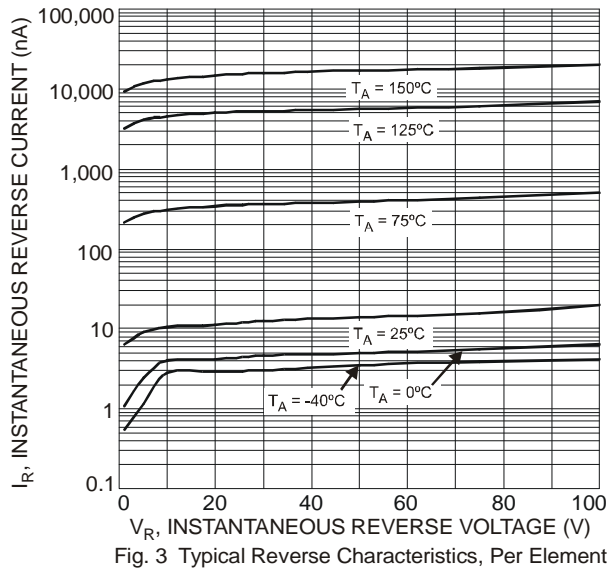
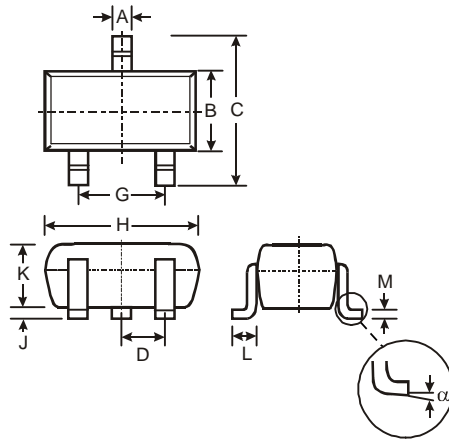


Fig. 2 Typical Forward Characteristics, Per Element

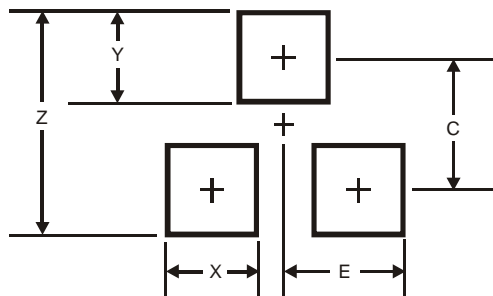
