



Top View Pin Configuration






















Figure 6 On-Resistance Variation with Temperature










Figure 7 On-Resistance Variation with Temperature



 $V_{SD}$  , SOURCE-DRAIN VOLTAGE (V) Figure 9 Diode Forward Voltage vs. Current







Figure 8 Gate Threshold Variation vs. Junction Temperature





Figure 13 Transient Thermal Resistance


