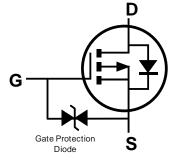

Figure 11. Gate Charge

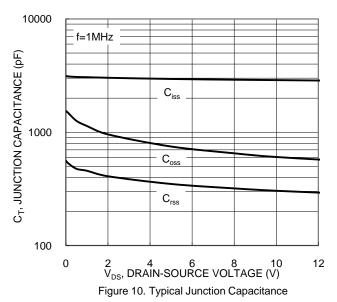
