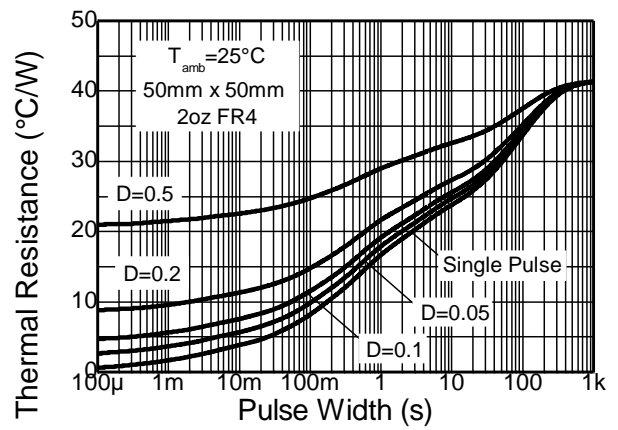

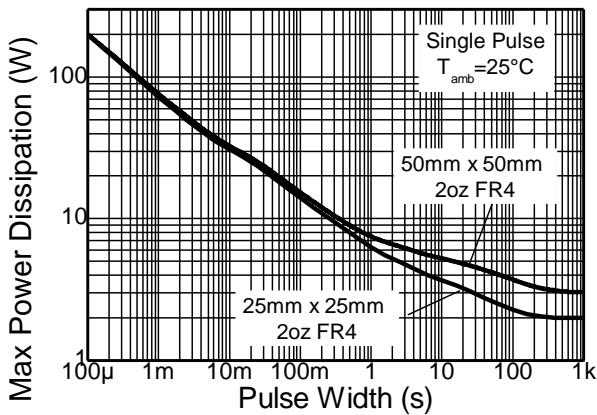
**Safe Operating Area**



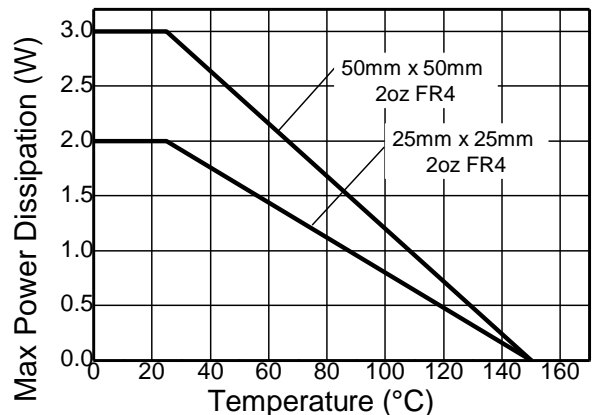
**Transient Thermal Impedance**

**Pulse Power Dissipation**



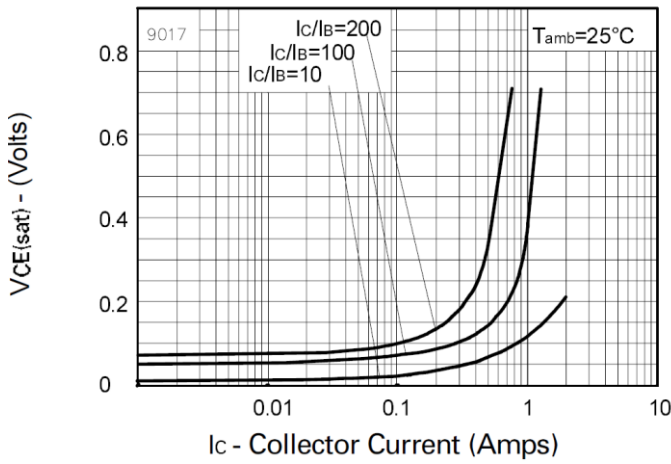
**Derating Curve**

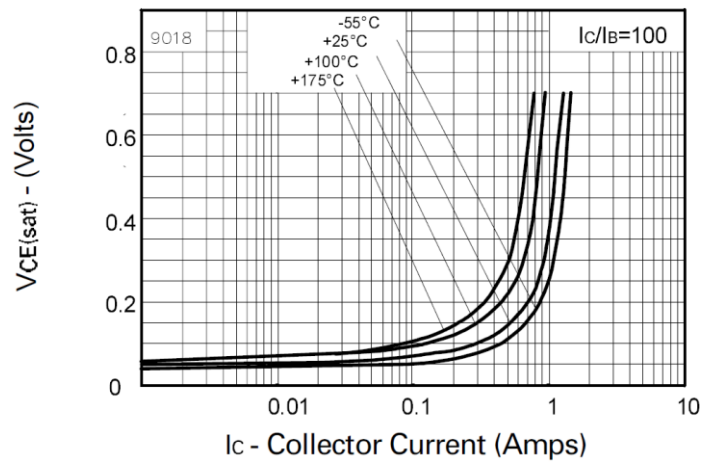

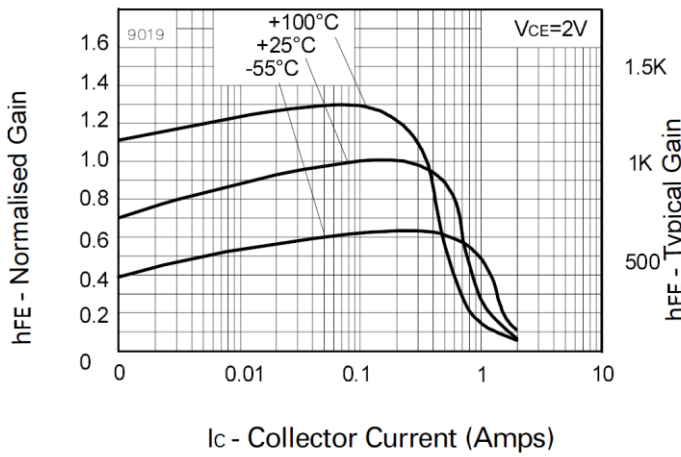

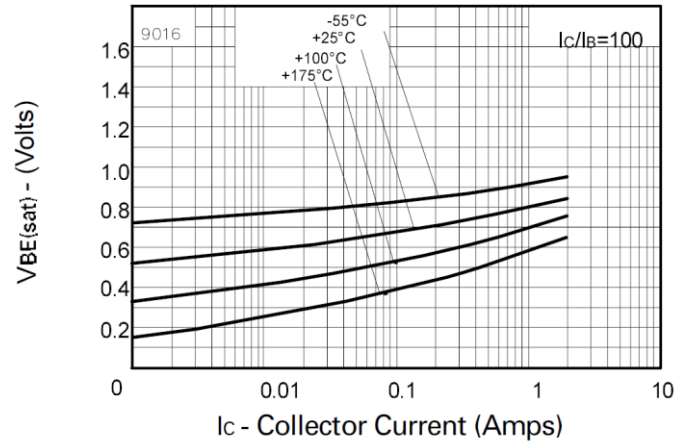
**$V_{CE(sat)}$  v  $I_C$**



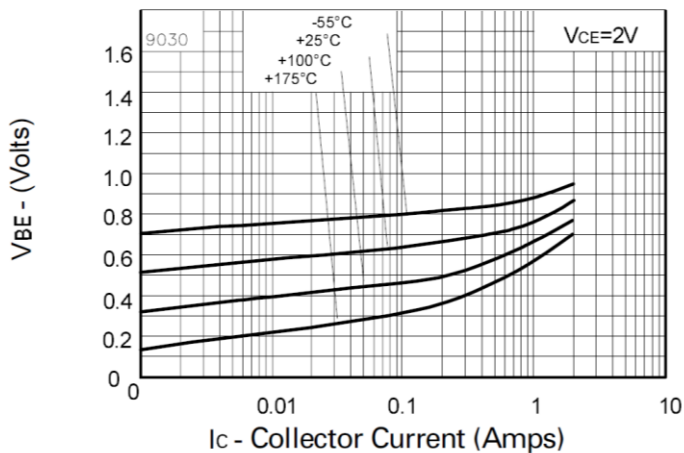
**$V_{CE(sat)}$  v  $I_C$**



**$h_{FE}$  v  $I_C$**



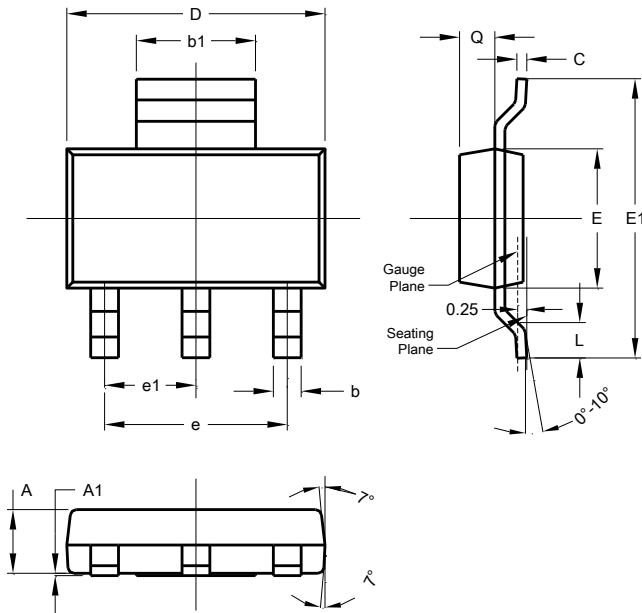
**$V_{BE(sat)}$  v  $I_C$**

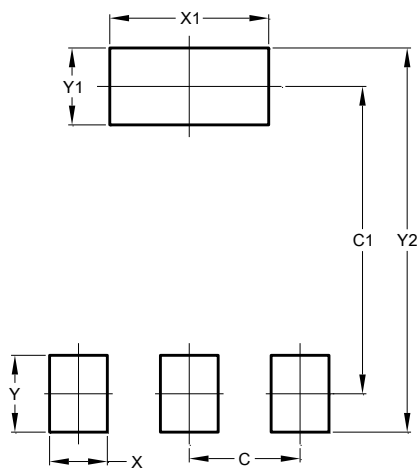
