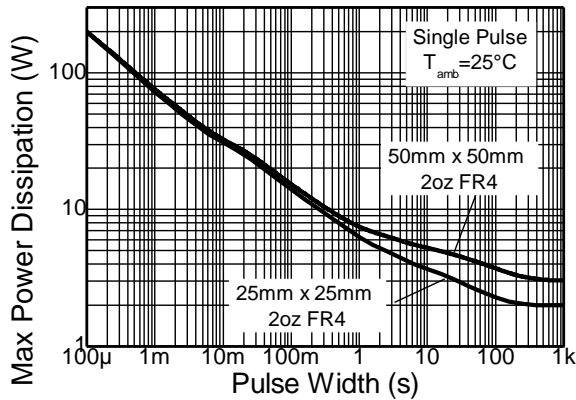

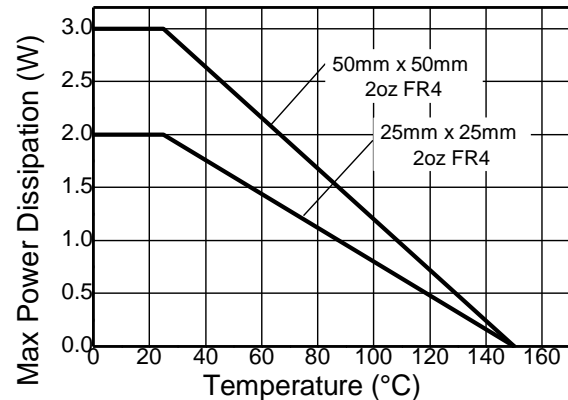
**Transient Thermal Impedance**

**Pulse Power Dissipation**



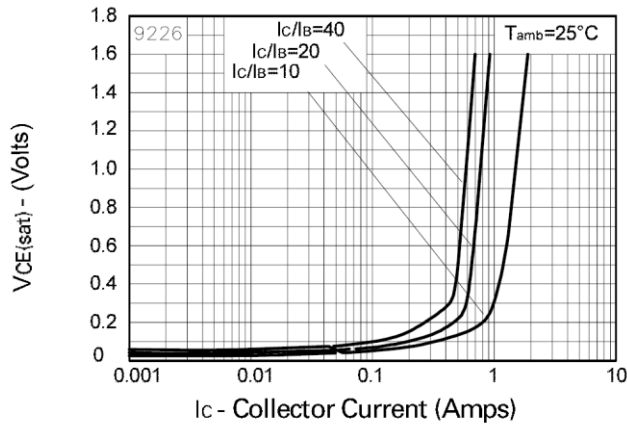
**Derating Curve**

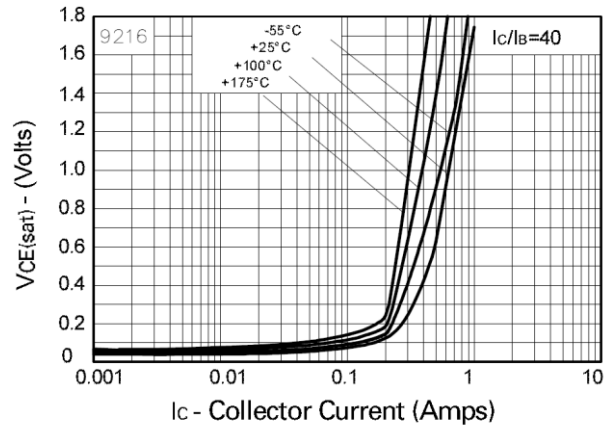

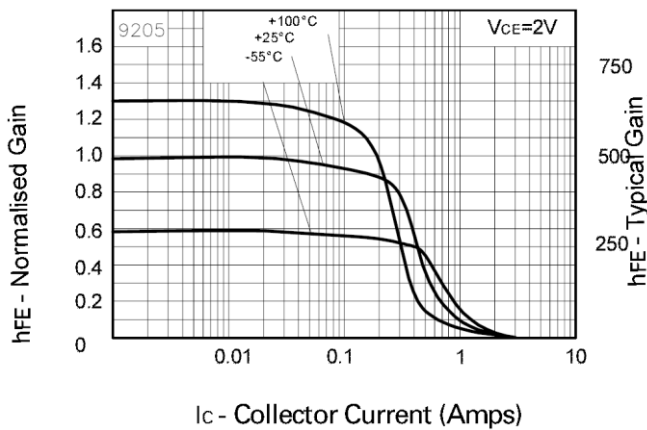

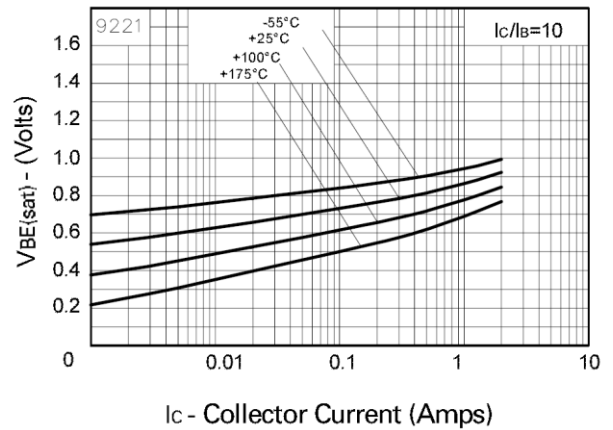
**VCE(sat) v IC**



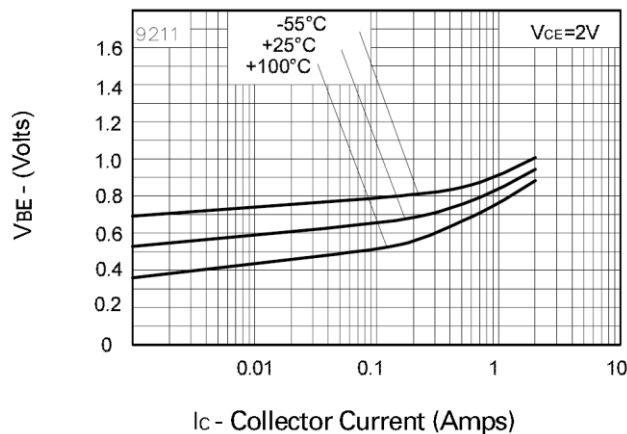
**VCE(sat) v IC**



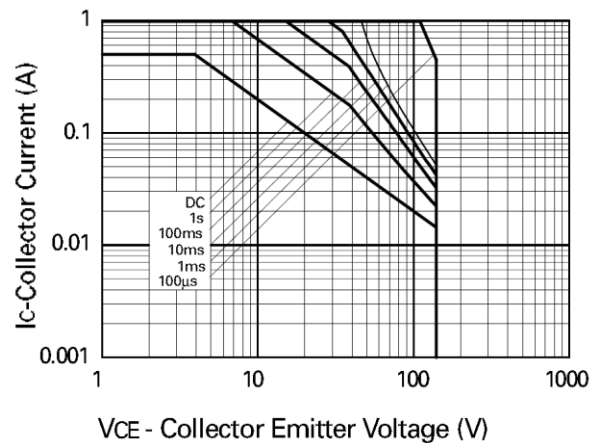
**hFE v IC**

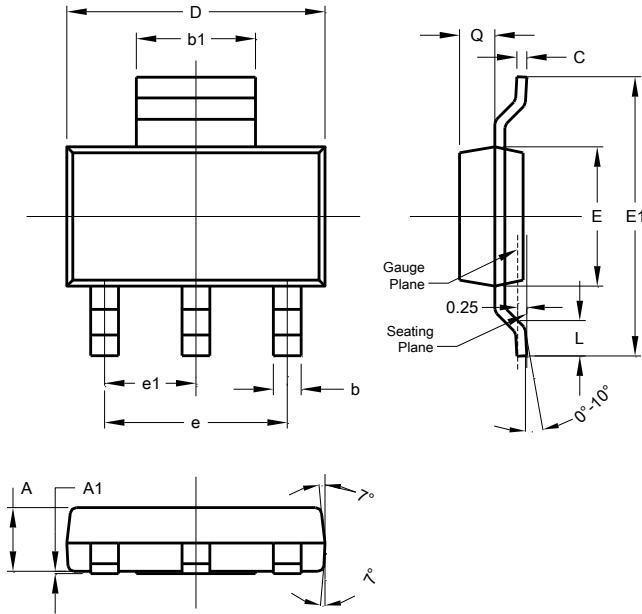
**VBE(on) v IC**

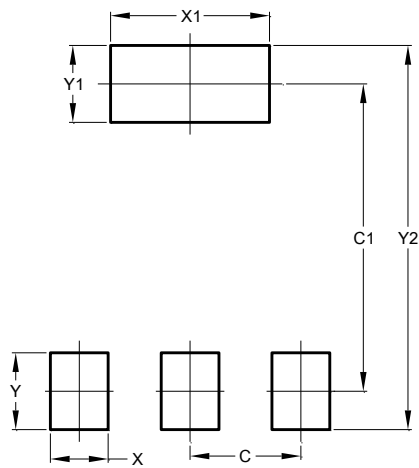
