# **Block Diagram**


### Description

The series is designed to monitor power supplies in  $\mu$ P and digital systems. It provides excellent circuit reliability and low cost by eliminating external components and adjustments, and a debounced manual reset input.

This device performs a single function: it asserts a reset signal whenever the  $V_{CC}$  supply voltage falls below a preset threshold or whenever manual reset is asserted. Reset remains asserted for an internally programmed interval (reset timeout period) after  $V_{CC}$  has risen above the reset threshold or manual reset is deasserted.

The PT7M6315USxx devices are open-drain RESET output. They can be pulled up to a voltage higher than  $V_{CC}$ .

The serials come with factory-trimmed, reset threshold voltages in 100mV increments from 1.8V to 5V. Preset timeout periods of 200ms (typ.) for PT7M6315USxxD3, 1570ms (typ.) for PT7M6315USxxD4, and 26ms for PT7M6315USxxD2 are available.



### **Function Description**

#### **Power Monitor**

A microprocessor's ( $\mu$ P) reset input starts the  $\mu$ P in a known state. Whenever the  $\mu$ P is in an unknown state, it should be held in reset. The supervisory circuits assert reset during power-up and prevent code execution errors during power down or brownout conditions.

On power up, once Vcc reaches about 1.0V,  $\overline{\text{RST}}$  is a guaranteed logic low of 0.4V or less. As Vcc rises,  $\overline{\text{RST}}$  stays low. When Vcc rises above the reset threshold V<sub>RST</sub>, an internal timer releases  $\overline{\text{RST}}$  after about 200ms (PT7M6315USxxD3) or 1570ms (PT7M6315USxxD4) or 26ms (PT7M6315USxxD2) or 1.6ms (PT7M6315USxxD1).  $\overline{\text{RST}}$  asserts whenever Vcc drops below the reset threshold, i.e. brownout condition. If brownout occurs in the middle of a previously initiated reset pulse, the pulse continues for at least another 200ms (PT7M6315USxxD3) or 1570ms (PT7M6315USxxD4) or 26ms (PT7M6315USxxD2) or 1.6ms (PT7M6315USxxD4) or 26ms (PT7M6315USxxD2) or 1.6ms (PT7M6315USxxD1). On power down, once Vcc falls below the reset threshold,  $\overline{\text{RST}}$  stays low and is guaranteed to be 0.4V or less until Vcc drops below 1V.

#### **Manual Reset**

The manual-reset input  $(\overline{MR})$  allows reset to be triggered by a push button switch. The switch is effectively debounced by the 1.6ms (PT7M6315USxxD1) or 26ms (PT7M6315USxxD2) or 200ms (PT7M6315USxxD3) or 1570ms (PT7M6315USxxD4) reset pulse width.






