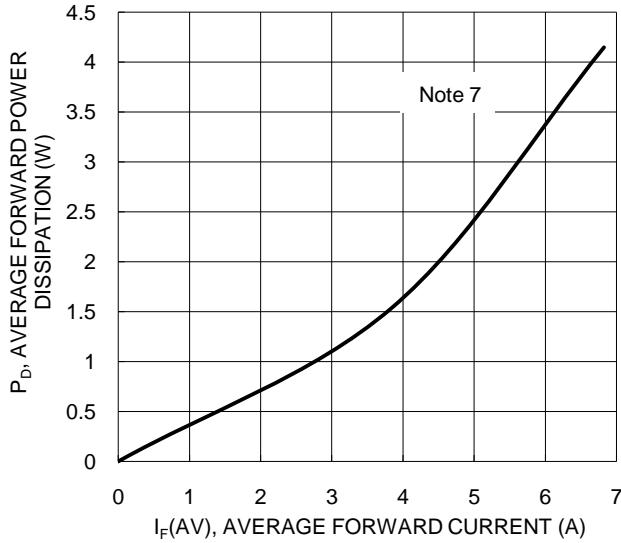


Figure 1 Forward Power Dissipation

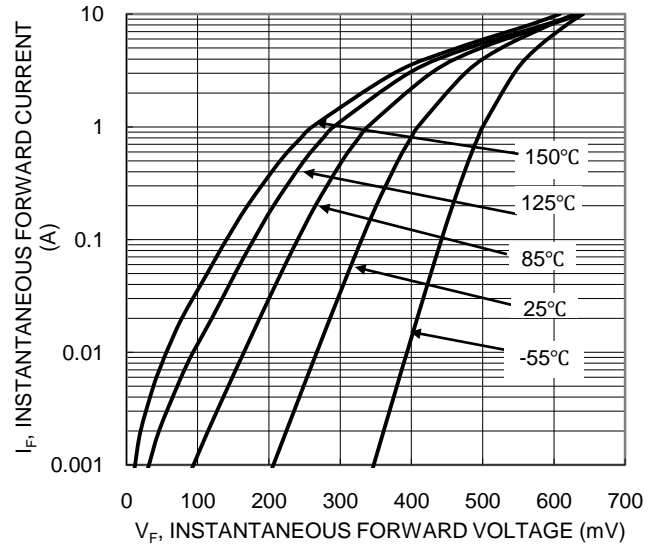


Figure 2 Typical Forward Characteristics

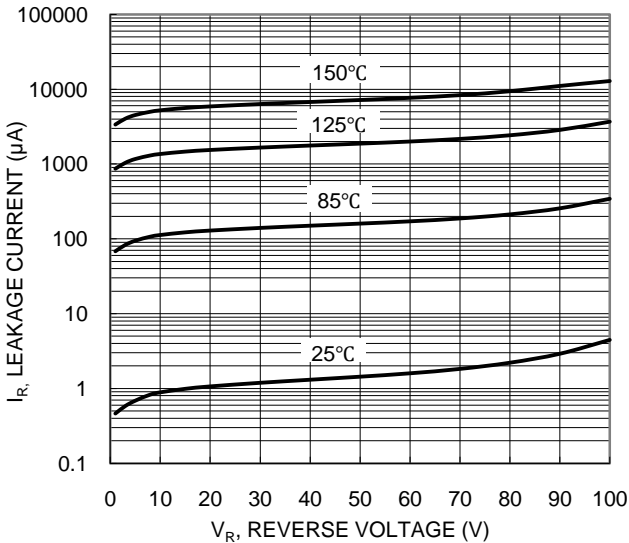


Figure 3 Typical Reverse Characteristics

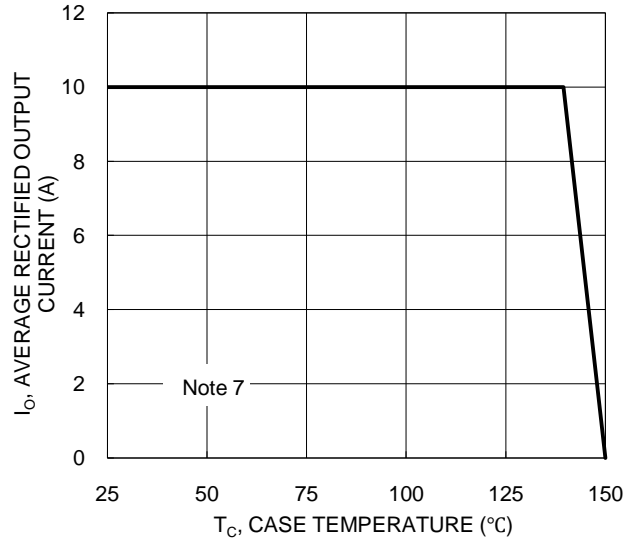


Figure 4 DC Forward Current Derating

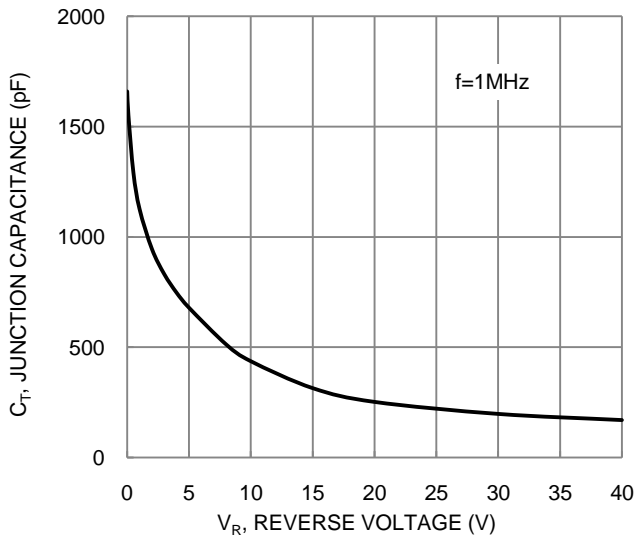


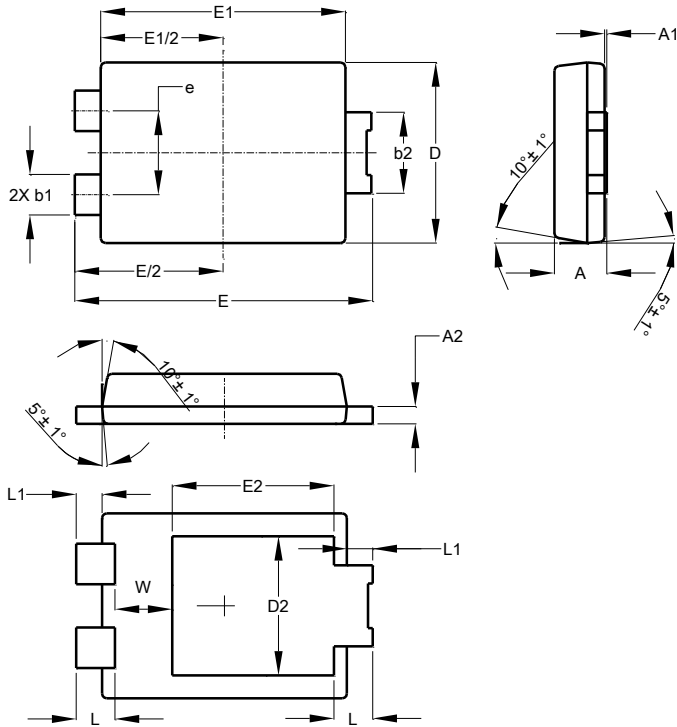
Figure 5 Total Capacitance vs. Reverse Voltage

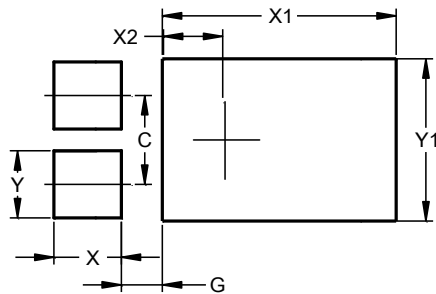
