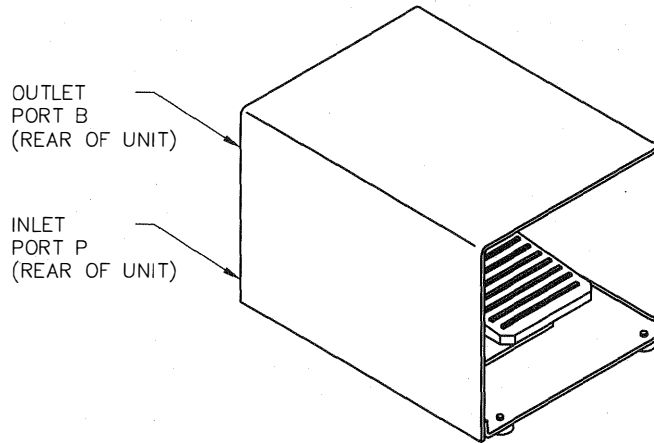


# WA10A FOOT PEDAL

## GENERAL SPECIFICATIONS

- \* The WA10A Foot Pedal is designed to be used with Daniels pneumatic crimp tools like the WA22 series and WA27 series.
- \* Either the hand operated valve or the WA10A Foot Valve may be used with the pneumatic tools. The working pressure of the tools is 80–120 PSI. It is recommended that each tool be set up with a Regulator and a Filter (Daniels WA27RF).
- \* All Crimp Tools, Positioning Heads, Bench Mounts, Gages and Foot Valves must be ordered separately by part number.

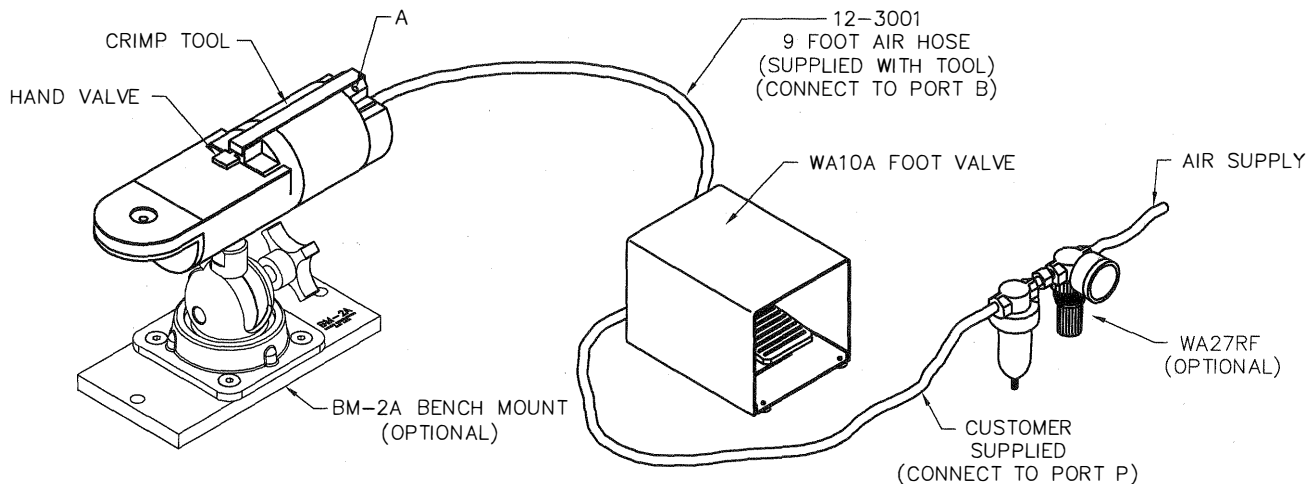

## FOOT VALVE OPERATION WITH DANIELS PNEUMATIC TOOLS

Attach Foot Valve between air supply and tool air inlet as shown in Figure 2. Depress hand valve and lock in down position with the set screw (A) using a 1/16 hex Allen wrench.

### CARE OF THE FOOT PEDAL

It is a good practice to keep the Foot Pedal free of debris. Any debris that accumulates in the Foot Pedal may be blown out with compressed air.

We strongly recommend that you:

1. DO NOT immerse the Foot Pedal in any cleaning solution.
2. DO NOT spray oil into the Foot Pedal to lubricate.
3. DO NOT attempt to disassemble the Foot Pedal or make repairs.
