

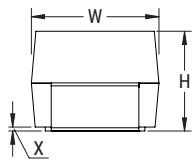

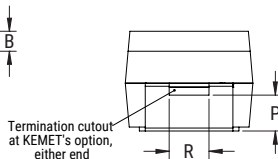
CATHODE (-) END VIEW



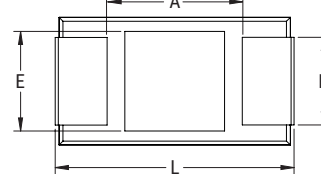
SIDE VIEW
