#### 14.2 Assembling

Products can be applied to reflow and flow soldering.

< Thermal Shock >

Pre-heating should be in such a way that the temperature difference between solder and ceramic surface is limited to 100°C max. Also cooling into solvent after soldering should be in such a way that the temperature difference is limited to 100°C max. Not enough preheating may cause deterioration in insulation resistance and / or crank or ceramic body.

#### 14.3 Cleaning Conditions

Products shall be cleaned on the following conditions.


#### 14.4 Resin coating

The impedance value may change due to high cure-stress of resin to be used for coating/molding products.   - •Products shall not be arranged on the line of a series of holes when there are big holes in P.C.B. (Because the stress concentrate on the line of holes.)
- < Products Placing >
  - •Support pins shall be set under P.C.B. to prevent causing a warp to P.C.B. during placing the products on the other side of P.C.B..
- < P.C.B. Separation >
  - •P.C.B. shall not be separated with hand. P.C.B. shall be separated with the fixture so as not to cause P.C.B. bending.

- · Pre-heating: 150°C, 1 min
- · Soldering iron output: 30W max.
- Tip temperature: 350°C max.
- · Tip diameter:φ3mm max.
- Soldering time : 3(+1,-0) seconds. Times : 2times max.

Notes: Do not touch the products directly with the soldering iron.

#### 14.10 Handling of a substrate

After mounting products on a substrate, do not apply any stress to the product caused by bending or twisting to the substrate when cropping the substrate, inserting and removing a connector from the substrate or tightening screw to the substrate.
