





Fig. 1. Forward current as a function of forward voltage




- (1) V_R = V_{Rmax}; maximum values




Fig. 5. Maximum forward current as a function of ambient temperature; derating curve





Fig. 6. Maximum continuous reverse voltage as a function of the ambient temperature





Fig. 8. Package outline TO-236AB (SOT23)
