




Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values




Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values




Fig. 4. Forward current as a function of forward voltage; typical values




Fig. 5. Forward current as a function of forward voltage; typical values; (logarithmic scale)




Fig. 6. Reverse current as a function of reverse voltage; typical values





Fig. 7. Diode capacitance as a function of reverse voltage; typical values.









Fig. 10. Package outline DFN1006D-2 (SOD882D)
