




Fig. 2. Forward current as a function of forward voltage; typical values




Fig. 3. Forward current as a function of forward voltage; typical values




Fig. 4. Non-repetitive peak forward current as a function of pulse duration; maximum values




Fig. 5. Reverse current as a function of reverse voltage; typical values




Fig. 6. Diode capacitance as a function of reverse voltage; typical values.





Fig. 7. Maximum continuous reverse voltage as a function of ambient temperature




