Dual high-voltage switching diodes, encapsulated in a small SOT23 (TO-236AB) Surface-Mounted Device (SMD) plastic package.

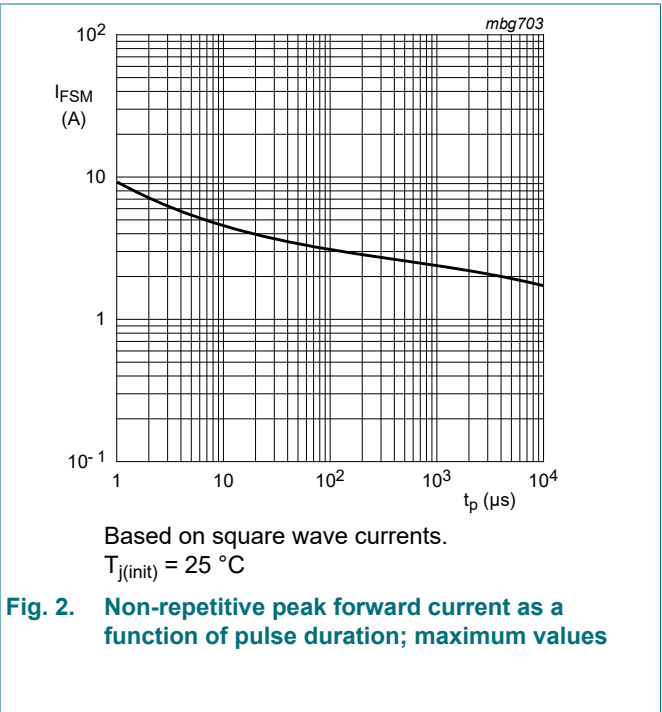
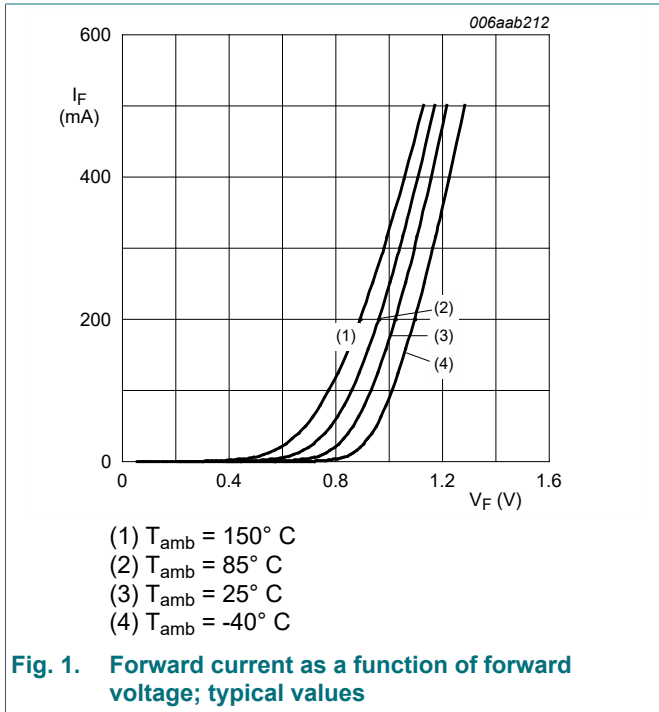

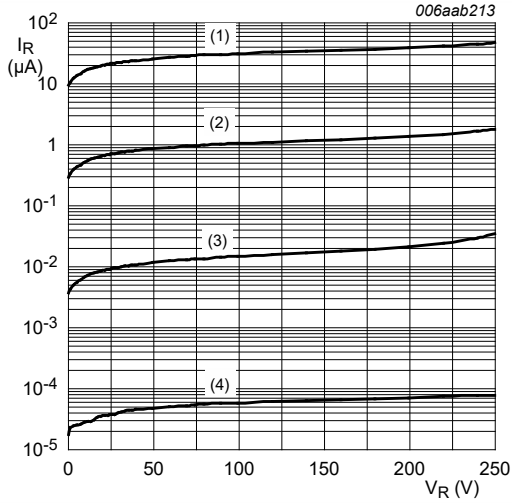

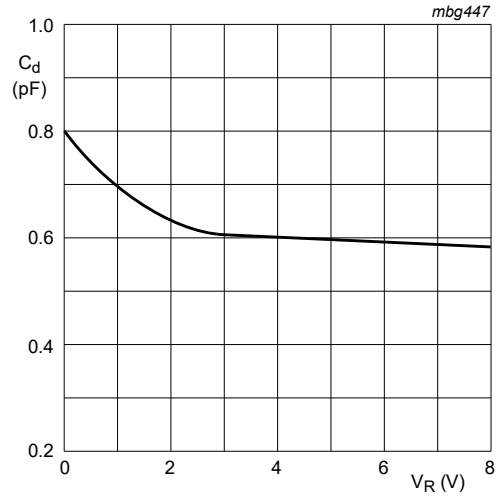

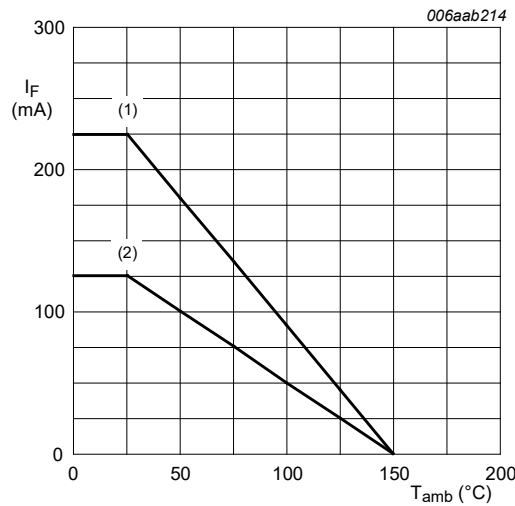

 $T_j = 25^\circ\text{C}$.

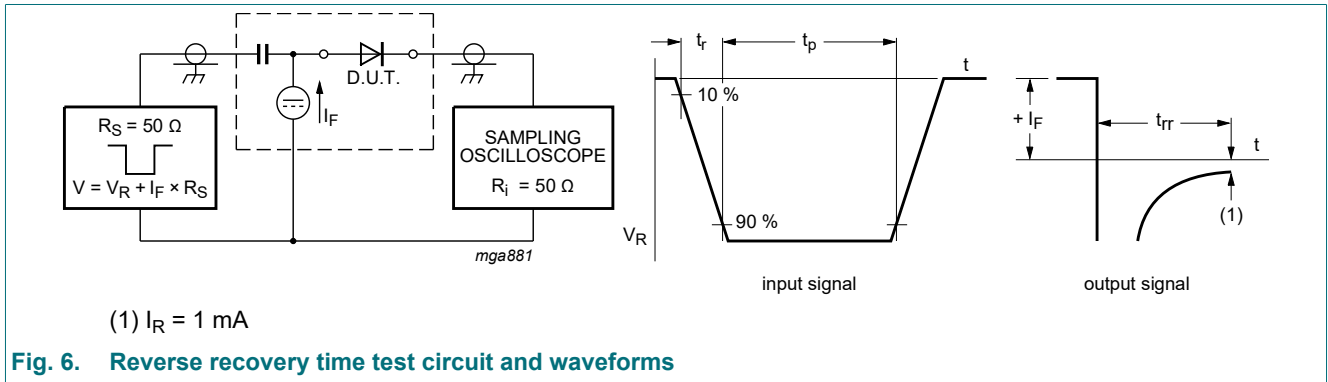
Fig. 4. Diode capacitance as a function of reverse voltage; typical values.

Fig. 5. Forward current as a function of ambient temperature; derating curves

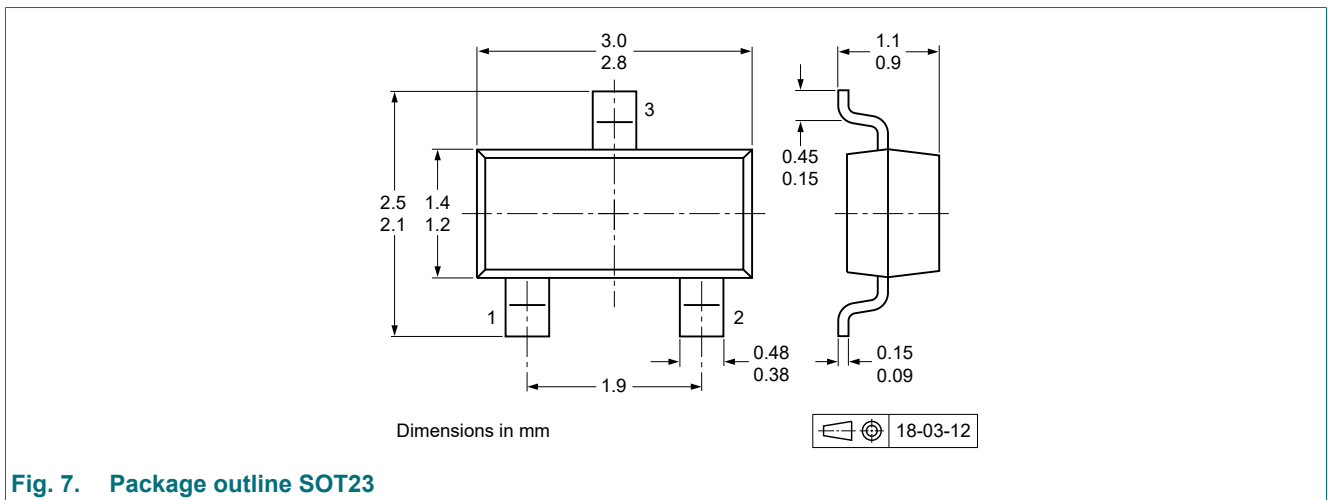

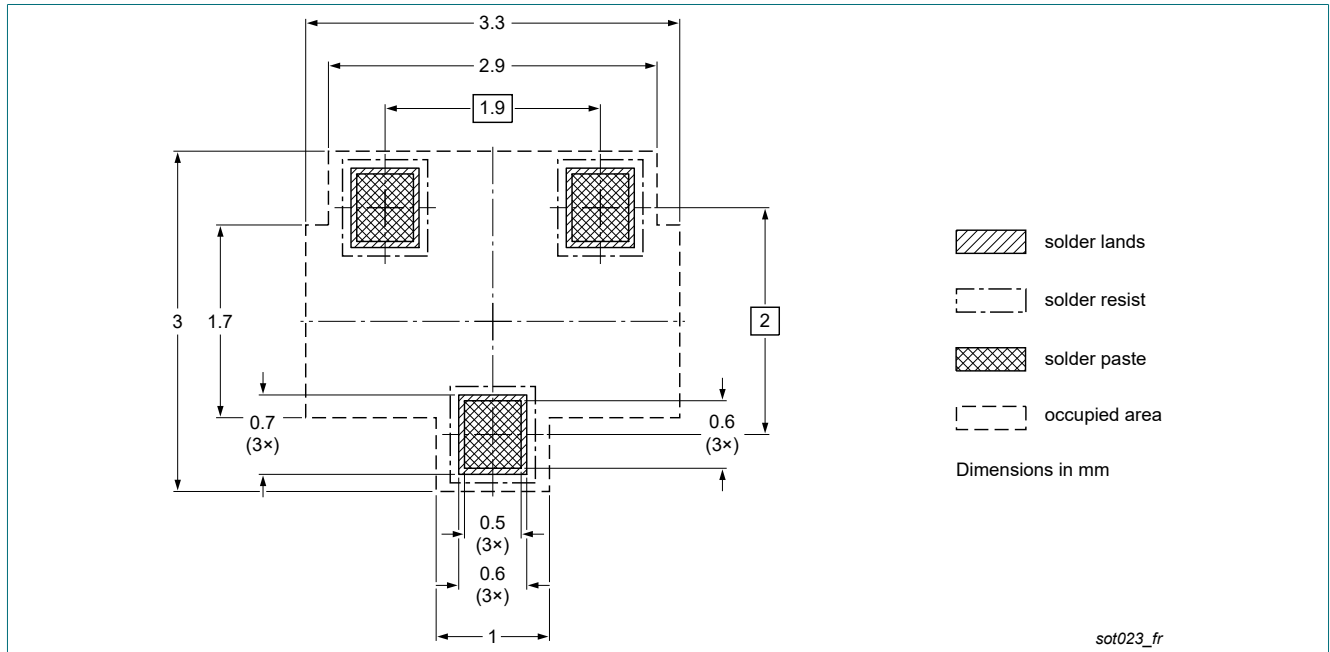


Fig. 8. Reflow soldering footprint for SOT23

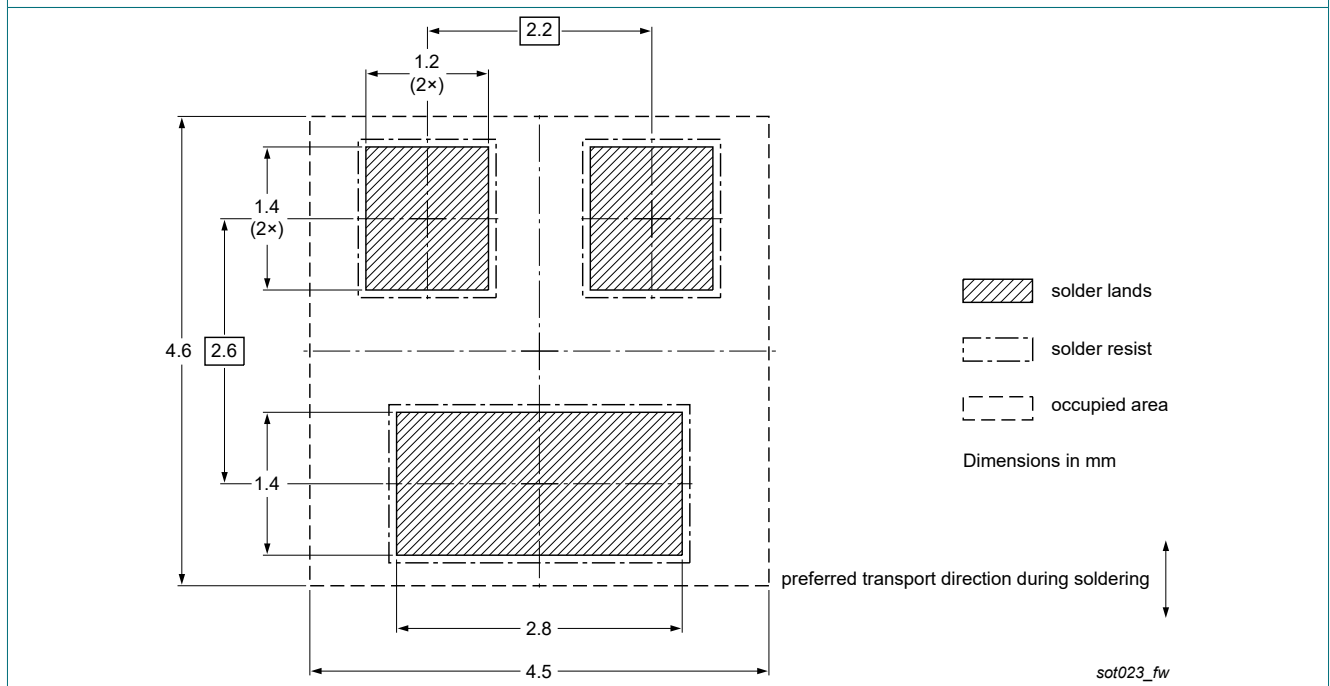


Fig. 9. Wave soldering footprint for SOT23
