






Fig 2. Per transistor: Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

Fig 4. Per transistor: Transient thermal impedance from junction to ambient as a function of pulse duration; typical values








Fig 6. Collector current as a function of collector-emitter voltage; typical values


Fig 7. Base-emitter voltage as a function of collector current; typical values


Fig 8. Base-emitter saturation voltage as a function of collector current; typical values



- (3)  $I_C/I_B = 10$


Fig 10. Collector-emitter saturation voltage as a function of collector current; typical values






Fig 13. BISS transistor switching time definition


