1. General description

Extremely low capacitance bidirectional ElectroStatic Discharge (ESD) protection diode, part of the TrEOS protection family. This device is housed in a DSN0402B-2 (SOD992B) leadless ultra small Surface-Mounted Device (SMD) package designed to protect one signal line from the damage caused by ESD and other transients.

- Extremely low diode capacitance $C_d = 0.17$ pF
- Extremely low insertion loss $\alpha_{IL} : -0.45$ dB at 10 GHz

- Extremely low clamping voltage to protect sensitive I/Os
- Extremely low inductance protection path to ground
- Ultra small SMD package




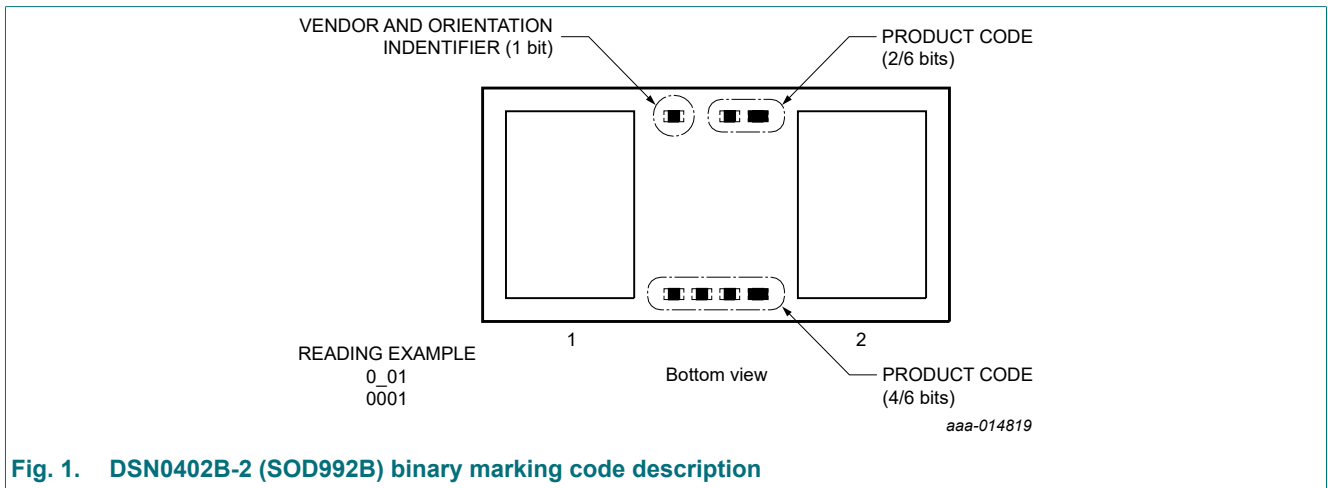


Fig. 1. DSN0402B-2 (SOD992B) binary marking code description

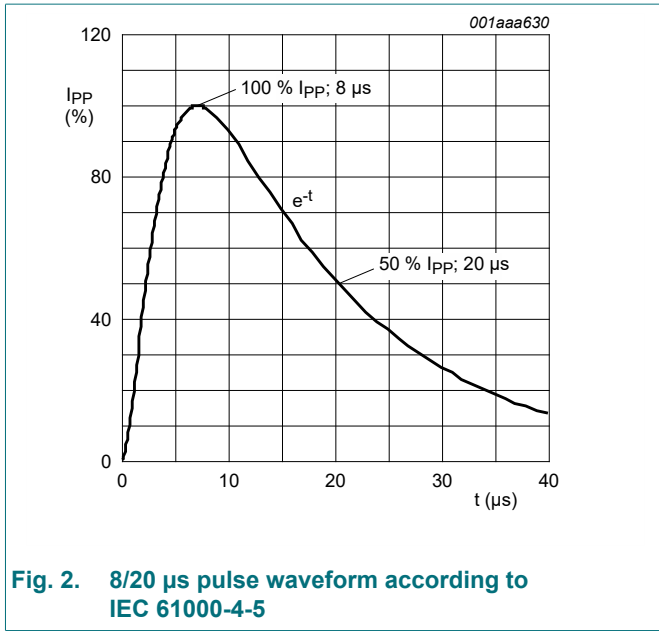


Fig. 2. 8/20 μs pulse waveform according to IEC 61000-4-5

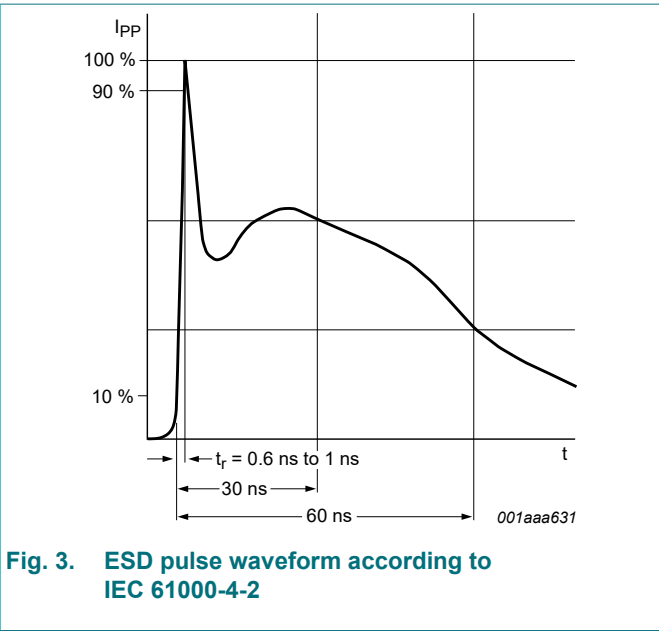


Fig. 3. ESD pulse waveform according to IEC 61000-4-2

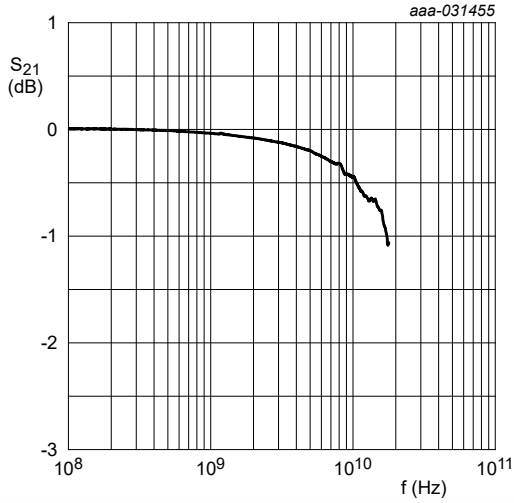


Fig. 4. Insertion loss; typical values

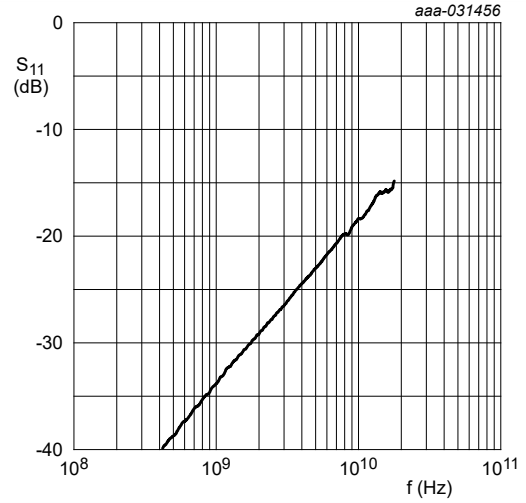


Fig. 5. Return loss; typical values

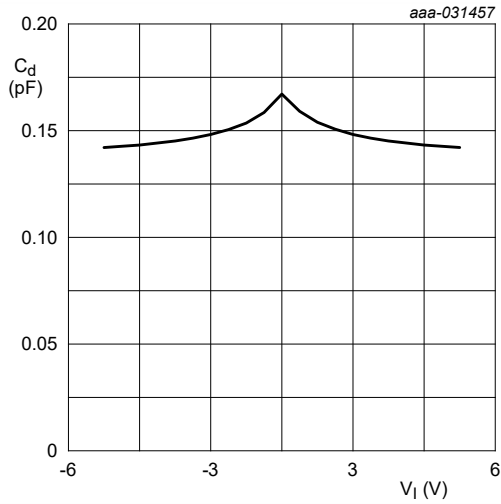
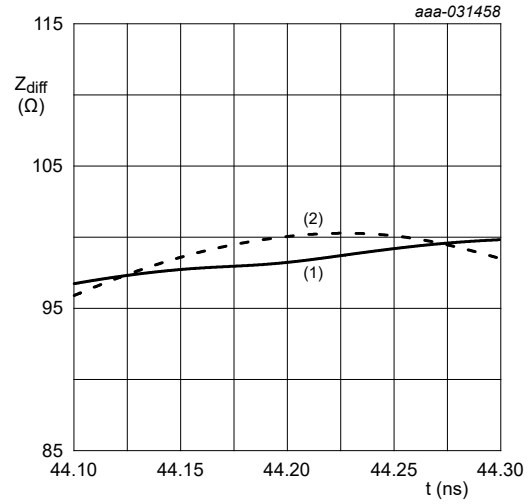
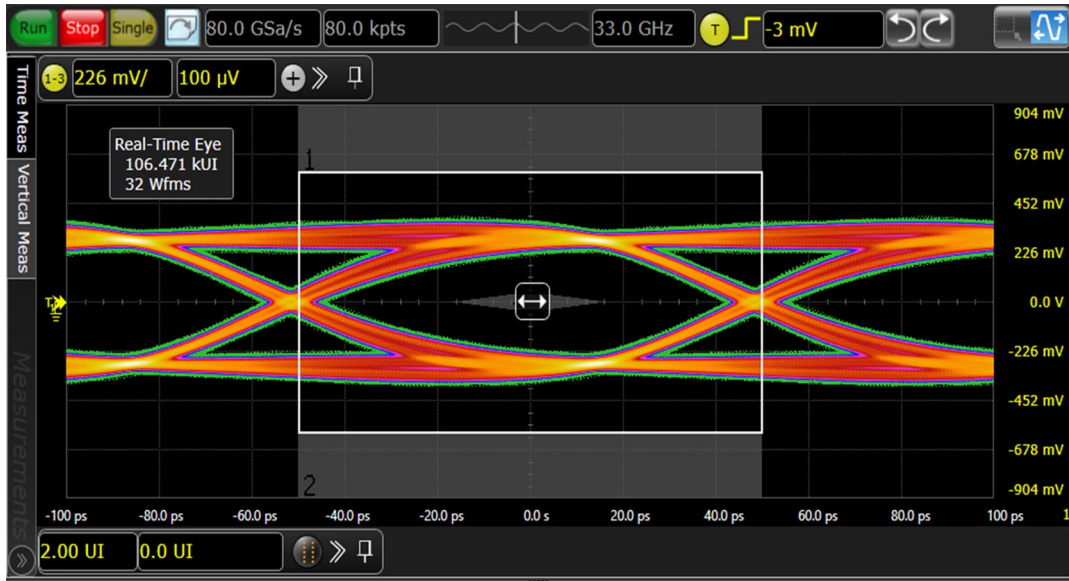


Fig. 6. Capacitance as a function of input voltage; typical values

 (2) Reference board without Device Under Test (DUT)

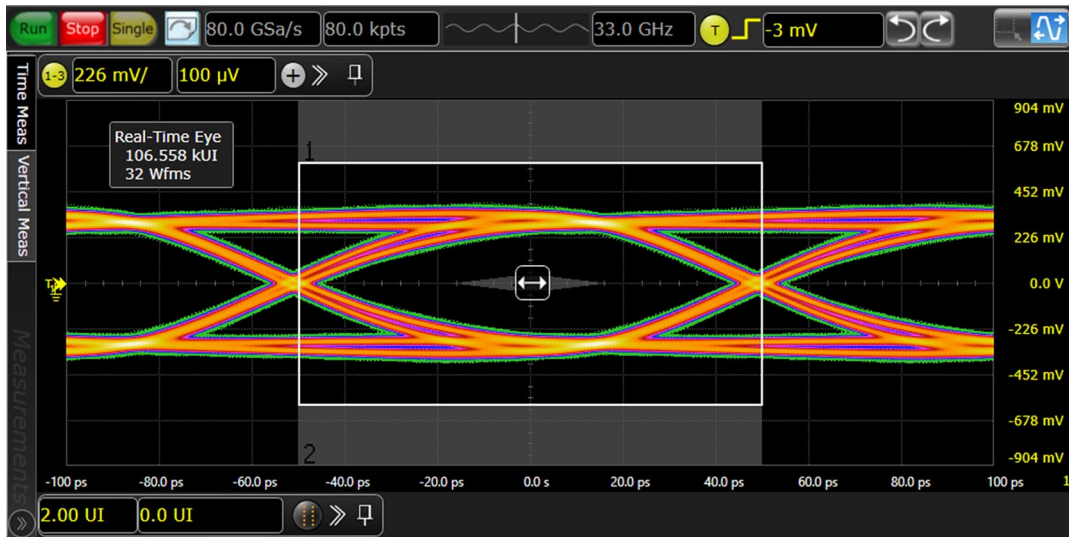
Fig. 7. Differential Time Domain Reflectometer (TDR) plot; typical values

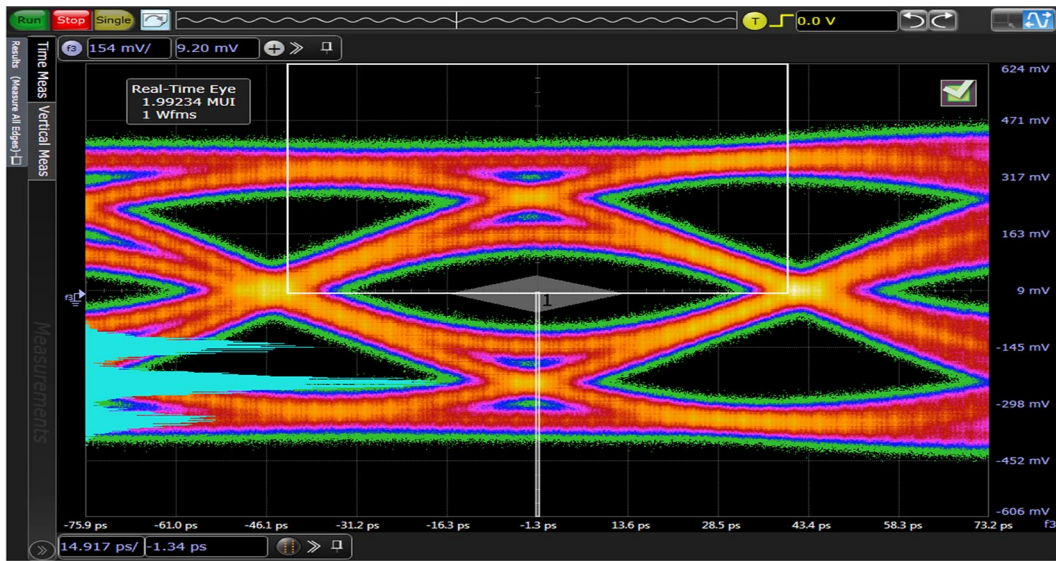
Fig. 8. USB 3.2 eye diagram, PCB with device; typical values

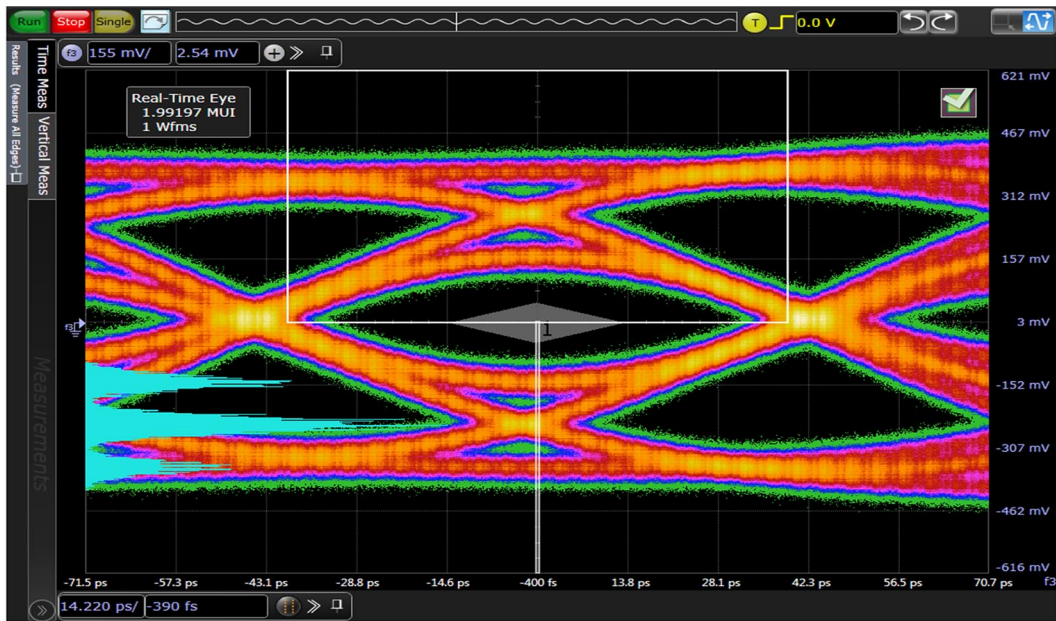

Fig. 9. USB 3.2 eye diagram, PCB without device; typical values



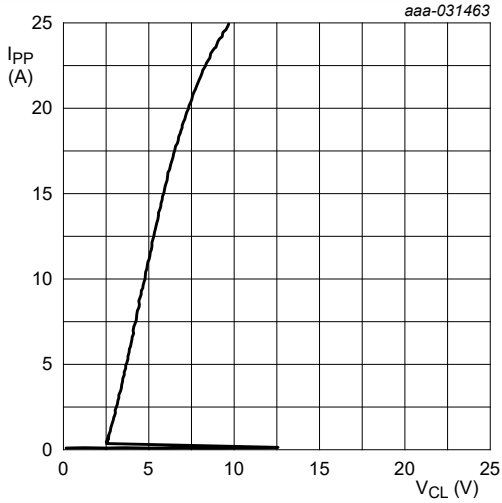

Fig. 10. HDMI 2.1 12G FRL eye diagram, WCM3, -8 dB; PCB with device; typical values



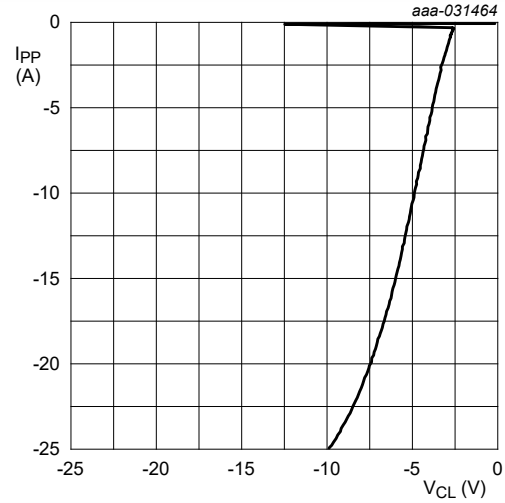

Fig. 11. HDMI 2.1 12G FRL eye diagram, WCM3; PCB without device; typical values



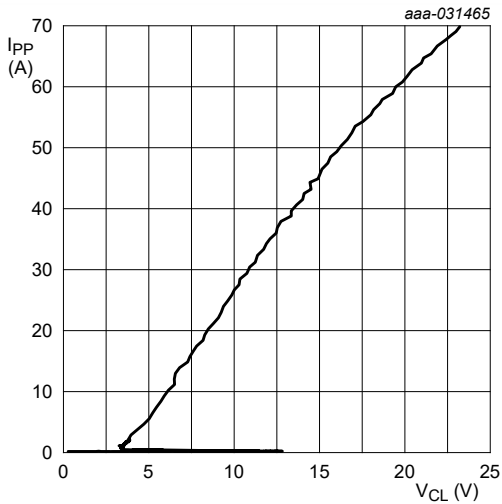

Fig. 12. Dynamic resistance with positive clamping; typical values



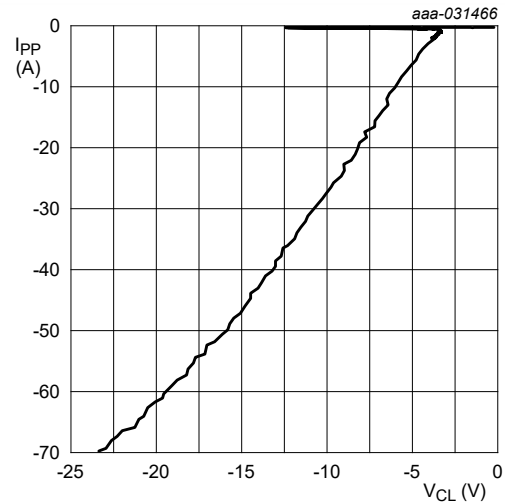

Fig. 13. Dynamic resistance with negative clamping; typical values



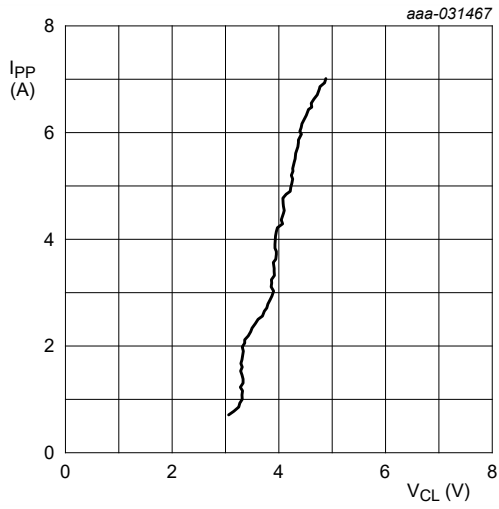

Fig. 14. Dynamic resistance with positive clamping; typical values



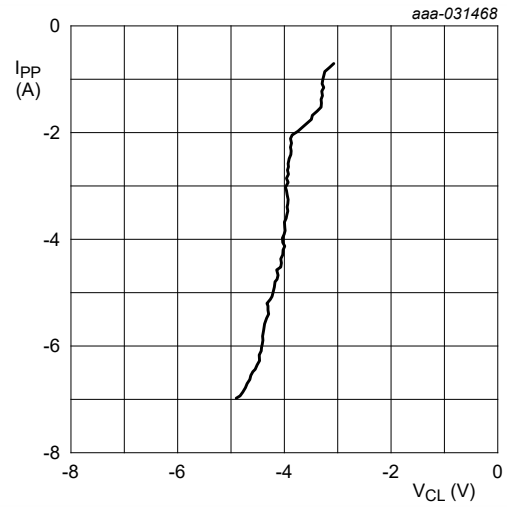

10. Application information

The device is designed for the protection of one bidirectional data line from surge pulses and ESD damage. The device is suitable on lines where the signal polarities are both positive and negative with respect to ground.

The device uses an advanced clamping structure showing a negative dynamic resistance. This snap-back behavior strongly reduces the clamping voltage to the system behind the ESD protection during an ESD event. Do not connect unlimited DC current sources to the data lines to avoid keeping the ESD protection device in snap-back state after exceeding breakdown voltage (due to an ESD pulse for instance).

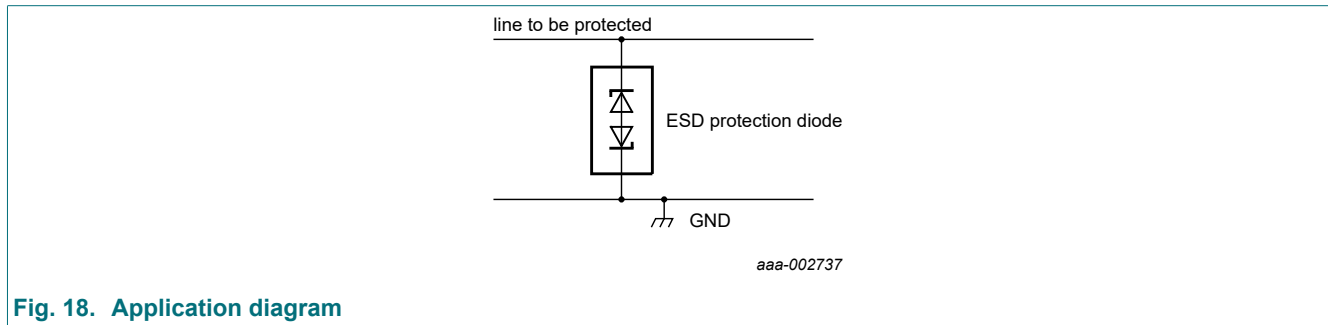


Fig. 18. Application diagram

Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

1. Place the device as close to the input terminal or connector as possible.
2. Minimize the path length between the device and the protected line.
3. Keep parallel signal paths to a minimum.
4. Avoid running protected conductors in parallel with unprotected conductors.
5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
6. Minimize the length of the transient return path to ground.
7. Avoid using shared transient return paths to a common ground point.
8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

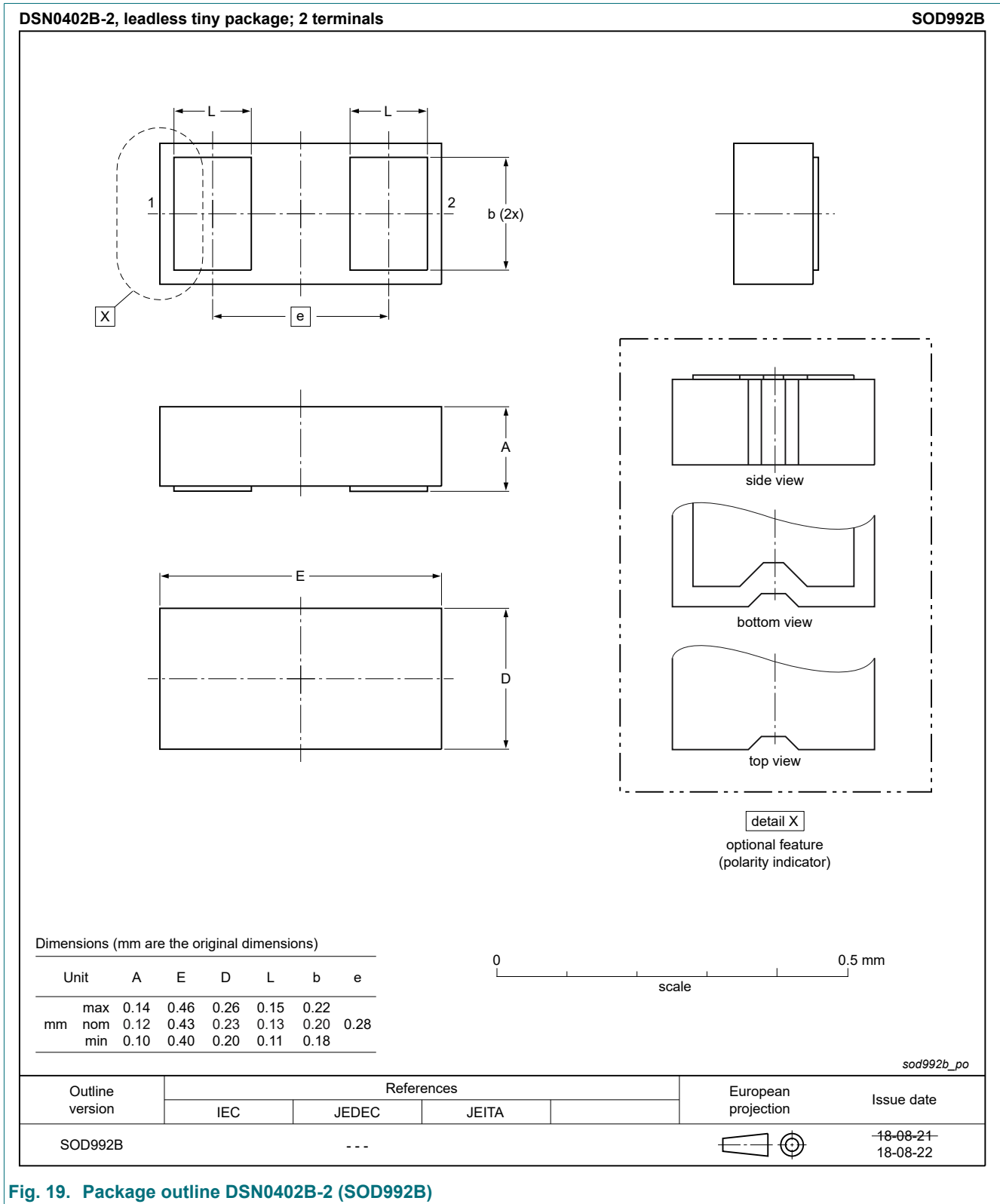


Fig. 19. Package outline DSN0402B-2 (SOD992B)

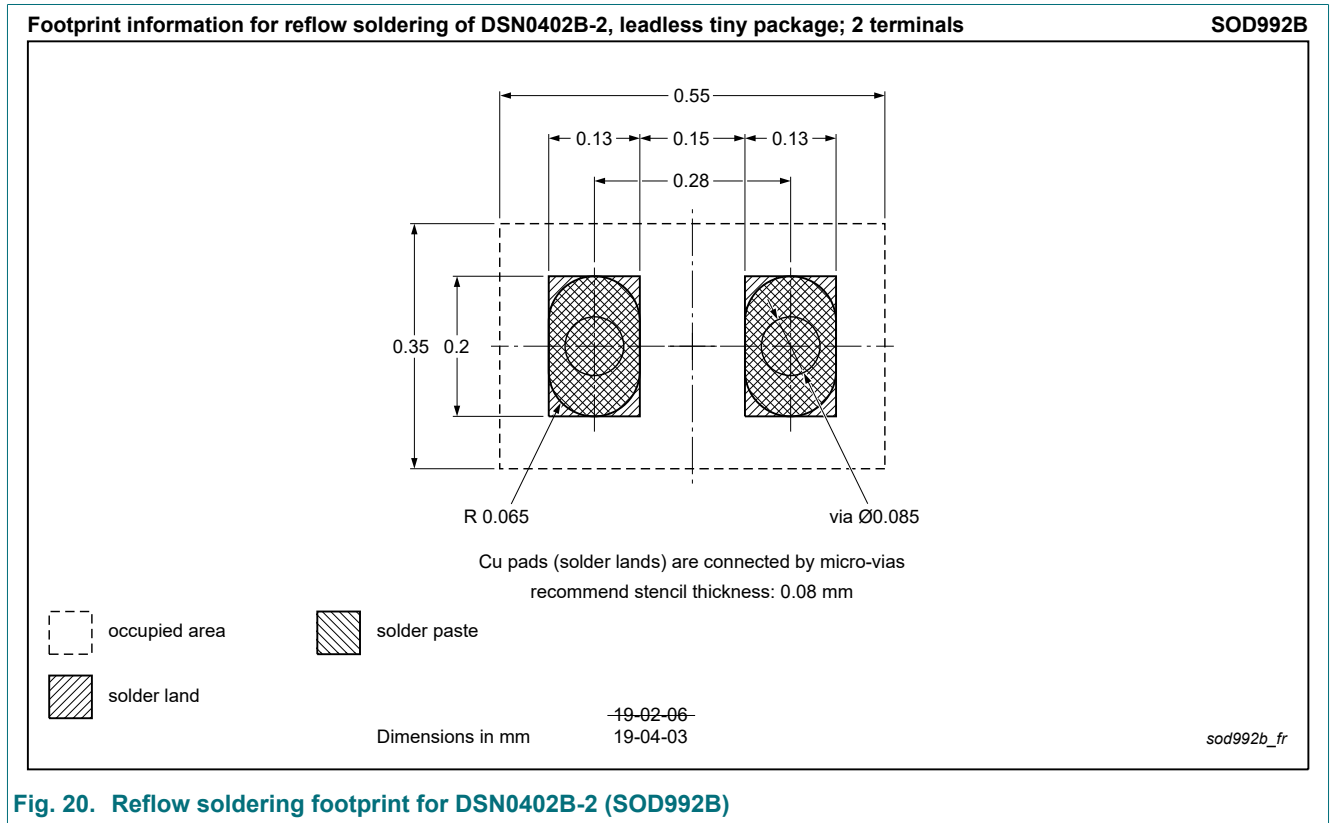


Fig. 20. Reflow soldering footprint for DSN0402B-2 (SOD992B)
