The TrEOS Protection family is optimized for safeguarding very sensitive high-speed interfaces against ESD pulses with a high level of robustness.




Fig. 1. 8/20 µs pulse waveform according to IEC 61000-4-5 and IEC 61643-321




Fig. 2. ESD pulse waveform according to IEC 61000-4-2




Fig. 3. V-I characteristics for a unidirectional ESD protection diode




Fig. 4. Diode capacitance as a function of reverse voltage; typical values




Fig. 5. Diode capacitance as a function of frequency; typical values




Fig. 6. Insertion loss; typical values




Fig. 7. Dynamic resistance with positive clamping voltage; typical values






Fig. 8. Dynamic resistance with negative clamping voltage; typical values



## 10. Application information

The device is designed for protection of one unidirectional data or signal line from the damage caused by ESD and surge pulses. The device may be used on lines where the signal polarities are either positive or negative with respect to ground. The device is not designed to be used on lines connected to a DC supply.



#### Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

- 1. Place the device as close to the input terminal or connector as possible.
- 2. Minimize the path length between the device and the protected line.
- 3. Keep parallel signal paths to a minimum.
- 4. Avoid running protected conductors in parallel with unprotected conductors.
- 5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
- 6. Minimize the length of the transient return path to ground.
- 7. Avoid using shared transient return paths to a common ground point.
- 8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.




Fig. 13. Package outline DSN0603-2 (SOD962-2)




Fig. 14. Reflow soldering footprint for DSN0603-2 (SOD962-2)
