


30 V, N-channel Trench MOSFET



30 V, N-channel Trench MOSFET

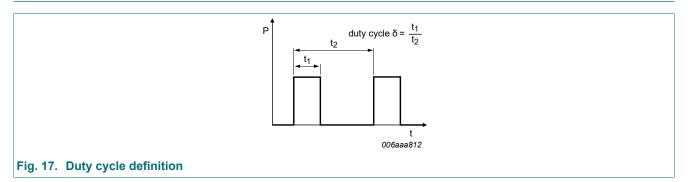




