
12 V, P-channel Trench MOSFET



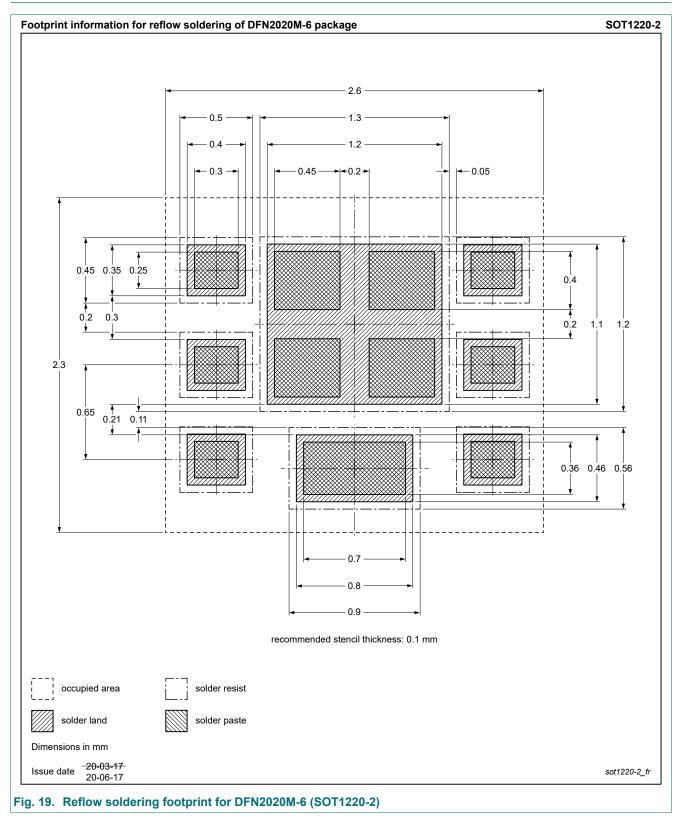
