






Fig 4. Transient thermal impedance from junction to mounting base as a function of pulse duration






Fig 5. Forward transconductance as a function of

Fig 6. Transfer characteristics: drain current as a function of gate-source voltage; typical values





Fig 8. Drain-source on-state resistance as a function of gate-source voltage; typical values

Output characteristics: drain current as a Fig 9. function of drain-source voltage; typical values





Fig 11. Sub-threshold drain current as a function of gate-source voltage

Fig 10. Gate-source threshold voltage as a function of junction temperature




Fig 12. Normailzed drain-source on-state resistance factor as a function of junction temperature





Fig 13. Drain-source on-state resistance as a function of drain current; typical values





Fig 14. Gate charge waveform definitions




Fig 17. Source current as a function of source-drain voltage; typical values

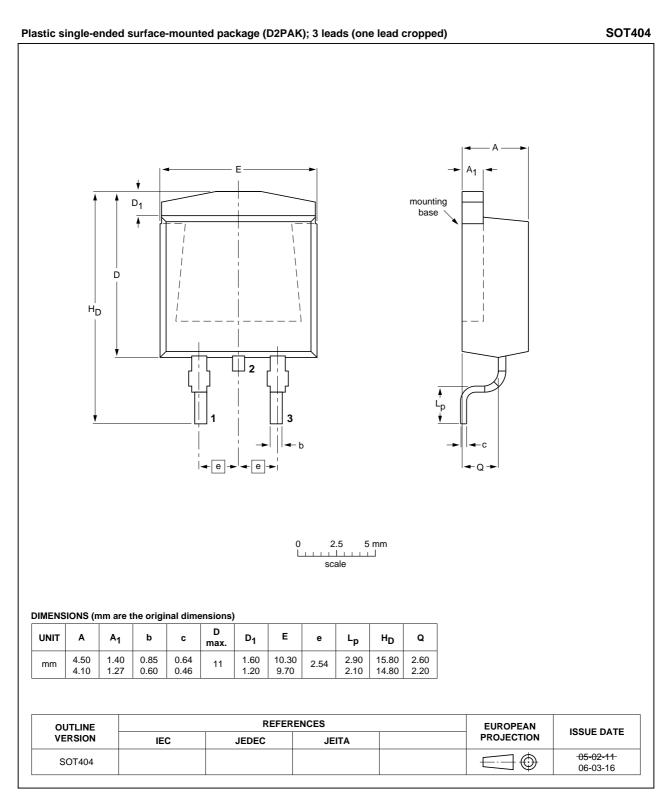


Fig 18. Package outline SOT404 (D2PAK)
