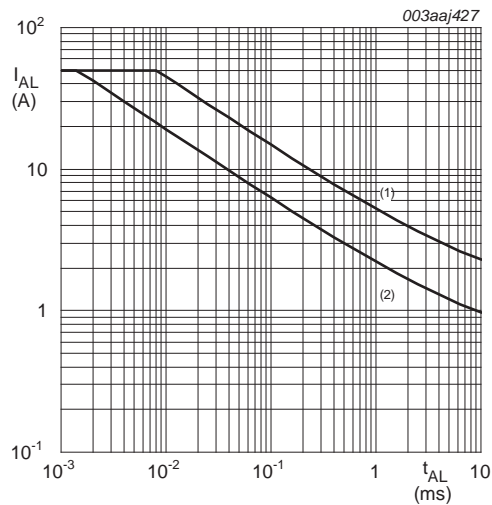

**Fig. 1. Continuous drain current as a function of mounting base temperature**



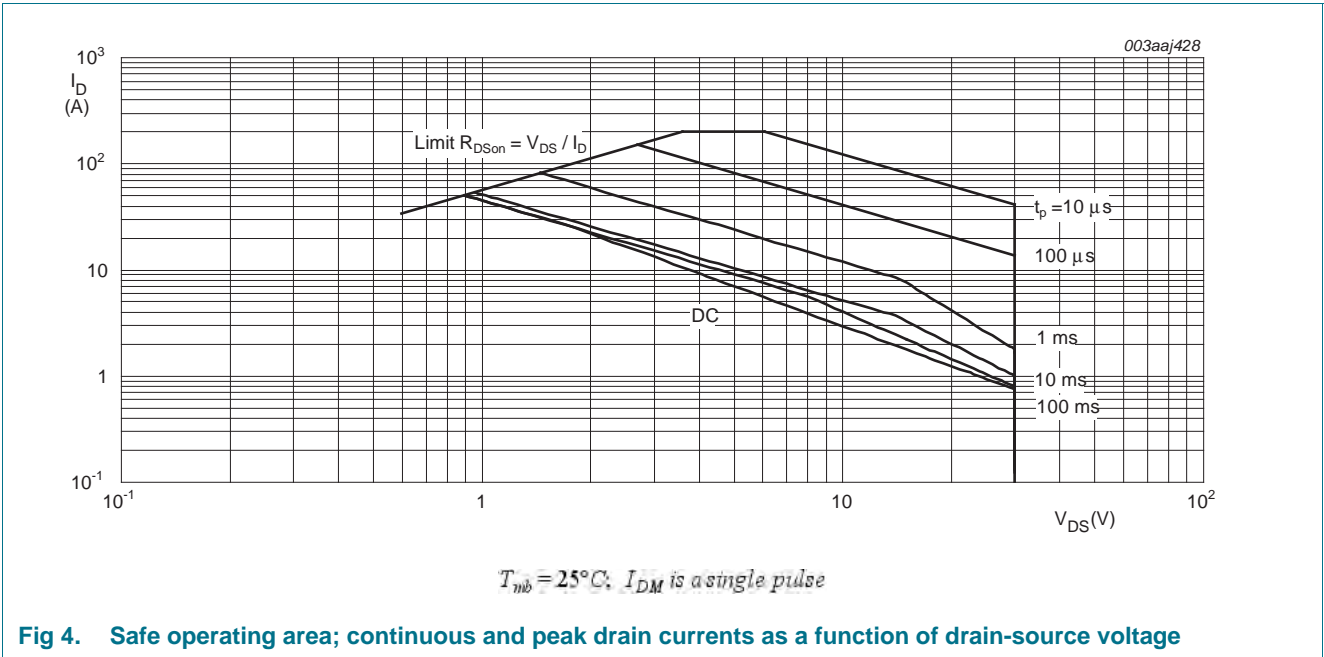

(1)  $T_{j(0.1s)} = 25^{\circ}C$ ; (2)  $T_{j(0.1s)} = 100^{\circ}C$

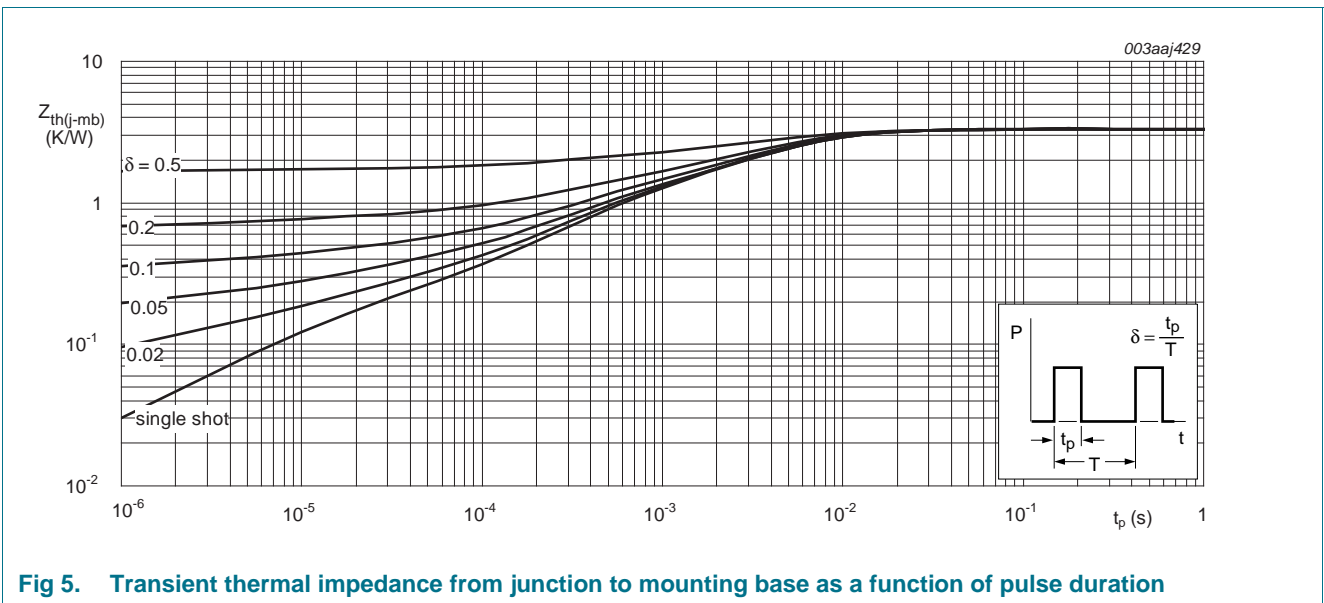
**Fig. 3. Single pulse avalanche rating; avalanche current as a function of avalanche time**

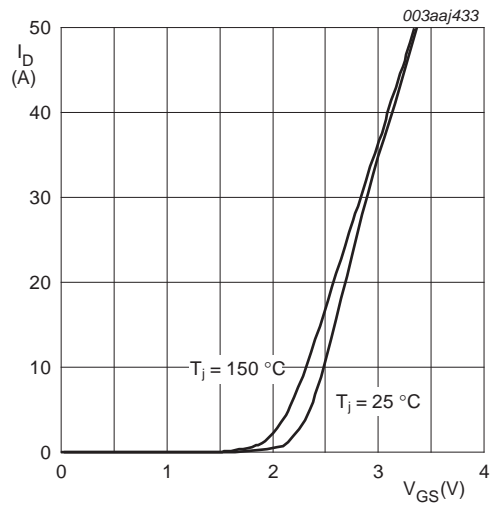

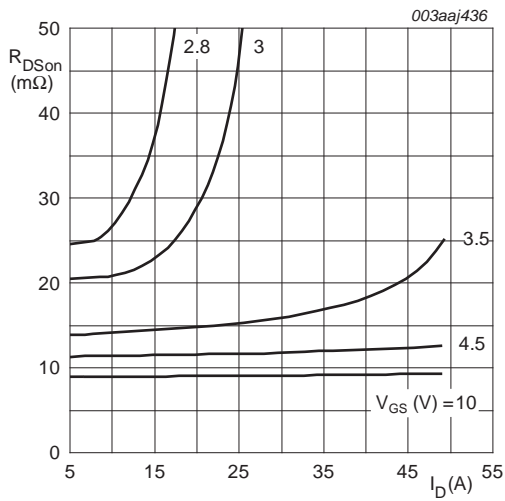

**Fig 8. Forward transconductance as a function of drain current; typical values**



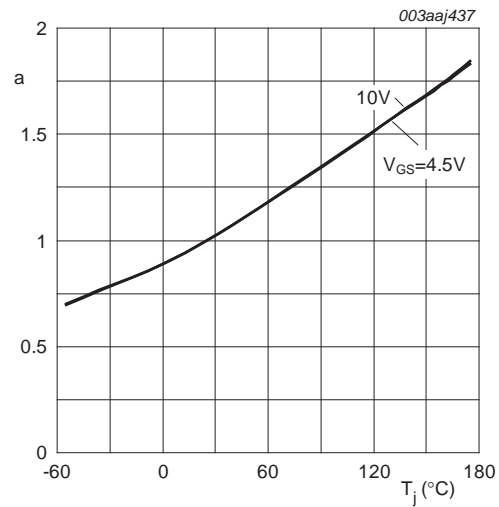

**Fig 11. Normalized drain-source on-state resistance factor as a function of junction temperature**

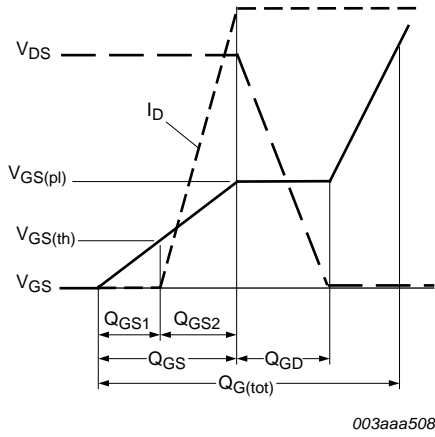


Fig 12. Gate charge waveform definitions

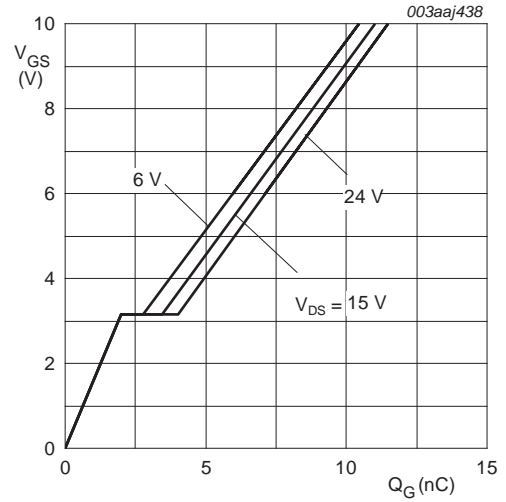


Fig 13. Gate-source voltage as a function of gate charge; typical values

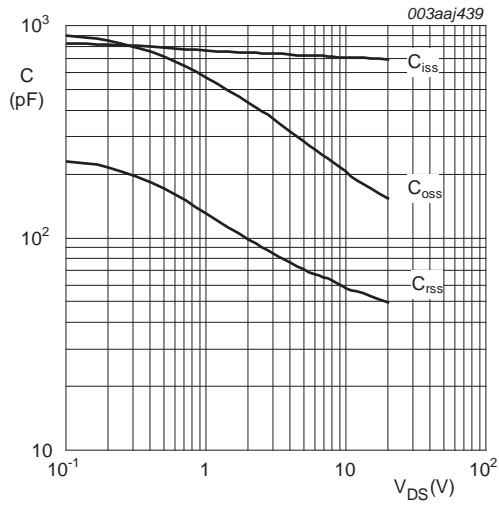


Fig 14. Input, output and reverse transfer capacitances as a function of drain-source voltage; typical values

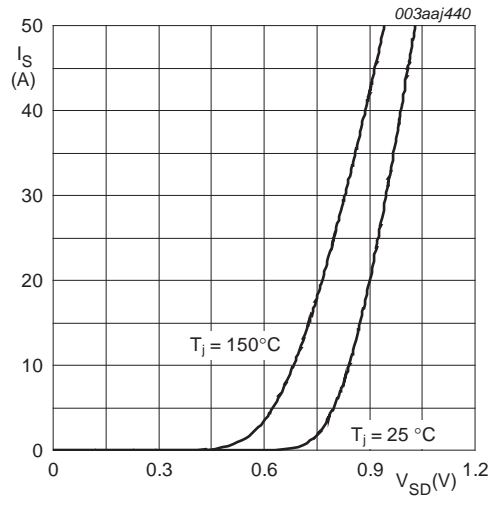


Fig 15. Source current as a function of source-drain voltage; typical values



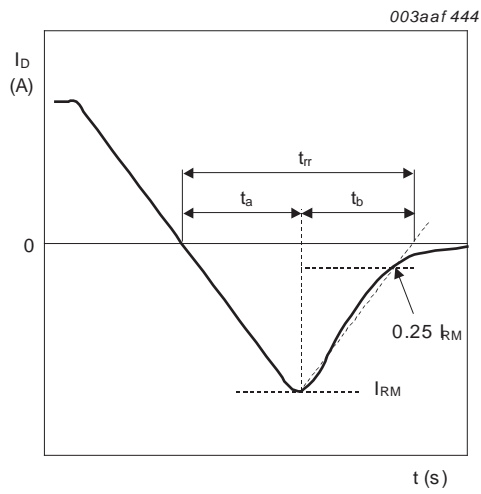


Fig 16. Reverse recovery timing definition
