FSTD16861 20-Bit Bus Switch with Level Shifting

General Description

The Fairchild Switch FSTD16861 provides 20-bits of high-speed CMOS TTL-compatible bus switching. The low On Resistance of the switch allows inputs to be connected to outputs without adding propagation delay or generating additional ground bounce noise. A diode to $V_{\rm CC}$ has been integrated into the circuit to allow for level shifting between 5V inputs and 3.3V outputs.

The device is organized as a 10-bit or 20-bit bus switch. When \overline{OE}_1 is LOW, the switch is ON and Port 1A is connected to Port 1B. When \overline{OE}_2 is LOW, Port 2A is connected to Port 2B. When \overline{OE}_X is HIGH, a high impedance state exists between the A and B Ports.

- Minimal propagation delay through the switch.
- Low I_{CC}.
- Zero bounce in flow-through mode.

Note 1: To ensure the high-impedance state during power up or power down, \overline{OE} should be tied to V_{CC} through a pull-up resistor; the minimum value of the resistor is determined by the current-sourcing capability of the driver





FIGURE 1. AC Test Circuit





FIGURE 2. AC Waveforms
