





Ic - COLLECTOR CURRENT (mA)



Base-Emitter Saturation






Collector-Cutoff Current vs Ambient Temperature





FIGURE 1: 500 MHz Oscillator Circuit









TO-92 Package Dimensions







Component Rotation




Sketch B (Top View)

Component lateral movement

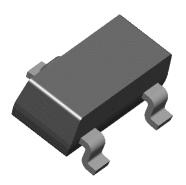
