

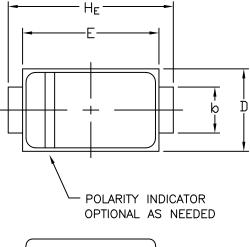


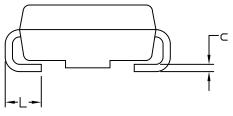
MECHANICAL CASE OUTLINE PACKAGE DIMENSIONS

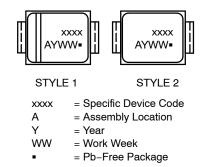




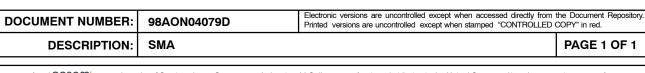

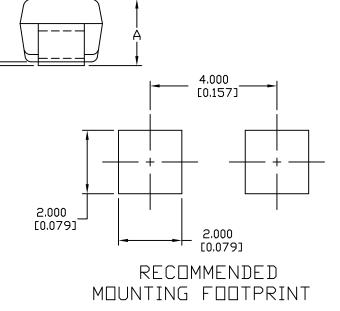
