




Relative Spectral Emission⁶⁾











Relative Luminous Intensity ^{6), 7)}









Relative Luminous Intensity⁶⁾

 $I_v/I_v(25 \ ^{\circ}C) = f(T_j); I_F = 30 \ mA$








Max. Permissible Forward Current


Permissible Pulse Handling Capability


Permissible Pulse Handling Capability

Dimensional Drawing ⁸⁾




