



TEST CIRCUIT 1 SWITCHING TIME






TEST CIRCUIT 2 GATE CHARGE







FORWARD BIAS SAFE OPERATING AREA





TRANSIENT THERMAL RESISTANCE vs. PULSE WIDTH







 T_{ch} - Channel Temperature - $^{\circ}C$




FORWARD TRANSFER CHARACTERISTICS




V_{GS} - Gate to Source Voltage - V

FORWARD TRANSFER ADMITTANCE vs. DRAIN CURRENT





DRAIN TO SOURCE ON-STATE RESISTANCE vs.

ID - Drain Current - A


