





Fig.1 Grounded emitter propagation




BASE TO EMITTER VOLTAGE : $V_{\text{BE}}\left[V\right]$

Fig.2 Grounded emitter output characteristics (I)




COLLECTOR TO EMITTER VOLTAGE: V_{CE} [V]

Fig.5 DC current gain vs. collector current (II)




Fig.6 Collector-emitter saturation voltage vs. collector current (I)




Fig.7 Collector-emitter saturation voltage vs. collector current (II)






Fig.8 Gain bandwidth product vs. emitter current




Fig.9 Collector output capacitance vs. collector-base voltage Emitter input capacitance vs. emitter-base voltage
