





Electrical characteristic curves(T_a=25°C) <For Tr1(PNP)>




Fig.7 Base-Emitter Saturation Voltage vs. Collector Current





Fig.8 Gain Bandwidth Product vs. Emitter Current






Fig.10 Safe Operating Area

Fig.1 Grounded Emitter Propagation





Fig.2 Typical Output Characteristics






Fig.7 Base-Emitter Saturation Voltage vs. **Collector Current**










Fig.6 Collector-Emitter Saturation Voltage

•Switching time test circuit(T_a=25°C) <For Tr2(NPN)>











