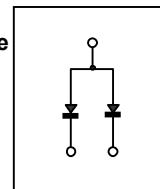

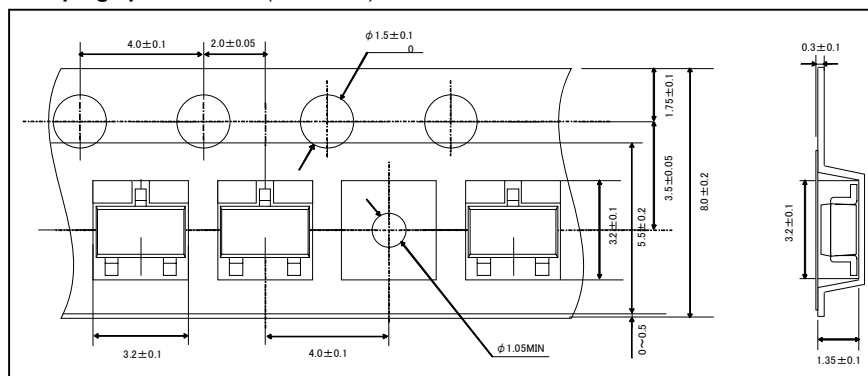

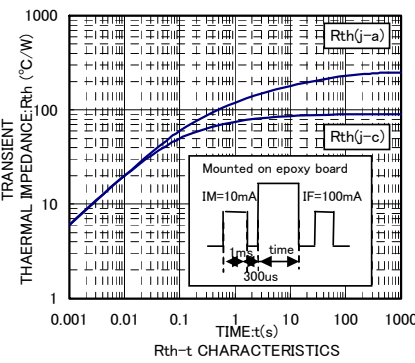
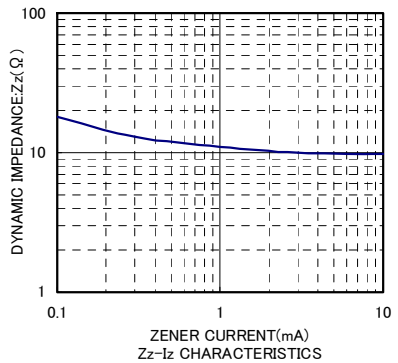
V_Z DISRESION MAP
