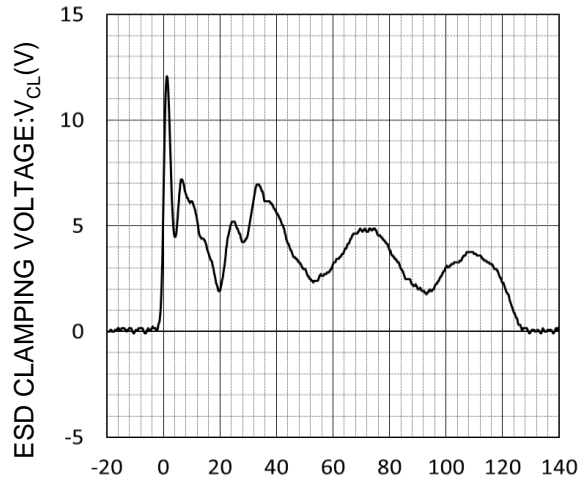

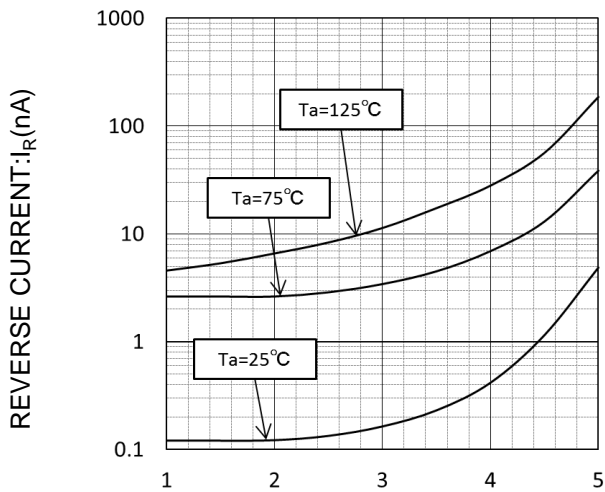

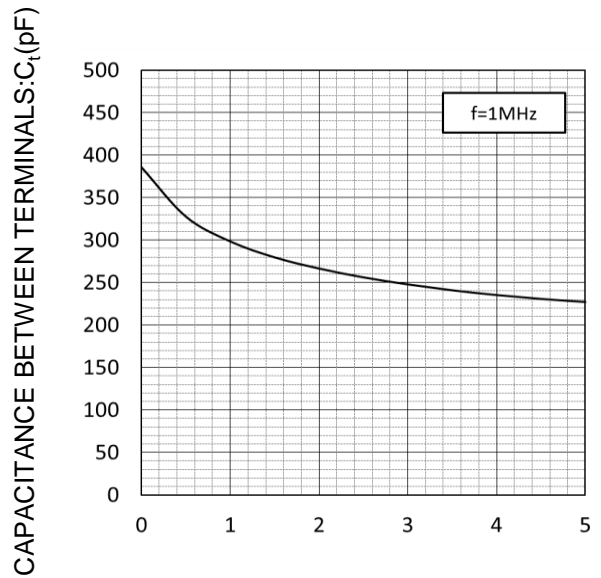
TIME(ns)

(IEC61000-4-2 +8kV CONTACT)

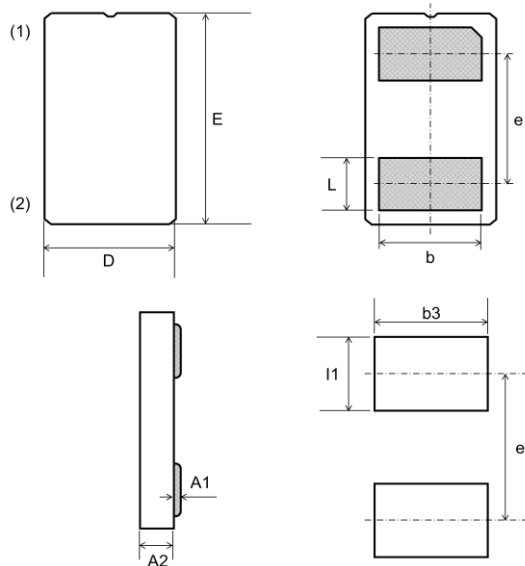


REVERSE VOLTAGE:  $V_R$ (V)

 $V_R$ - $C_t$  CHARACTERISTICS

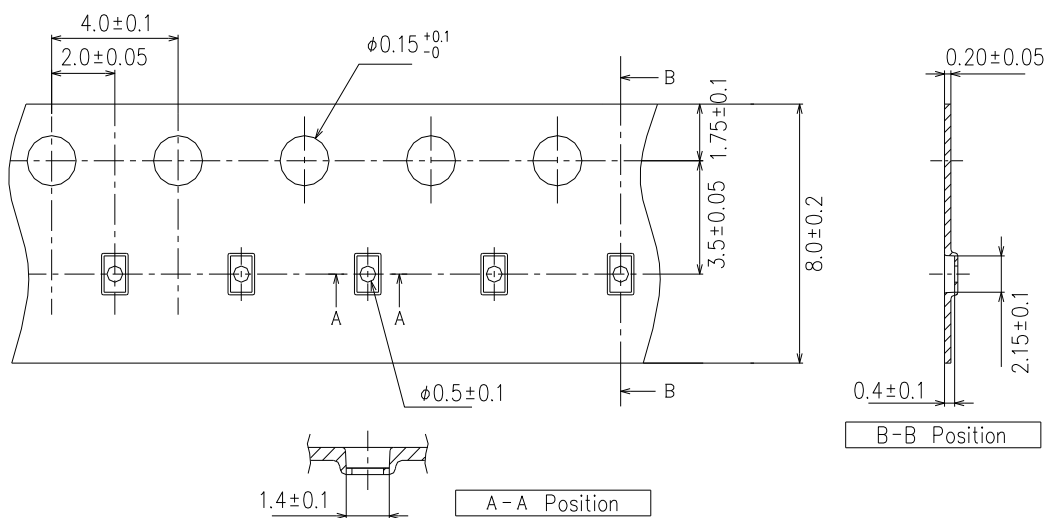
