






Rated current ≤7,5 A

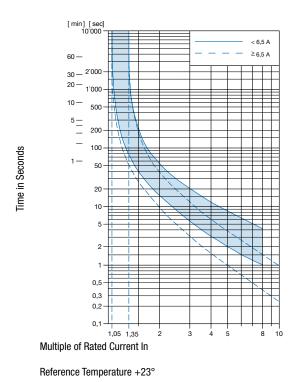
