


## Application Note: AN\_SY8705B High Efficiency, 1MHz, 3A, 30V Step Down White LED Driver

### **General Description**

SY8705B is a high efficiency step down regulator capable of driving 3A white LED from up to 30V input. It integrates the low  $R_{\rm ON}$  MOSFET and internal compensation. The 1MHz switching frequency allows the use of very small inductor.





Figure 1. Schematic diagram





## **Block Diagram**







## **Typical Operation Characteristics**











### **Operation**

SY8705B is a floating buck regulator IC that integrates the PWM control, power MOSFET on the same die to minimize the switching transition loss and conduction loss. With ultra low  $R_{\rm DS(ON)}$  power switches and proprietary PWM control, this regulator IC can achieve the high efficiency and the high switch frequency simultaneously to minimize the external inductor and capacitor size, and thus achieving the minimum solution footprint.

## **Applications Information**

Because of the high integration in the IC, the application circuit based on this IC is rather simple. Only input capacitor  $C_{\rm IN}$ , output capacitor  $C_{\rm OUT}$ , output inductor L and current sense resistor  $R_{\rm SEN}$  need to be selected for the targeted applications specifications.

#### Current sense resistor Rsen:

Choose  $R_{\text{SEN}}$  to program the proper output Current:

$$ILED(A) = \frac{0.1(V)}{R_{SEN}(\Omega)}$$

#### **Input capacitor CIN:**

The ripple current through input capacitor is calculated as:

$$I_{\text{CIN\_RMS}} = I_{\text{OUT}} \cdot \sqrt{D(1-D)}$$

A typical X7R or better grade ceramic capacitor with suitable capacitance should be choosen to handle this ripple current well. To minimize the potential noise problem, place this ceramic capacitor really close to the IN and GND pins. Care should be taken to minimize the loop area formed by C<sub>IN</sub>, and IN/GND pins.

#### **Output capacitor Cout:**

The output capacitor is selected to handle the output current ripple noise requirements. For the best performance, it is recommended to use X7R or better grade ceramic capacitor greater than 1uF capacitance.

#### **Output inductor L:**

There are several considerations in choosing this inductor.

 Choose the inductance to provide the desired ripple current. It is suggested to choose the ripple current to be about 40% of the maximum output current. The inductance is calculated as:

$$L = \frac{V_{\text{OUT}}(1 - V_{\text{OUT}}/V_{\text{IN,MAX}})}{F_{\text{SW}} \times I_{\text{OUT,MAX}} \times 40\%}$$

where Fsw is the switching frequency and  $I_{OUT,MAX}$  is the LED current.

The SY8705B regulator IC is quite tolerant of different ripple current amplitude. Consequently, the final choice of inductance can be slightly off the calculation value without significantly impacting the performance.

 The saturation current rating of the inductor must be selected to be greater than the peak inductor current under full load conditions.



#### Layout Design:

The layout design of SY8705B regulator is relatively simple. For the best efficiency and minimum noise problems, we should place the following components close to the IC: CIN\_L, COUT and RSEN.


- 1) It is desirable to maximize the PCB copper area connecting to GND pin to achieve the best thermal and noise performance. If the board space allowed, a ground plane is highly desirable.
- 2)  $C_{\text{IN}}$  must be close to Pins IN and GND. The loop area formed by  $C_{\text{IN}}$  and GND must be minimized.
- 3) The PCB copper area associated with LX pin must be minimized to avoid the potential noise problem.







## **SO8E Package Outline & PCB layout**




Notes: All dimension in millimeter and exclude mold flash & metal burr.




