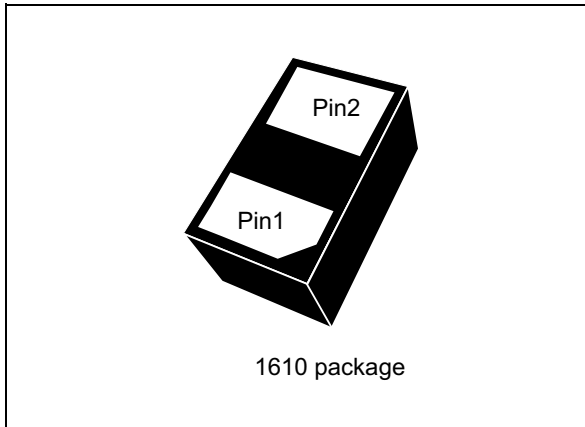


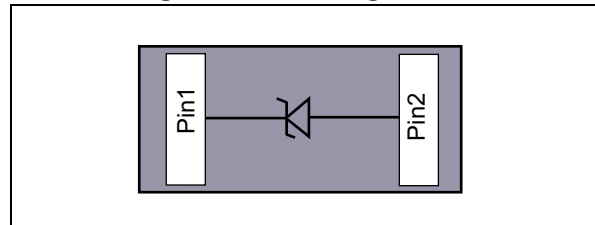
**High power transient voltage suppressor**

**Description**

The ESDA7P60-1U1M is a unidirectional single line TVS diode designed to protect the power line against EOS and ESD transients.

The device is ideal for applications where high power TVS and board space saving are required.

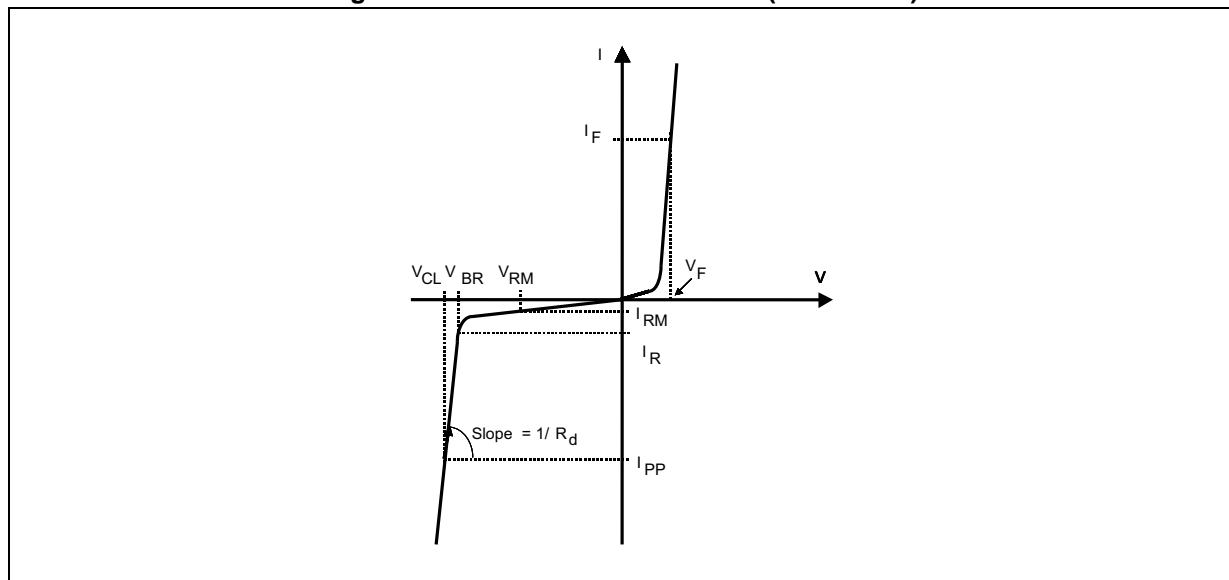

Figure 3. Peak pulse power dissipation versus initial junction temperature (typical values)

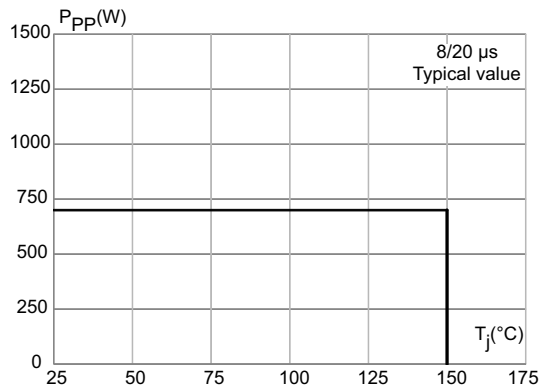


Figure 4. Peak pulse power versus exponential pulse duration (maximum values)

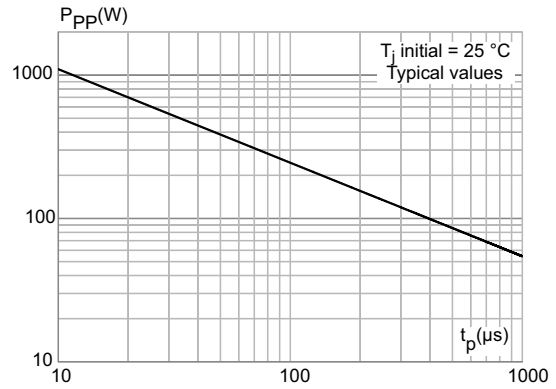


Figure 5. Peak pulse current versus clamping voltage (maximum values)

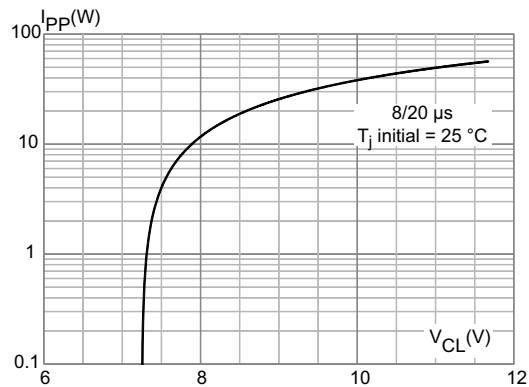


Figure 6. Leakage current versus junction temperature (typical values)

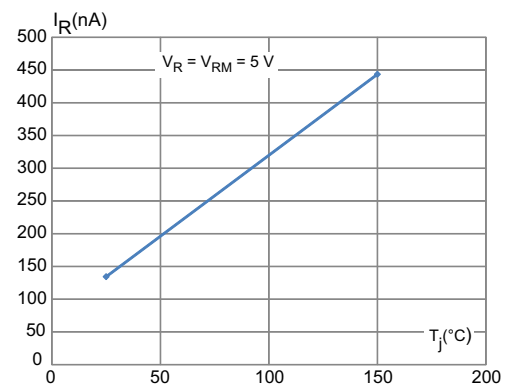


Figure 7. ESD response to IEC 61000-4-2 (+8 kV contact discharge)

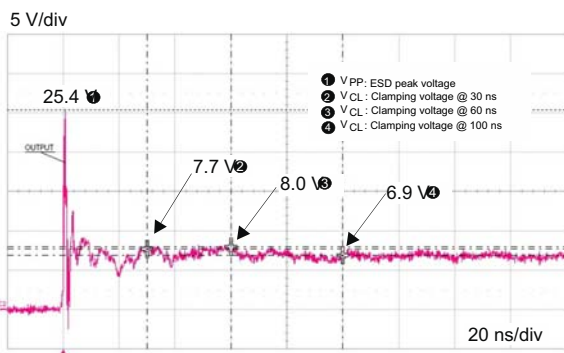
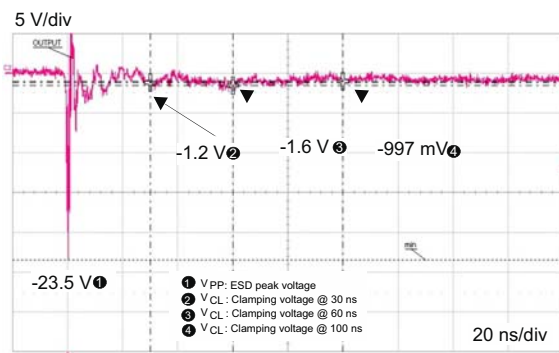


Figure 8. ESD response to IEC 61000-4-2 (-8 kV contact discharge)

Figure 9. 1610 package outline

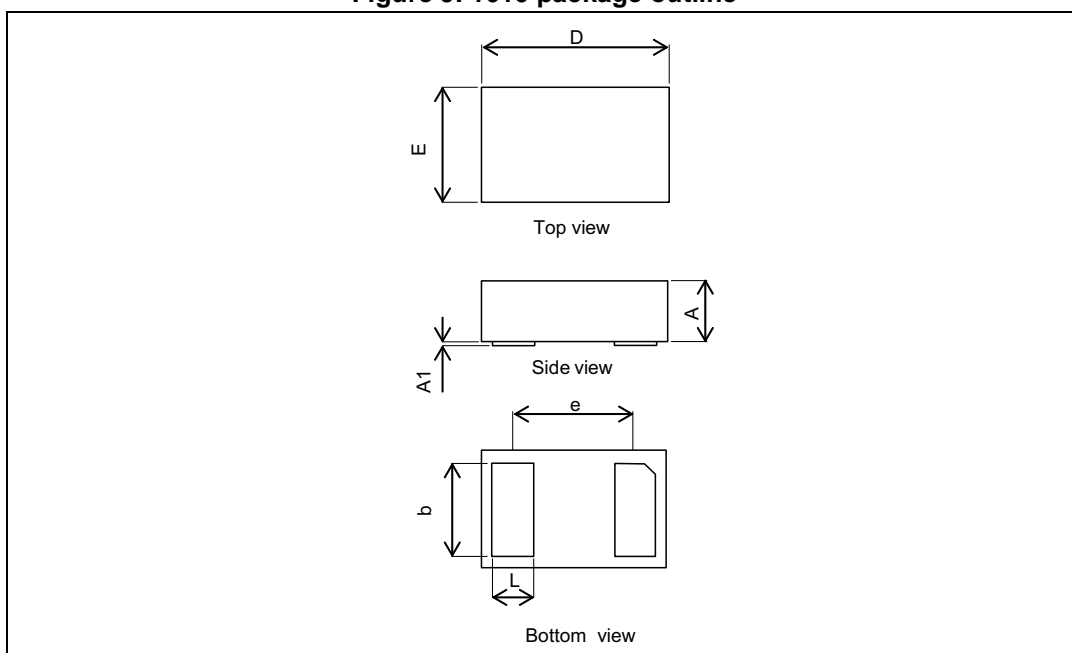
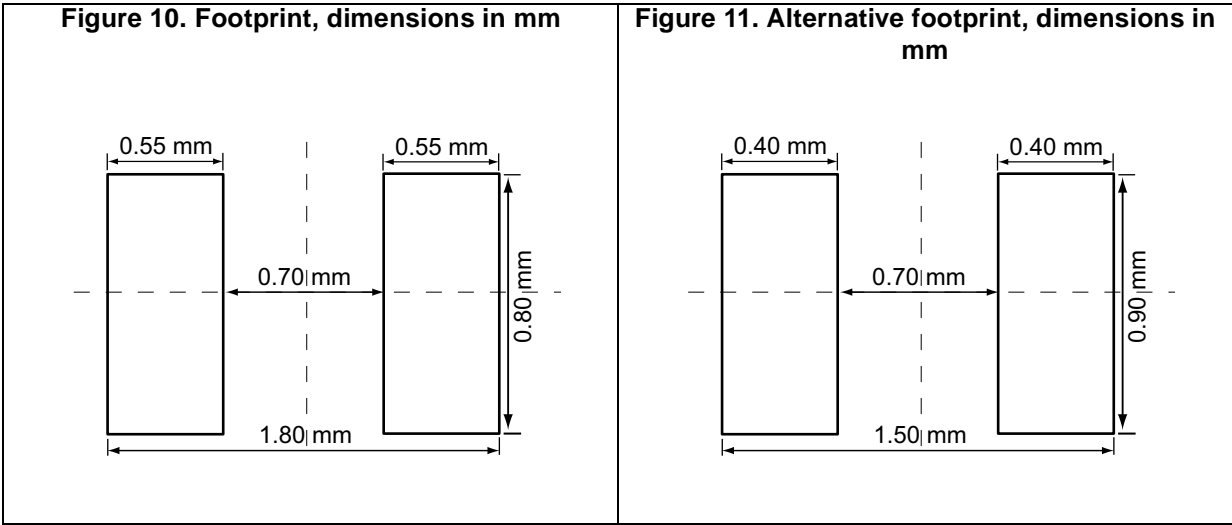

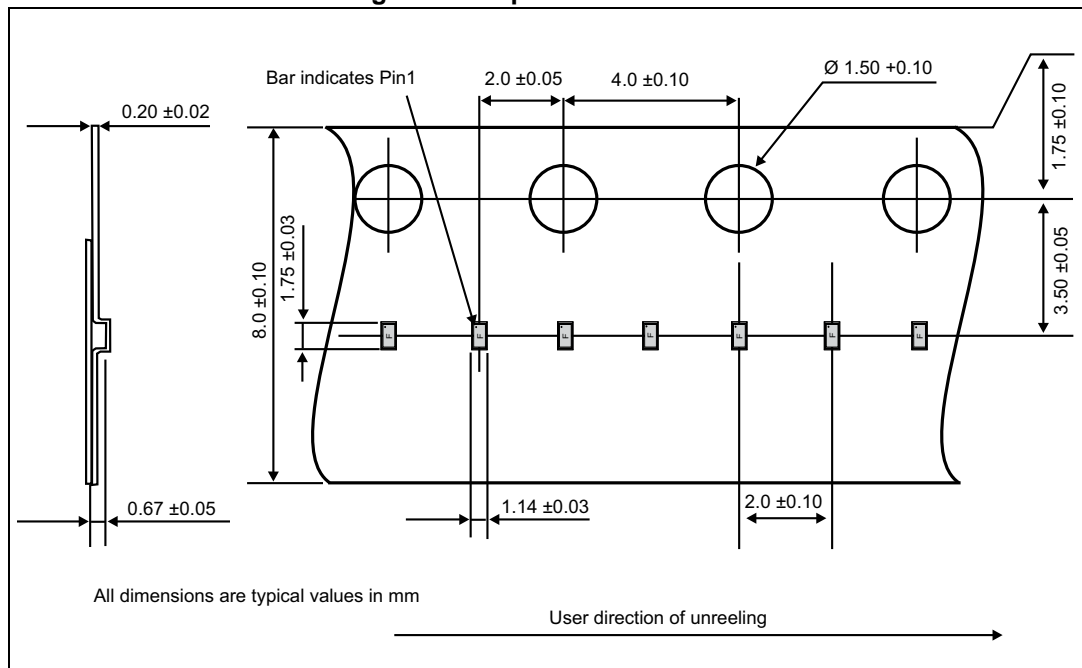
**Figure 12. Marking**

Figure 13. Tape and reel outline

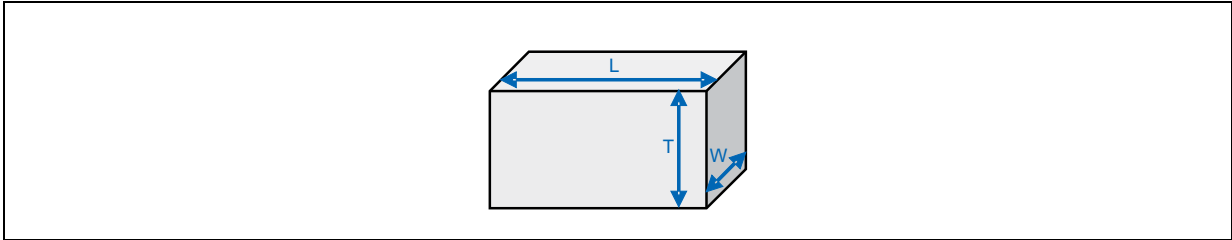


### 3 Recommendation on PCB assembly

#### 3.1 Stencil opening design

1. General recommendation on stencil opening design
  - a) Stencil opening dimensions: L (Length), W (Width), T (Thickness).

- b) General design rule
  - Stencil thickness (T) = 75 ~ 125 μm
  - Aspect Ratio =  $\frac{W}{T} \geq 1.5$
  - Aspect Area =  $\frac{L \times W}{2T(L + W)} \geq 0.66$

2. Reference design
  - a) Stencil opening thickness: 100 μm
  - b) Stencil opening for leads: Opening to footprint ratio is 90%.

Figure 15. Recommended stencil window position

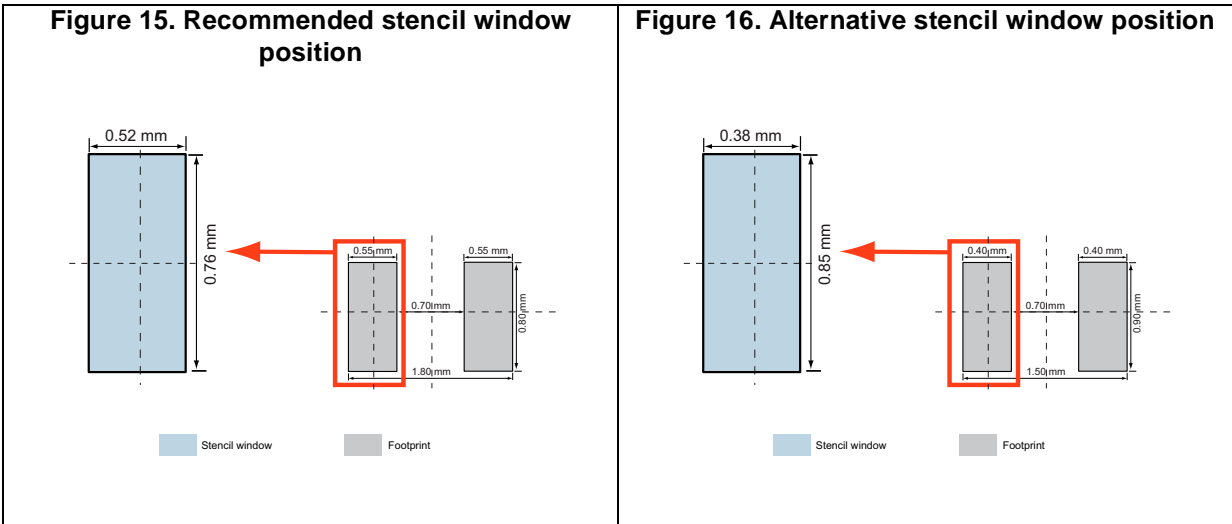
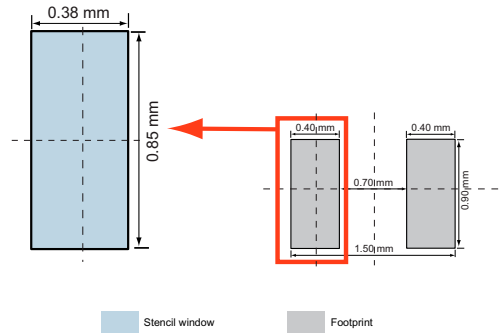


Figure 16. Alternative stencil window position



### 3.2 Solder paste

1. Use halide-free flux, qualification ROL0 according to ANSI/J-STD-004.
2. “No clean” solder paste recommended.
3. Offers a high tack force to resist component displacement during PCB movement.
4. Use solder paste with fine particles: powder particle size 20-45  $\mu\text{m}$ .

### 3.3 Placement

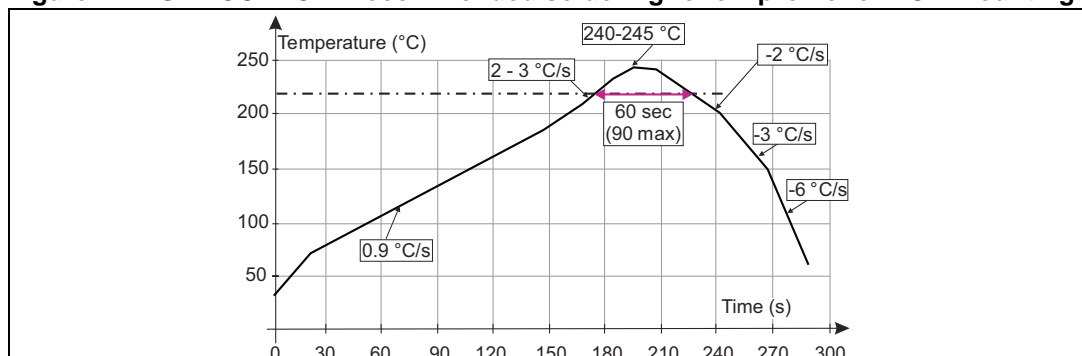
1. Manual positioning is not recommended.
2. It is recommended to use the lead recognition capabilities of the placement system, not the outline centering.
3. Standard tolerance of  $\pm 0.05$  mm is recommended.
4. 3.5 N placement force is recommended. Too much placement force can lead to squeezed out solder paste and cause solder joints to short. Too low placement force can lead to insufficient contact between package and solder paste that could cause open solder joints or badly centered packages.
5. To improve the package placement accuracy, a bottom side optical control should be performed with a high resolution tool.
6. For assembly, a perfect supporting of the PCB (all the more on flexible PCB) is recommended during solder paste printing, pick and place and reflow soldering by using optimized tools.

### 3.4 PCB design preference

1. To control the solder paste amount, the closed via is recommended instead of open vias.
2. The position of tracks and open vias in the solder area should be well balanced. The symmetrical layout is recommended, in case any tilt phenomena caused by asymmetrical solder paste amount due to the solder flow away.

### 3.5 Reflow profile

Note: Minimize air convection currents in the reflow oven to avoid component movement.

Figure 18. Ordering information scheme

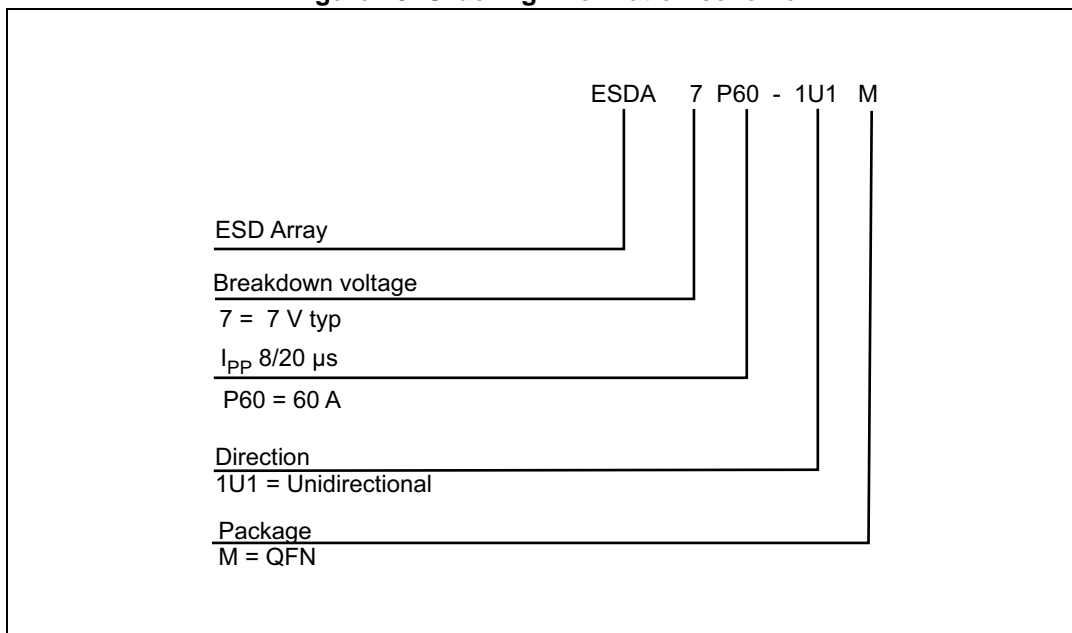
