Description

The STTH8BC060 is a specific rectification diode used in continuous mode power factor correction working in the BC^2 topology. This diode has been especially designed for the dedicated BC^2 topology. Therefore, its electrical characteristics offer the best possible efficiency with a P-N optimized structured diode. As a result, SMPS efficiency growth of up to 2.5% can be produced compared with standard ultrafast 600 V P-N diode.


