#### 7-2. Soldering

Mildly activated rosin fluxes are preferred. TAI-TECH terminations are suitable for all wave and re-flow soldering systems. If hand soldering cannot be avoided, the preferred technique is the utilization of hot air soldering tools.

#### 7-2.1 Lead Free Solder re-flow:

Recommended temperature profiles for lead free re-flow soldering in Figure 1.

#### 7-2.2 Soldering Iron(Figure 2):

- Products attachment with a soldering iron is discouraged due to the inherent process control limitations. In the event that a soldering iron must be employed the following precautions are recommended.
- Preheat circuit and products to 150°C
  · Never contact the ceramic with the iron tip
  · 350°C tip temperature (max)
  · 1.0mm tip diameter (max)
  · Limit soldering time to 4~5 sec.





