

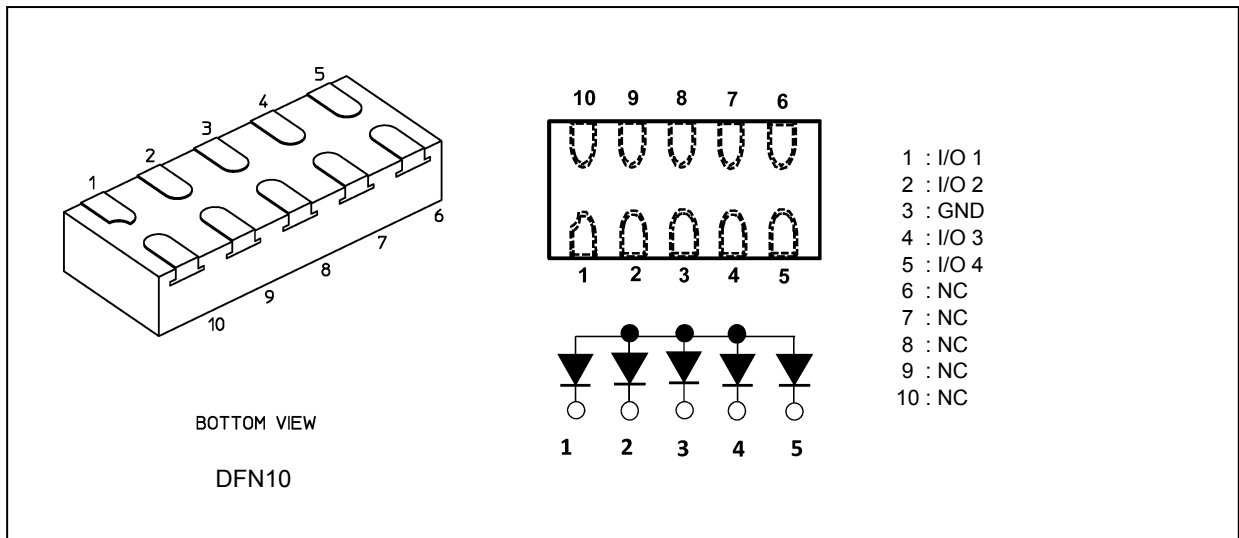

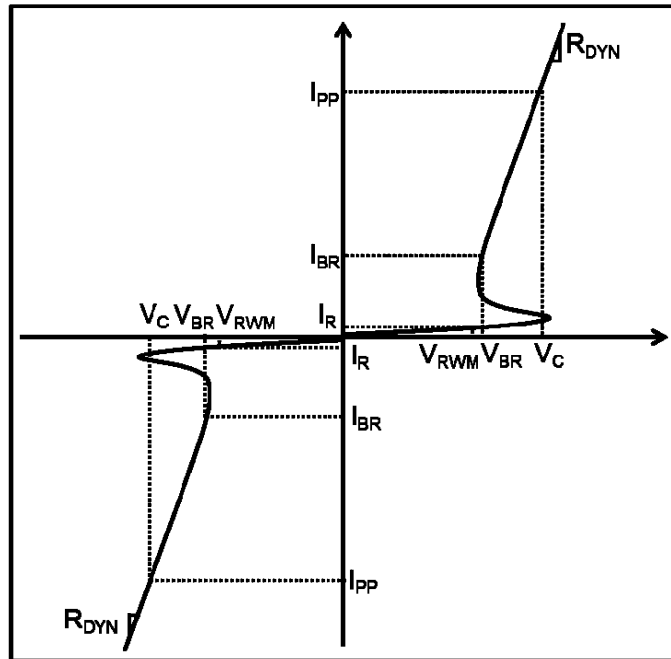


Fig. 4.1 Definitions of Electrical Characteristics

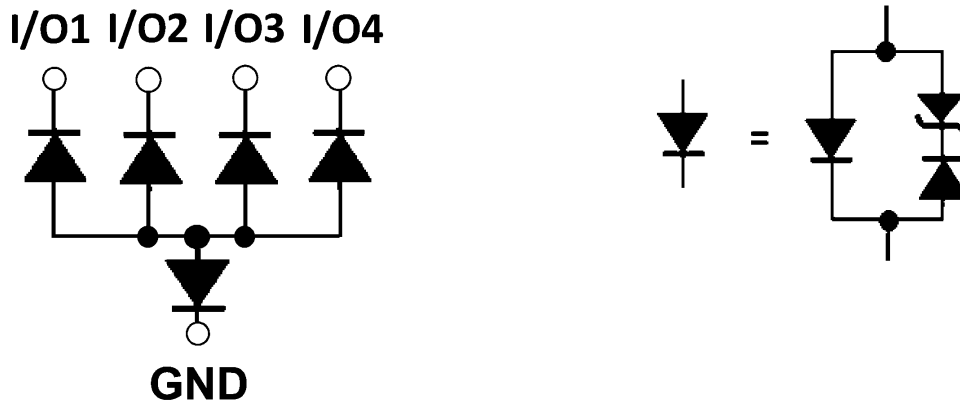

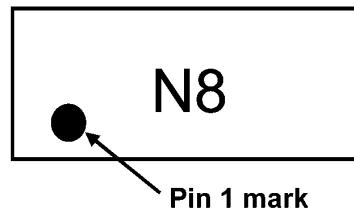


Fig. 6.1 Marking

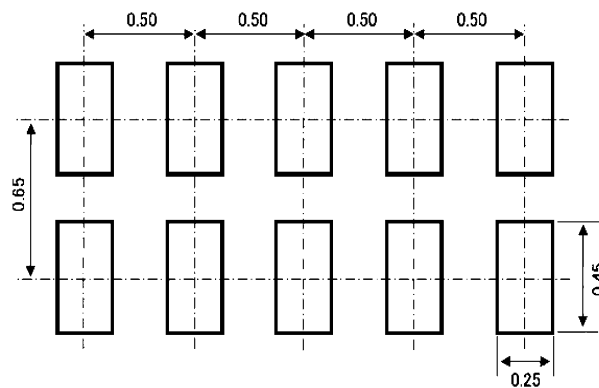


Fig. 7.1 Land Pattern Dimensions (Unit: mm)

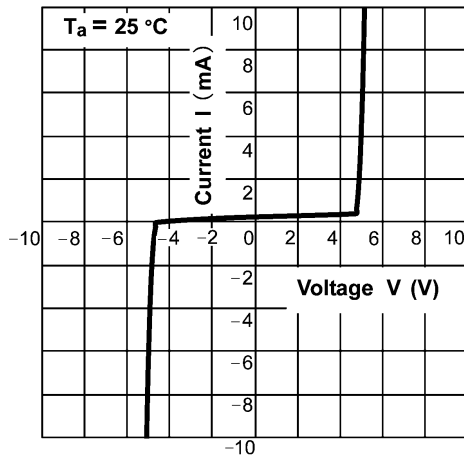


Fig. 8.1 I - V

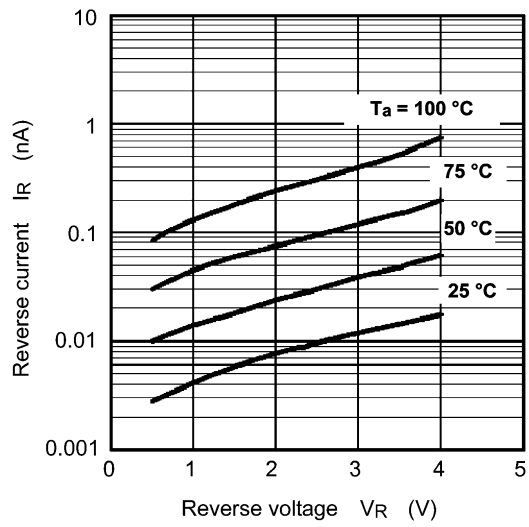


Fig. 8.2 $I_R - V_R$

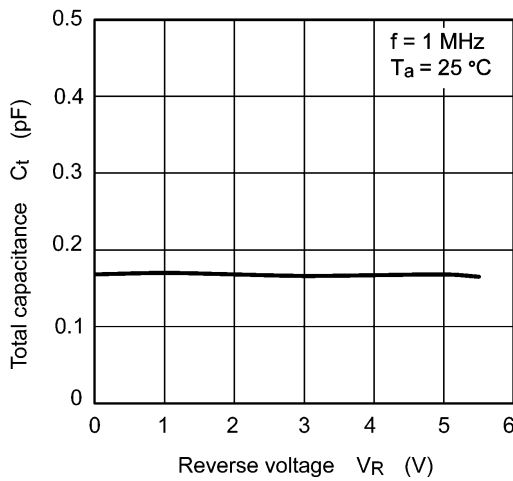


Fig. 8.3 $C_t - V_R$

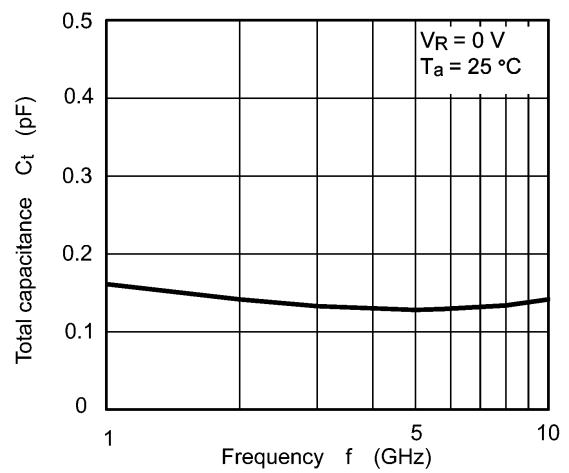


Fig. 8.4 $C_t - f$

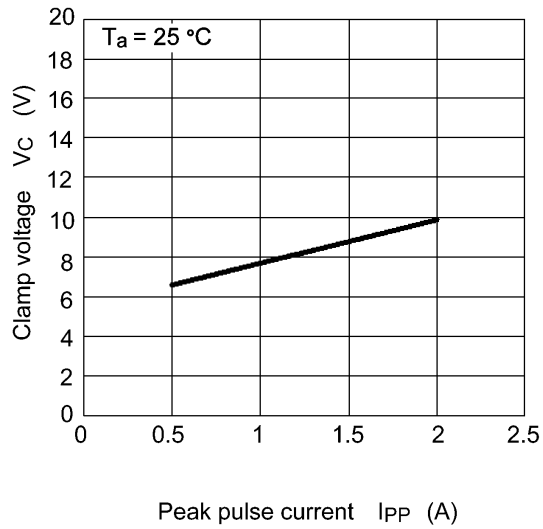


Fig. 9.1 V_C - I_{PP}

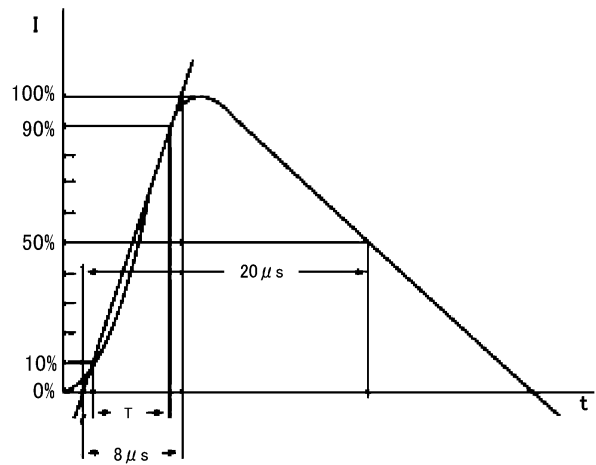


Fig. 9.2 Based on IEC61000-4-5 8/20 μ s pulse.(Ed.2)

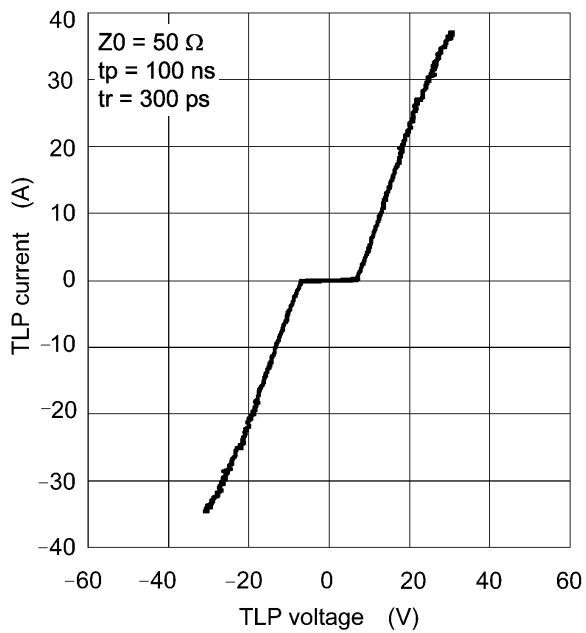


Fig. 9.3 TLP

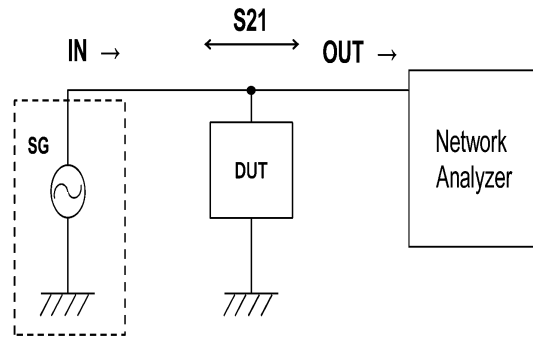
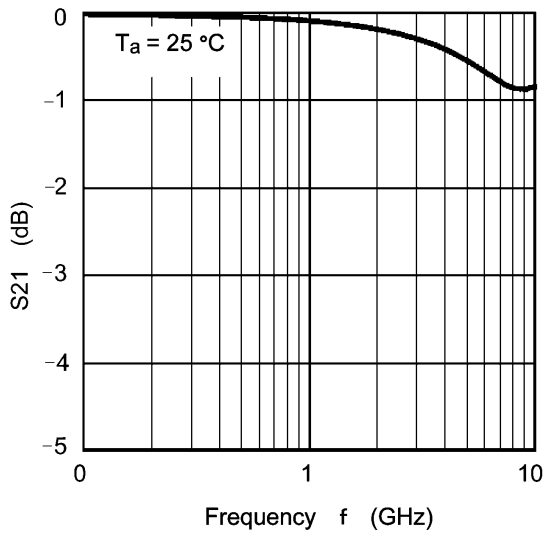
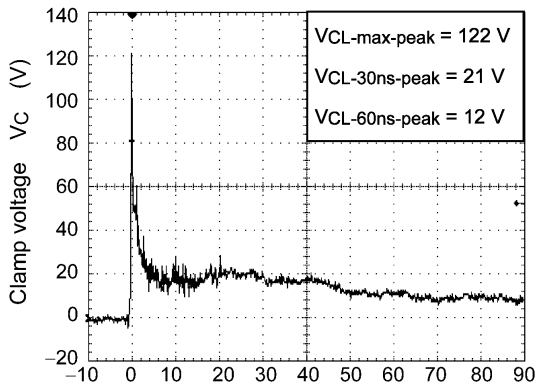


Fig. 10.1 S21 - f

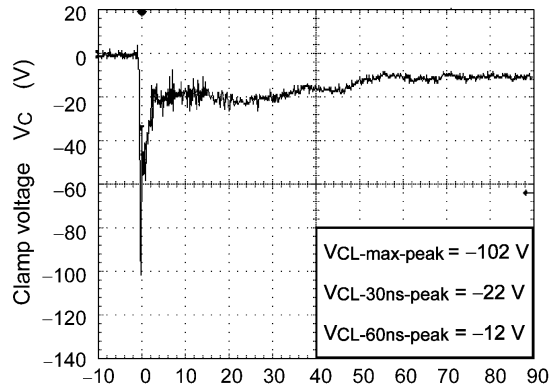

11. ESD Clamp Waveform (Note)



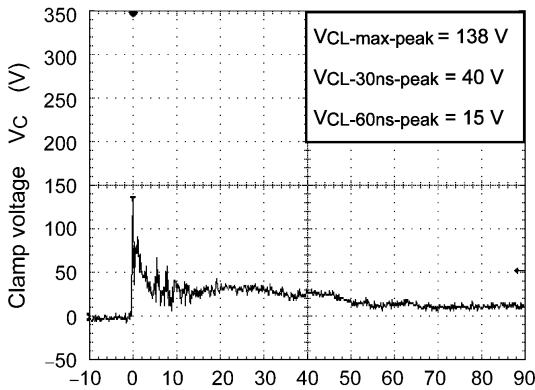

Fig. 11.1 +8 kV



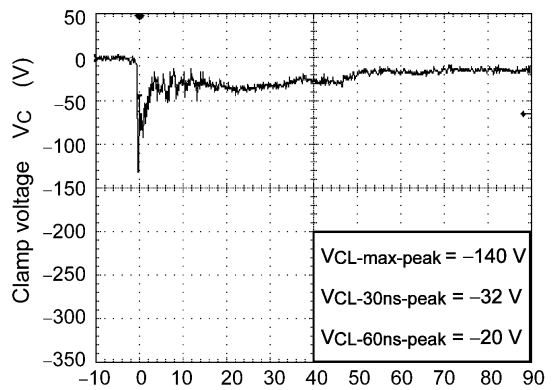
Pulse time t_p (ns)

Fig. 11.4 -15 kV

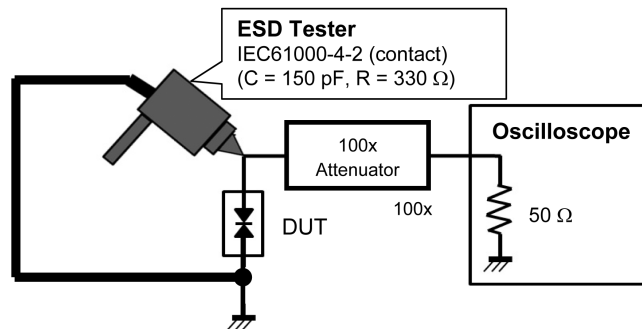
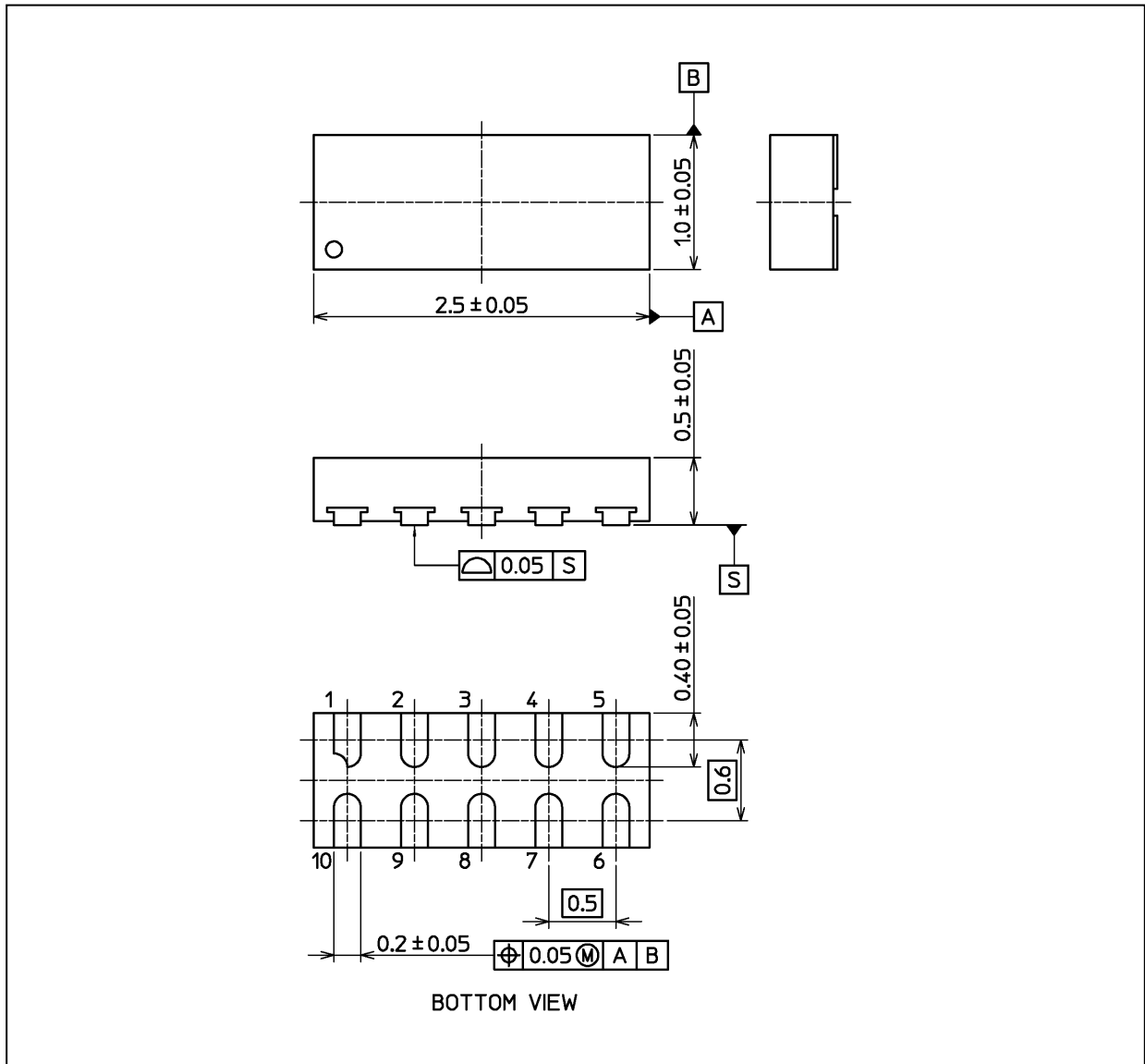


Fig. 11.5 IEC61000-4-2 (Contact)
