


Fig. 7.1 SOD-923 (unit: mm)





Fig. 7.2 fSC (unit: mm)



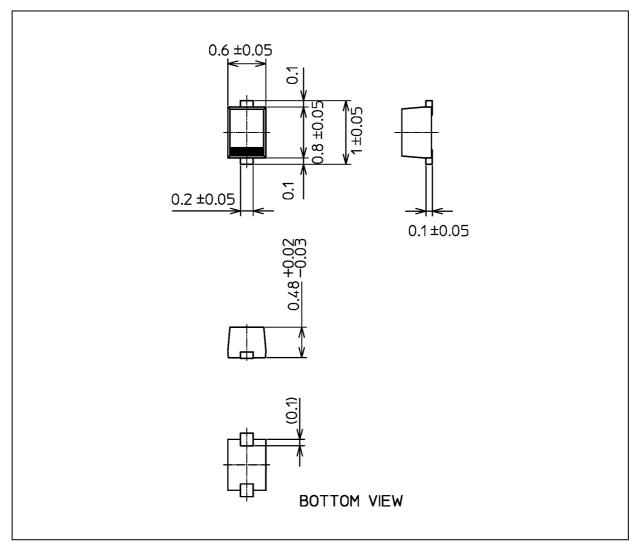
