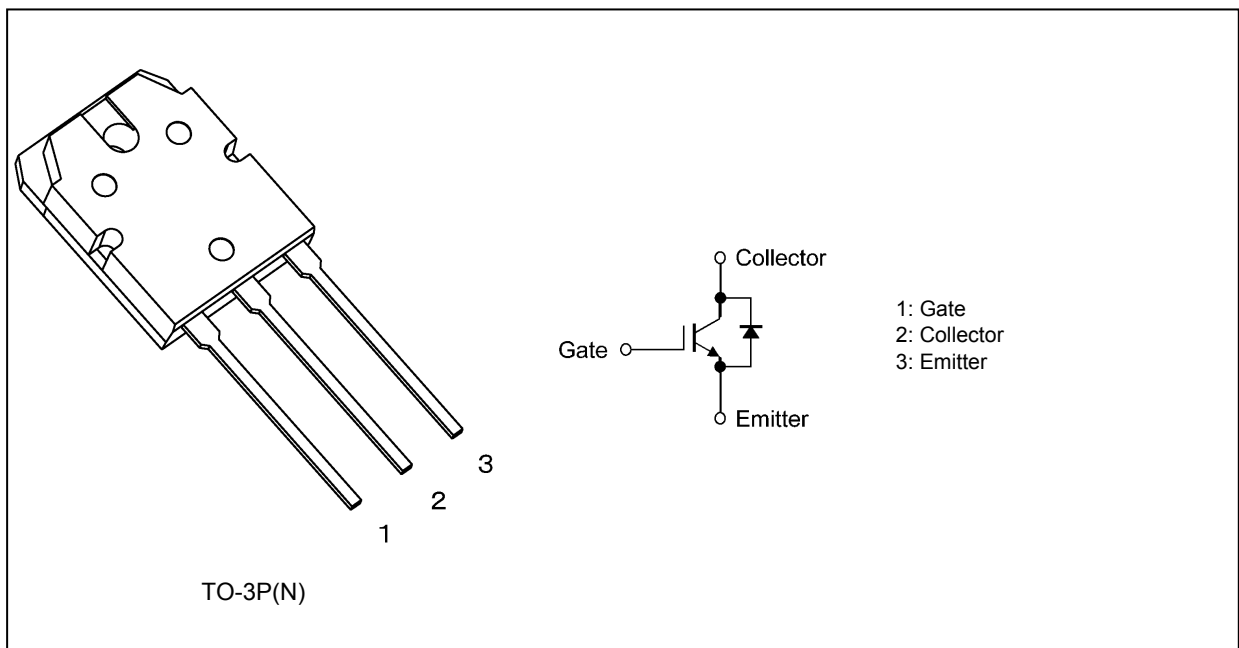

Note 1: Ensure that the junction temperature does not exceed  $175^\circ\text{C}$ .

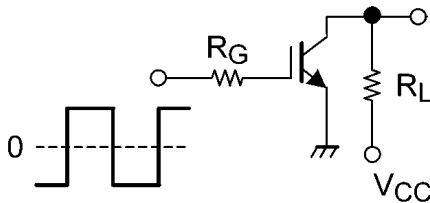

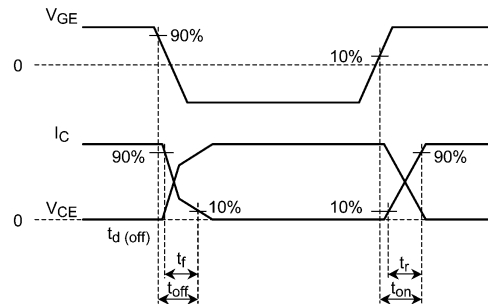

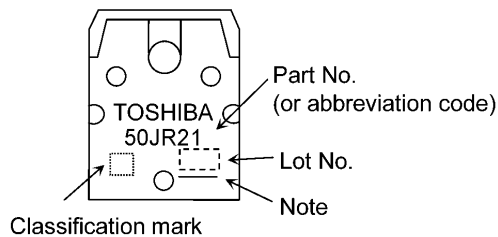


**Fig. 6.2.1 Test Circuit of Switching Time**

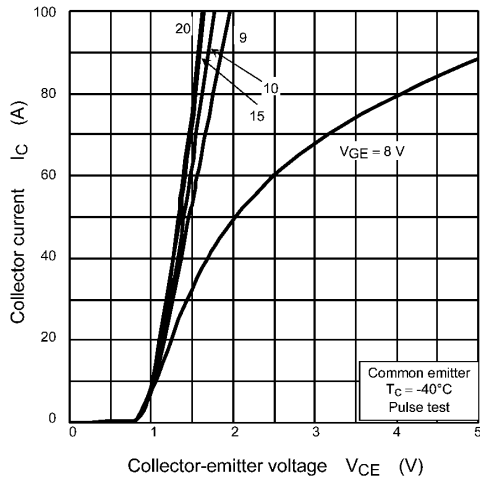


**Fig. 7.1 Marking**

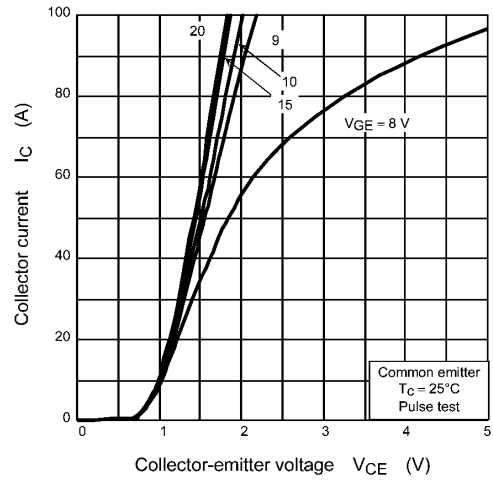

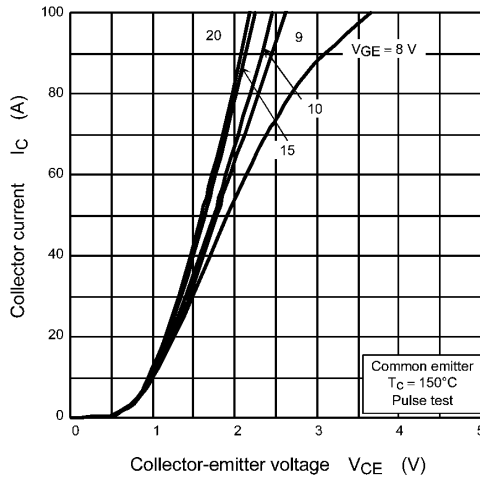

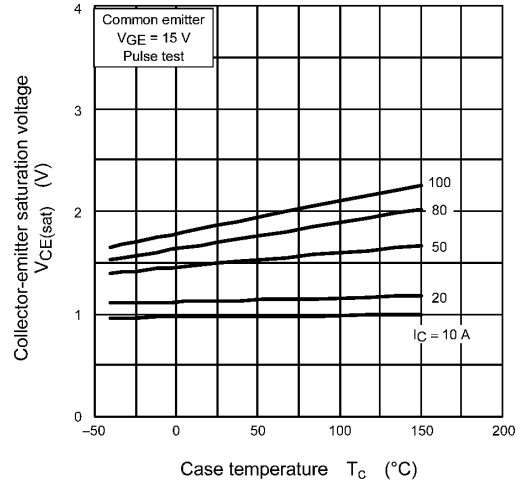
**Fig. 8.1  $I_c - V_{CE}$**



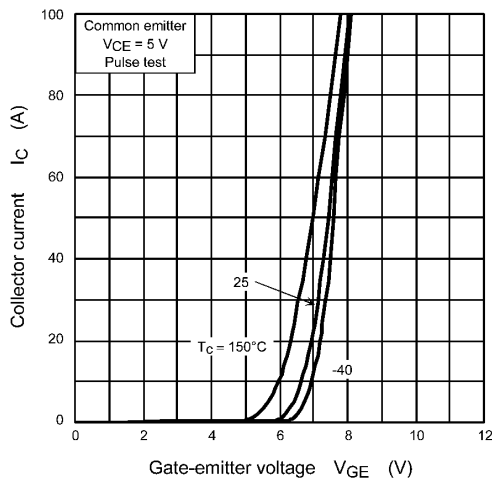
**Fig. 8.2  $I_c - V_{CE}$**



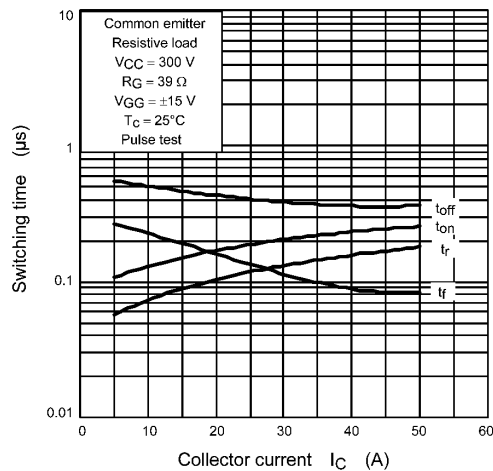
**Fig. 8.3  $I_c - V_{CE}$**



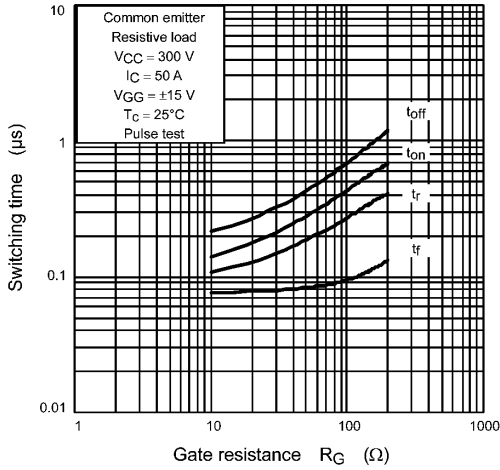
**Fig. 8.4  $V_{CE(sat)} - T_c$**



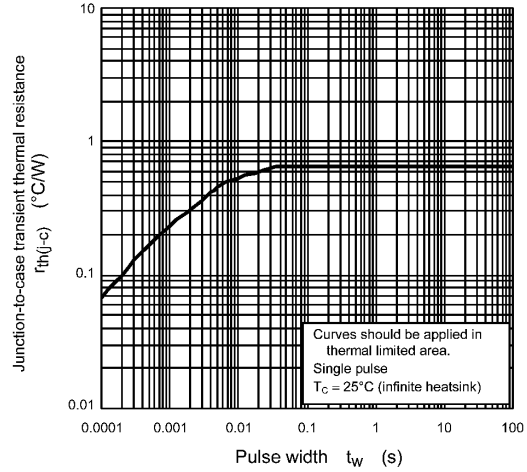
**Fig. 8.5  $I_c - V_{GE}$**



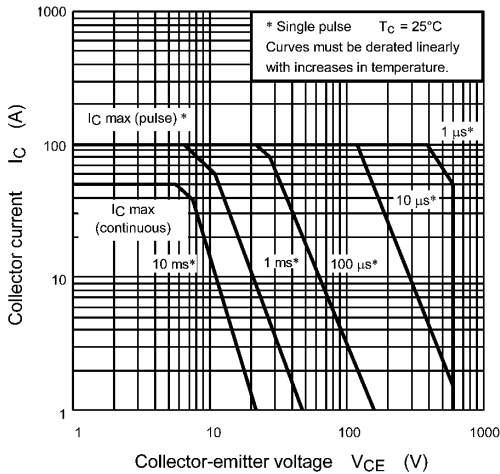
**Fig. 8.6 Switching Time -  $I_c$**



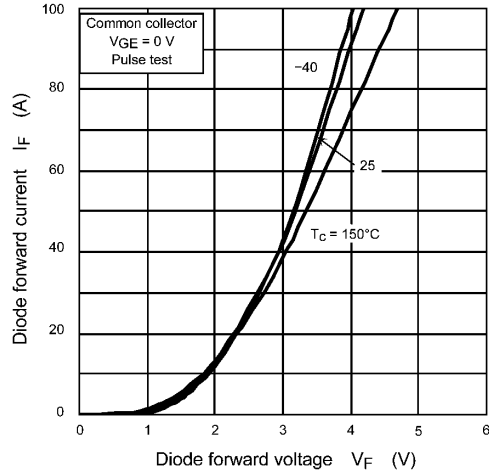
**Fig. 8.7 Switching Time -  $R_G$**
