




Fig. 6.2.1 Test Circuit of Switching Time




Fig. 6.2.2 Timing Chart of Switching Time




Fig. 7.1 Marking




Fig. 8.1 I_C - V_{CE}




Fig. 8.3 I_C - V_{CE}




Fig. 8.5 I_C - V_{GE}




Fig. 8.2 I_C - V_{CE}




Fig. 8.4 V_{CE(sat)} - T_c




Fig. 8.6 Switching Time - I_C




Fig. 8.7 Switching Time - R_G




Fig. 8.8 $r_{th(j-c)}$ - t_w (Guaranteed Maximum)




Fig. 8.9 Safe Operating Area (Guaranteed Maximum)





Fig. 8.10 I_F - V_F
