




Fig. 6.2.1 Test Circuit of Switching Time




Fig. 6.2.2 Timing Chart of Switching Time




Fig. 7.1 Marking




Fig. 8.1 I<sub>C</sub> - V<sub>CE</sub>




Fig. 8.3 I<sub>C</sub> - V<sub>CE</sub>




Fig. 8.5 I<sub>C</sub> - V<sub>GE</sub>




Fig. 8.2 Ic - VCE




Fig. 8.4 V<sub>CE(sat)</sub> - T<sub>c</sub>




Fig. 8.6 Switching Time - I<sub>C</sub>




Fig. 8.7 Switching Time - R<sub>G</sub>




Fig. 8.8  $r_{th(j-c)}$  -  $t_w$  (Guaranteed Maximum)




Fig. 8.9 Safe Operating Area (Guaranteed Maximum)





Fig. 8.10 I<sub>F</sub> - V<sub>F</sub>
