





8. Characteristics Curves (Note) (Q1, Q2 Common)







Fig. 8.1 Ic - VCE

Fig. 8.2 h_{FE} - I_C







Fig. 8.3 V_{CE(sat)} - I_C

Fig. 8.4 V_{BE(sat)} - I_C






Fig. 8.5 f_T - I_C


Fig. 8.6 I_B - V_{BE}
