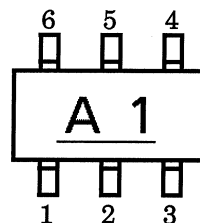

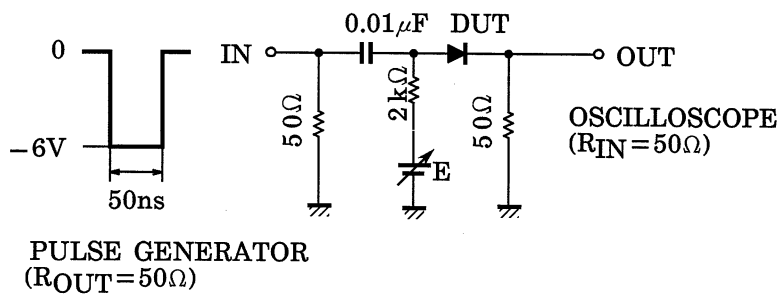
Pin Assignment (Top View)

OUTPUT WAVEFORM

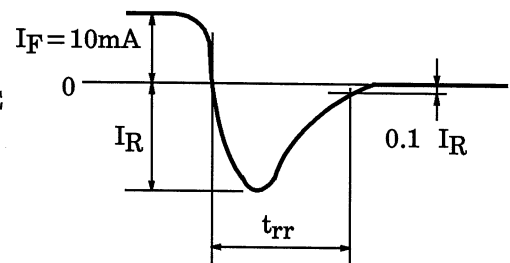
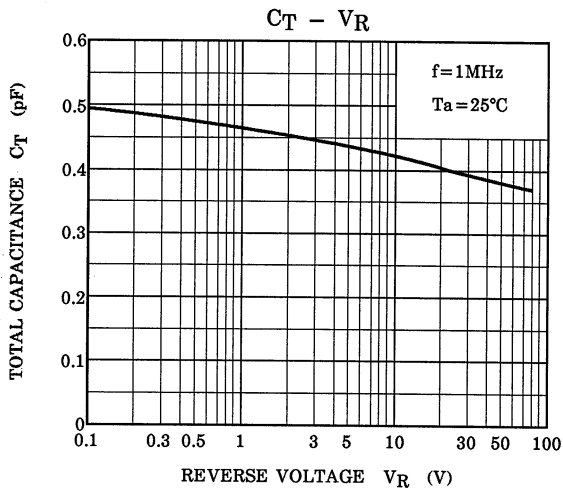
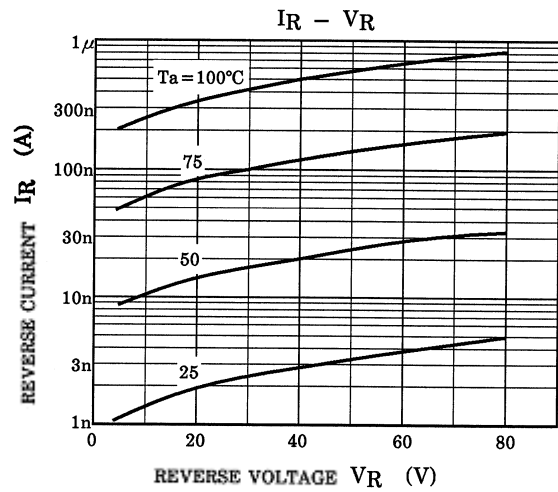
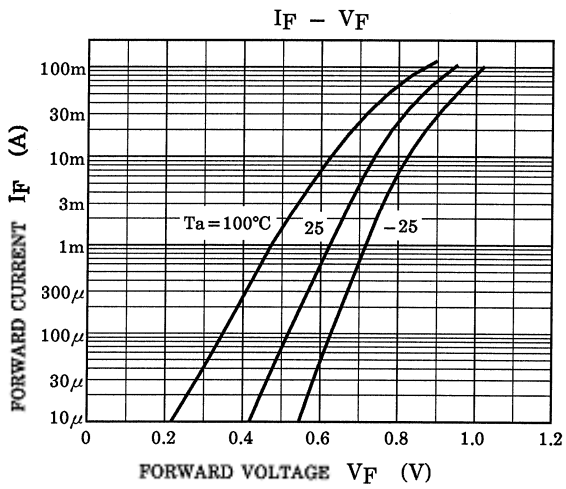


Fig.1 Reverse Recovery Time (t_{rr}) Test Circuit
