






Fig. 13.1 Q1 I_C-V_{I(ON)}





Fig. 13.2 Q2 I_C-V_{I(ON)}







Fig. 13.3 Q1 I_C-V_{I(OFF)}

Fig. 13.4 Q2 I_C-V_{I(OFF)}







Fig. 13.5 Q1 h_{FE}-I_C

Fig. 13.6 Q2 h_{FE}-I_C








Fig. 13.7 Q1 V_{CE(sat)}-I_C


Fig. 13.8 Q2 V_{CE(sat)}-I_C
