

Note 1: Let  $V_{th}$  be the voltage applied between gate and source that causes the source current ( $I_S$ ) to below (1.11 mA for this device). Then, for normal switching operation,  $V_{GS(ON)}$  must be higher than  $V_{th}$ , and  $V_{GS(OFF)}$  must be lower than  $V_{th}$ . This relationship can be expressed as:  $V_{GS(OFF)} < V_{th} < V_{GS(ON)}$ .

Take this into consideration when using the device.






Fig. 6.3.1 Switching Time Test Circuit





Fig. 7.1 Marking




Fig. 9.1 Is - Vss




Fig. 9.2 R<sub>SS(ON)</sub> - I<sub>S</sub>




Fig. 9.3 Is - VGS




Fig. 9.4 R<sub>SS(ON)</sub> - V<sub>GS</sub>




Fig. 9.5 I<sub>F</sub> - V<sub>F</sub>





Fig. 9.6 IGSS - VGS








Fig. 9.7 ISSS - VSS

Fig. 9.8  $r_{th}$  -  $t_w$ 





Fig. 9.9 Safe Operating Area
