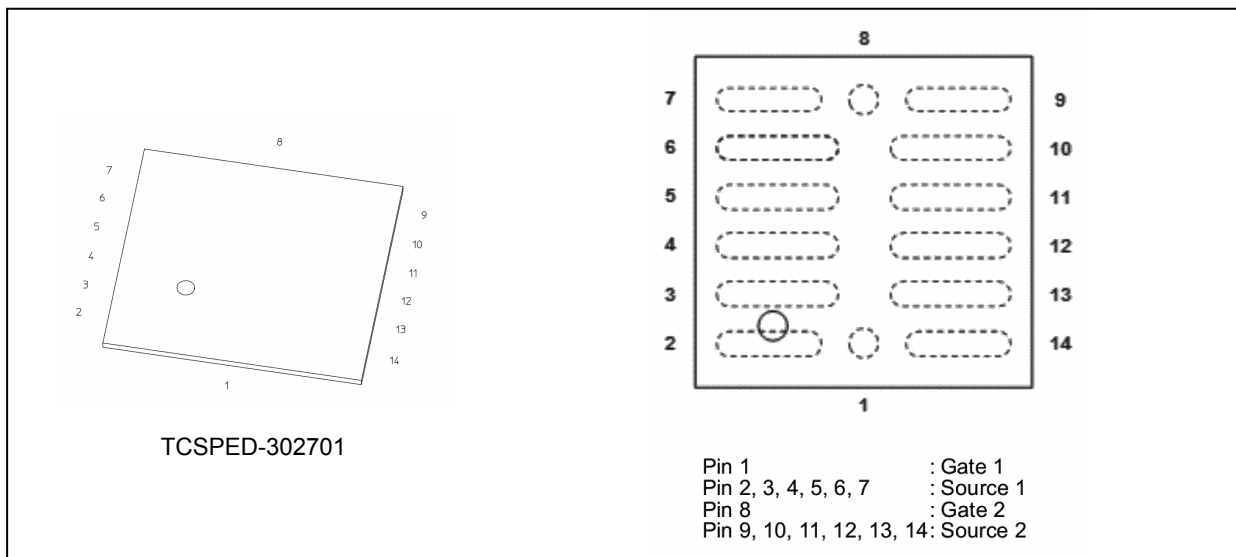

Note 1: Let  $V_{th}$  be the voltage applied between gate and source that causes the source current ( $I_S$ ) to below (1.57 mA for this device). Then, for normal switching operation,  $V_{GS(ON)}$  must be higher than  $V_{th}$ , and  $V_{GS(OFF)}$  must be lower than  $V_{th}$ . This relationship can be expressed as:  $V_{GS(OFF)} < V_{th} < V_{GS(ON)}$ .

Take this into consideration when using the device.

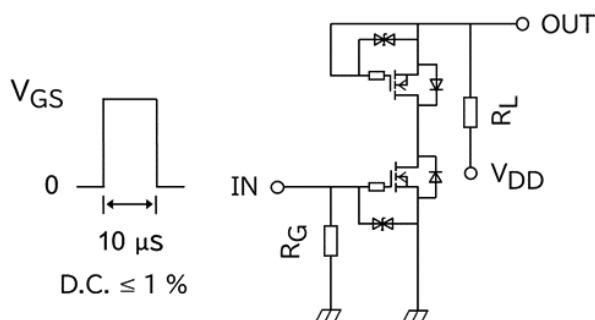


Fig. 6.3.1 Switching Time Test Circuit

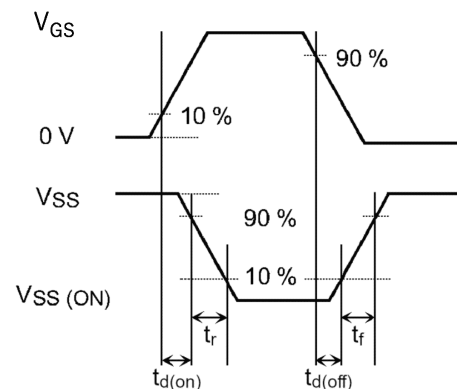
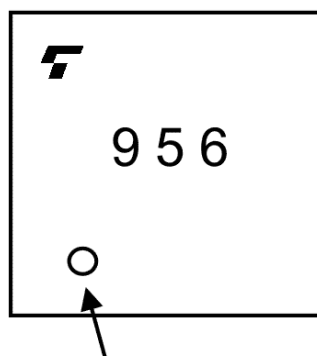


Fig. 6.3.2 Input Waveform/Output Waveform

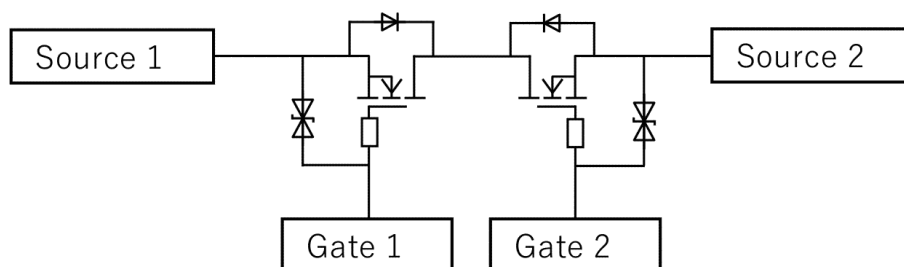

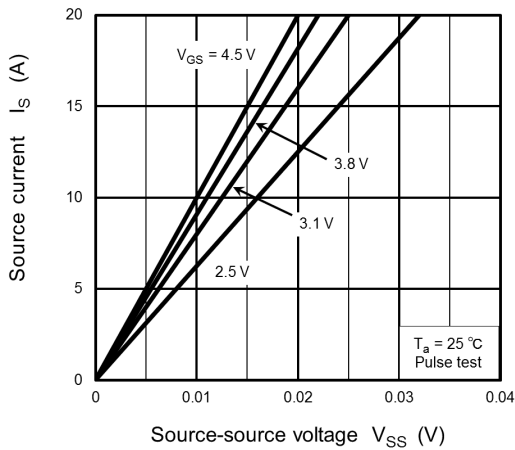


Fig. 9.1  $I_S - V_{SS}$

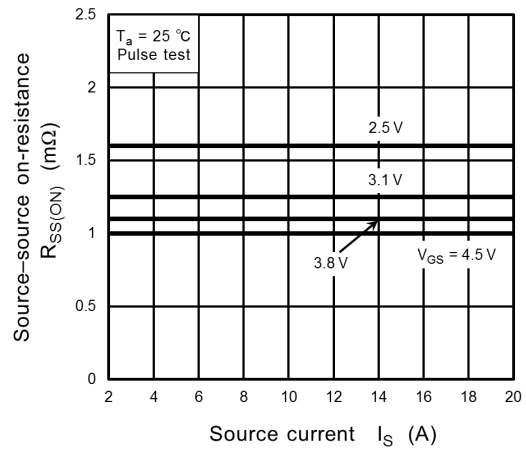


Fig. 9.2  $R_{SS(ON)} - I_S$

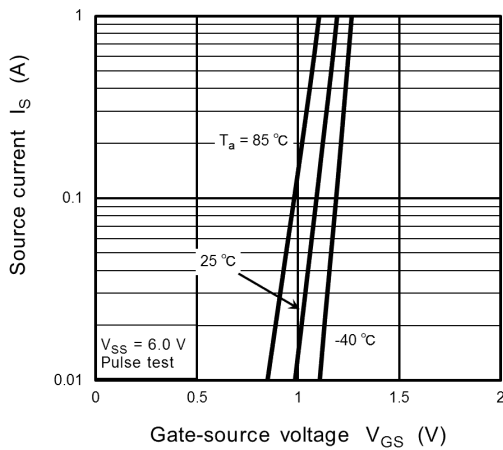


Fig. 9.3  $I_S - V_{GS}$

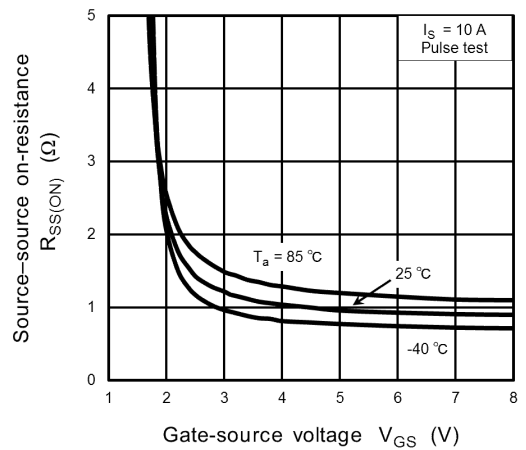


Fig. 9.4  $R_{SS(ON)} - V_{GS}$

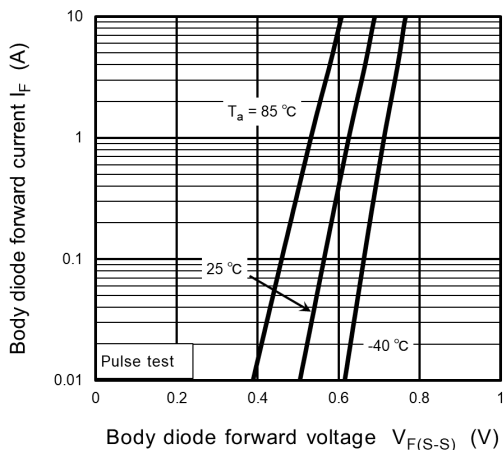


Fig. 9.5  $I_F - V_{F(S-S)}$

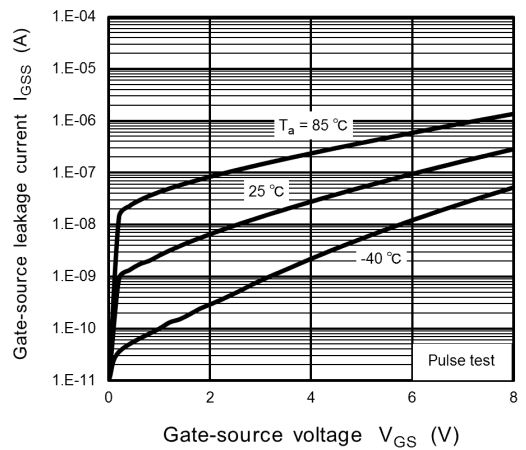
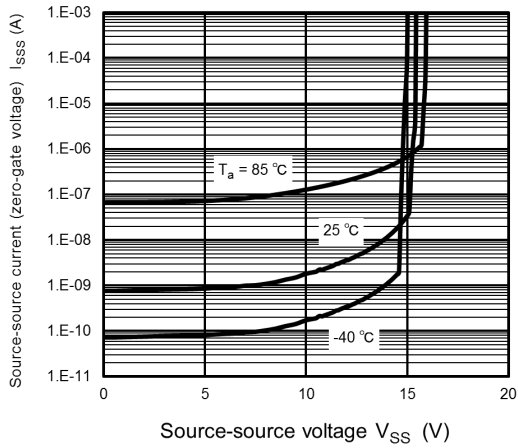
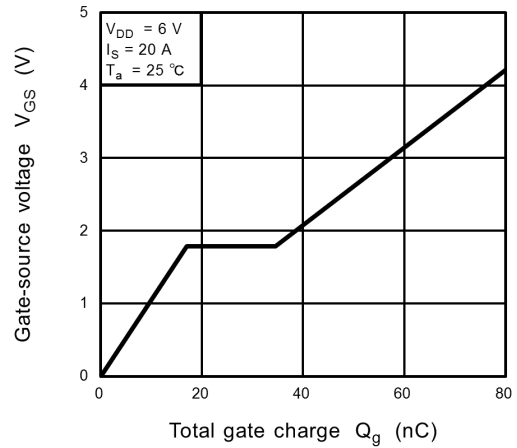


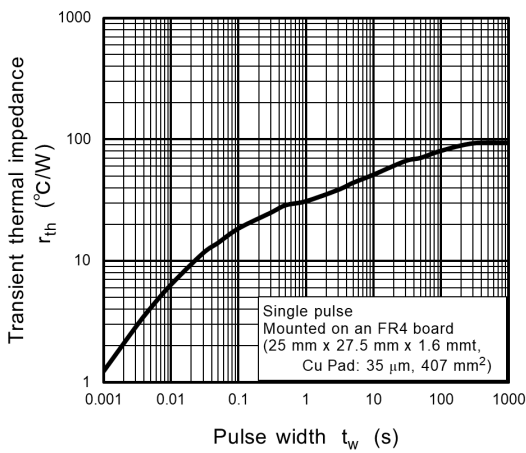
Fig. 9.6  $I_{GSS} - V_{GS}$



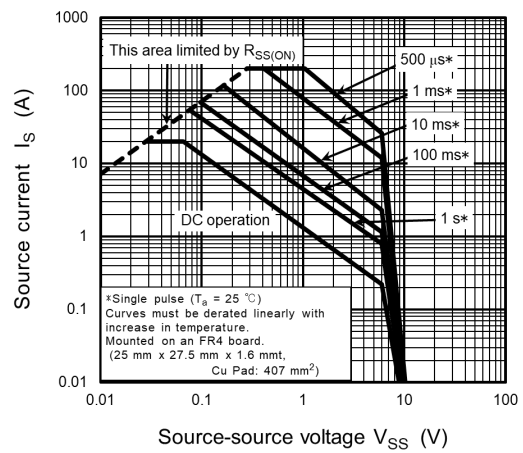
**Fig. 9.7**  $I_{SSS} - V_{SS}$

**Fig. 9.9**  $r_{th} - t_w$

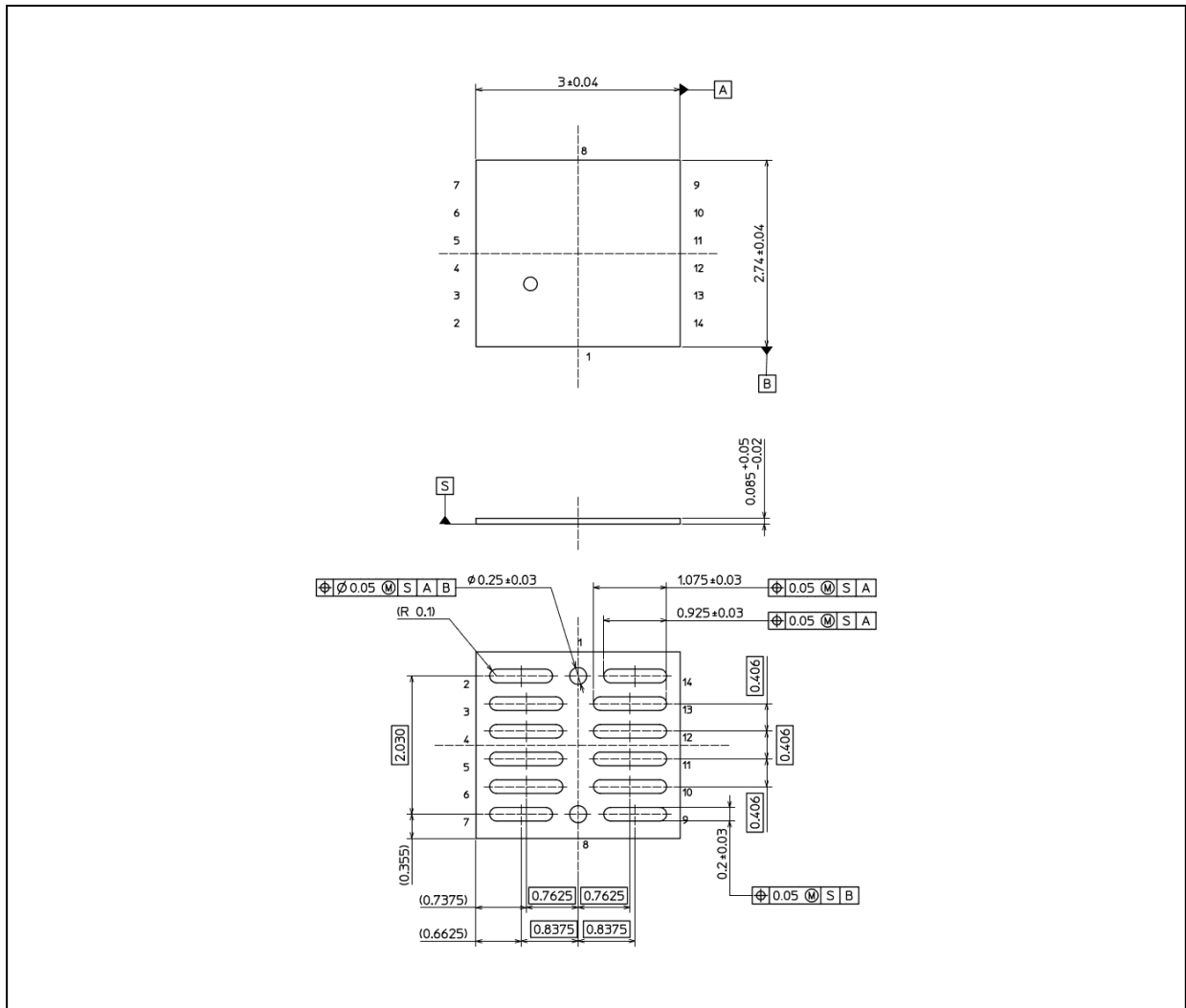


**Fig. 9.10** Safe Operating Area
