






Fig. 5.3.1 Switching Time Test Circuit






Fig. 7.1 I_D - V_{DS}




Fig. 7.3 R_{DS(ON)} - V_{GS}




Fig. 7.5 $R_{DS(ON)}$ - T_a




Fig. 7.2 I_D - V_{GS}




Fig. 7.4 R_{DS(ON)} - I_D




Fig. 7.6 V_{th} - T_a




Fig. 7.7 IDR - VDS




Fig. 7.9 Dynamic Input Characteristics




Fig. 7.11 rth - tw




Fig. 7.8 C - V_{DS}




Fig. 7.10 t-I_D




Fig. 7.12 P_D - T_a




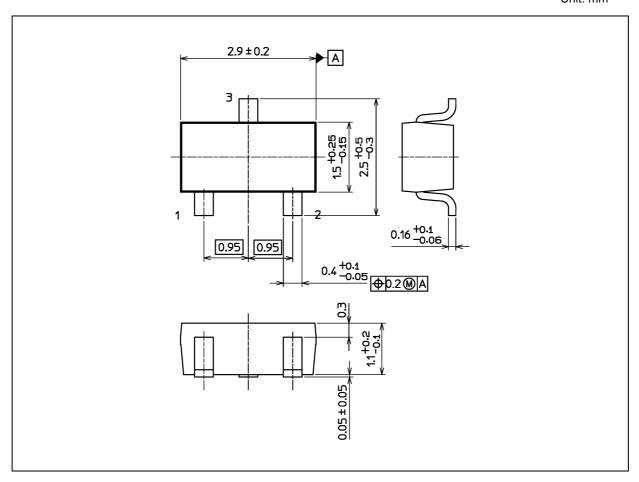
Fig. 7.13 Safe Operationg Area
