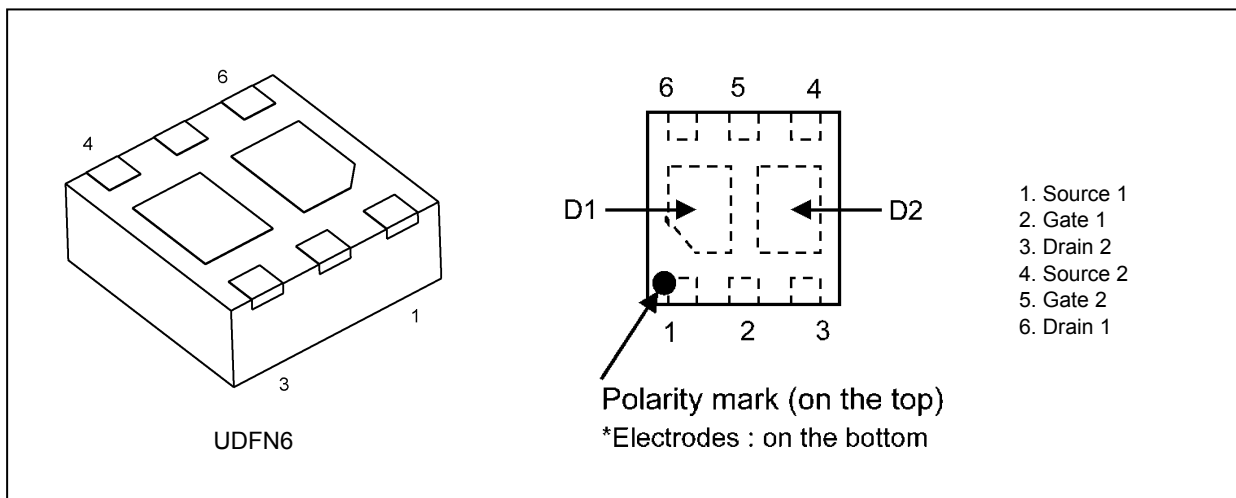

Note 1: If a reverse bias is applied between gate and source, this device enters  $V_{(BR)DSX}$  mode. Note that the drain-source breakdown voltage is lowered in this mode.

Note 2: Let  $V_{th}$  be the voltage applied between gate and source that causes the drain current ( $I_D$ ) to below (1 mA for this device). Then, for normal switching operation,  $V_{GS(ON)}$  must be higher than  $V_{th}$ , and  $V_{GS(OFF)}$  must be lower than  $V_{th}$ . This relationship can be expressed as:  $V_{GS(OFF)} < V_{th} < V_{GS(ON)}$ .  
Take this into consideration when using the device.

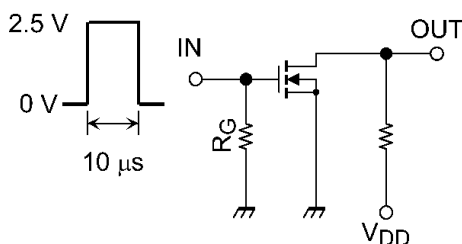


Fig. 5.3.1 Switching Time Test Circuit

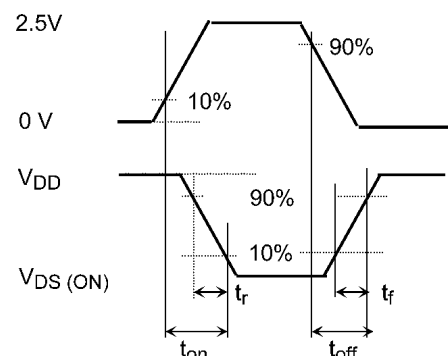


Fig. 5.3.2 Input Waveform/Output Waveform

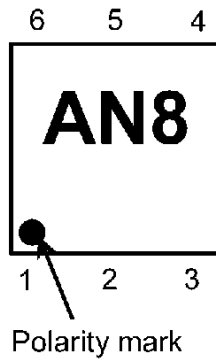

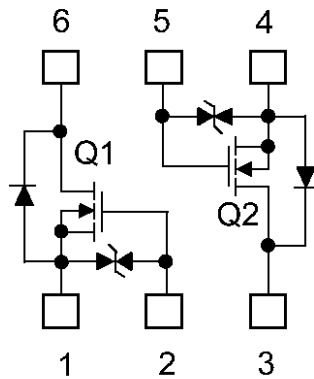

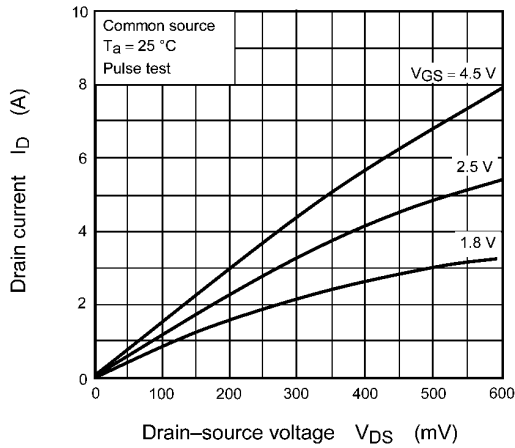

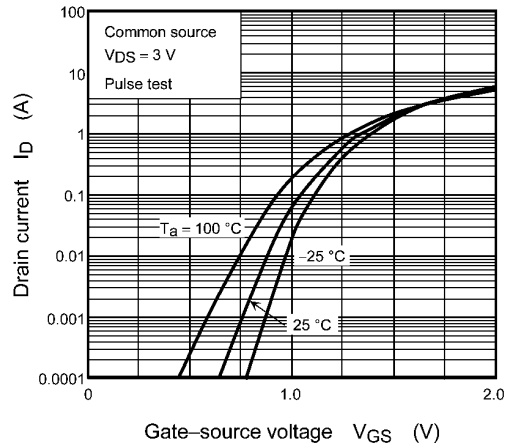

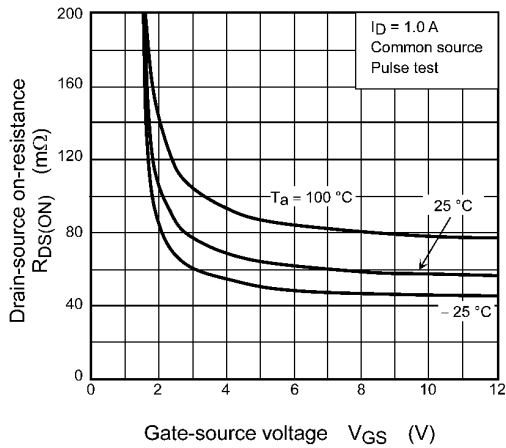

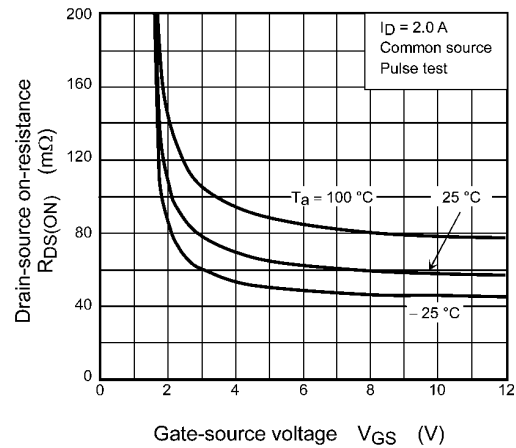
**Fig. 8.1**  $I_D - V_{DS}$



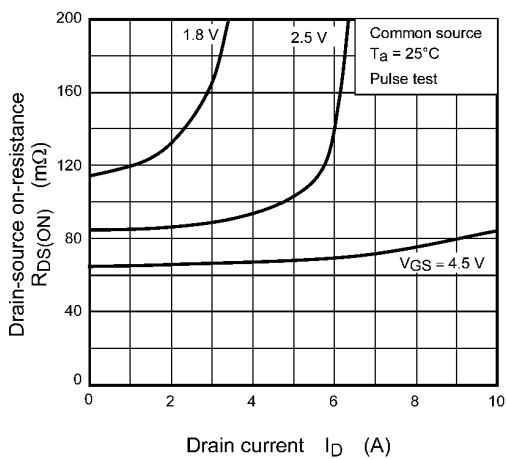
**Fig. 8.2**  $I_D - V_{GS}$



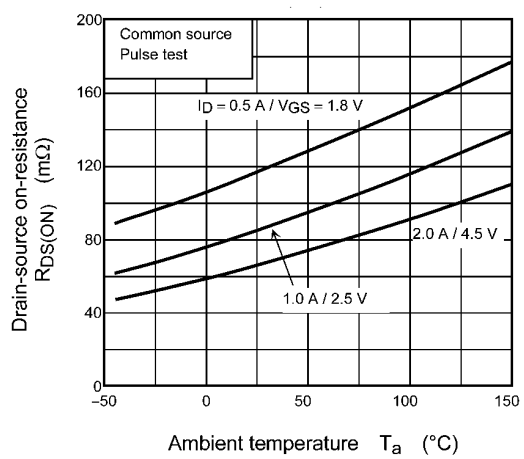
**Fig. 8.3**  $R_{DS(ON)} - V_{GS}$



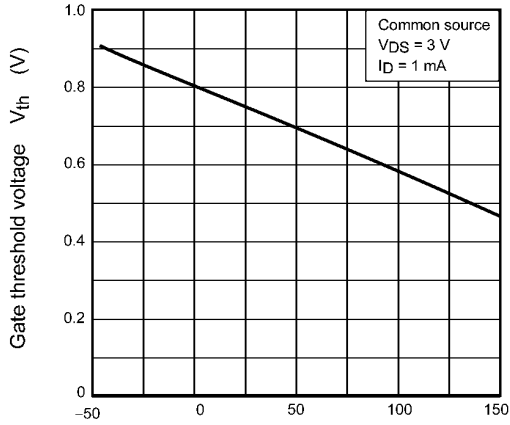
**Fig. 8.4**  $R_{DS(ON)} - V_{GS}$



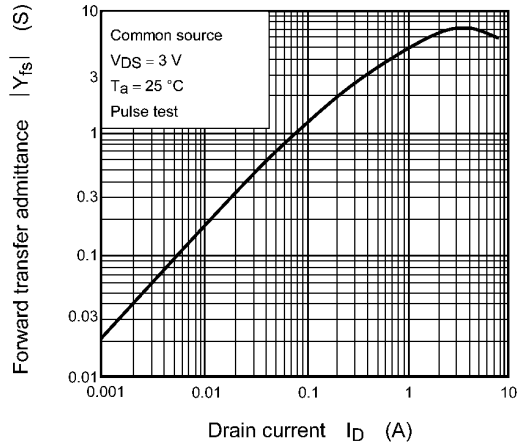
**Fig. 8.5**  $R_{DS(ON)} - I_D$



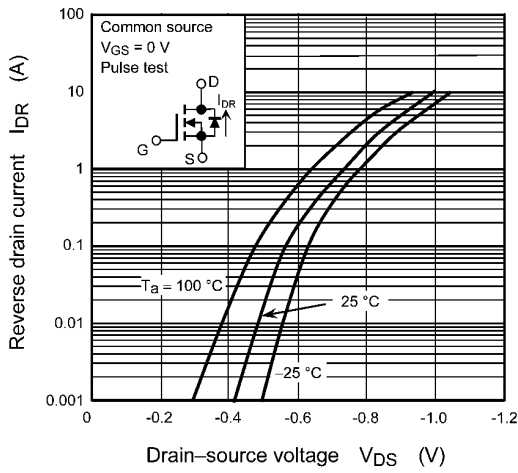
**Fig. 8.6**  $R_{DS(ON)} - T_a$



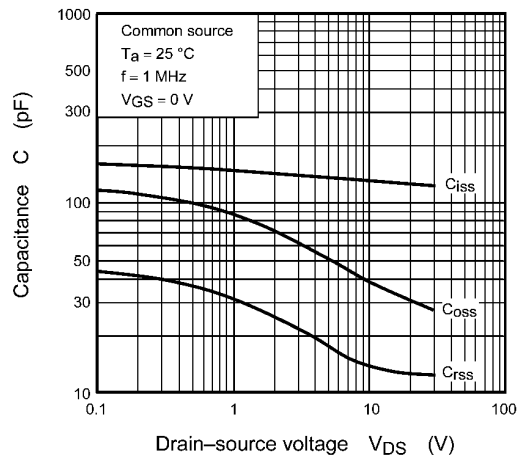
**Fig. 8.7  $V_{th} - T_a$**



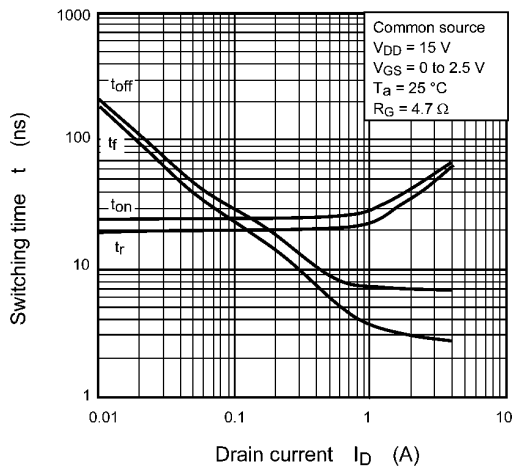
**Fig. 8.8  $|Y_{fs}| - I_D$**



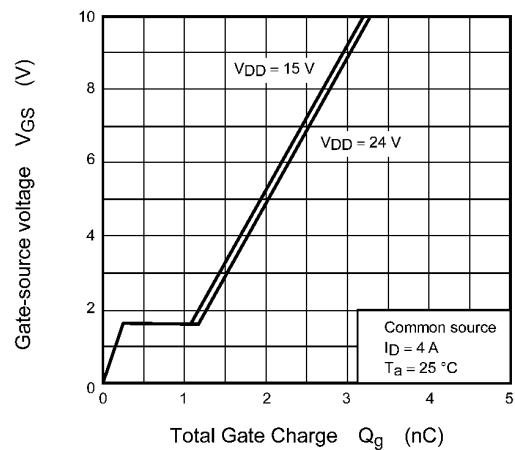
**Fig. 8.9  $I_{DR} - V_{DS}$**



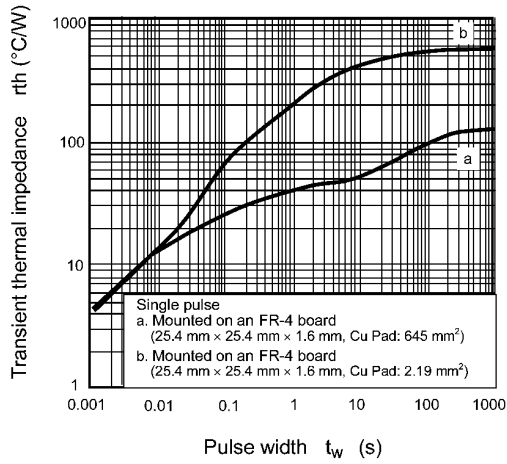
**Fig. 8.10  $C - V_{DS}$**



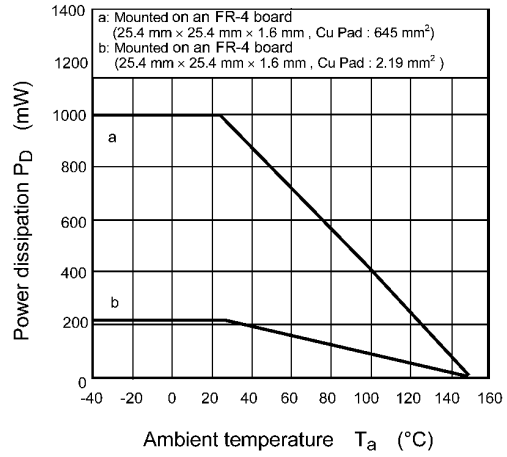
**Fig. 8.11  $t - I_D$**

**Fig. 8.13**  $r_{th} - t_w$

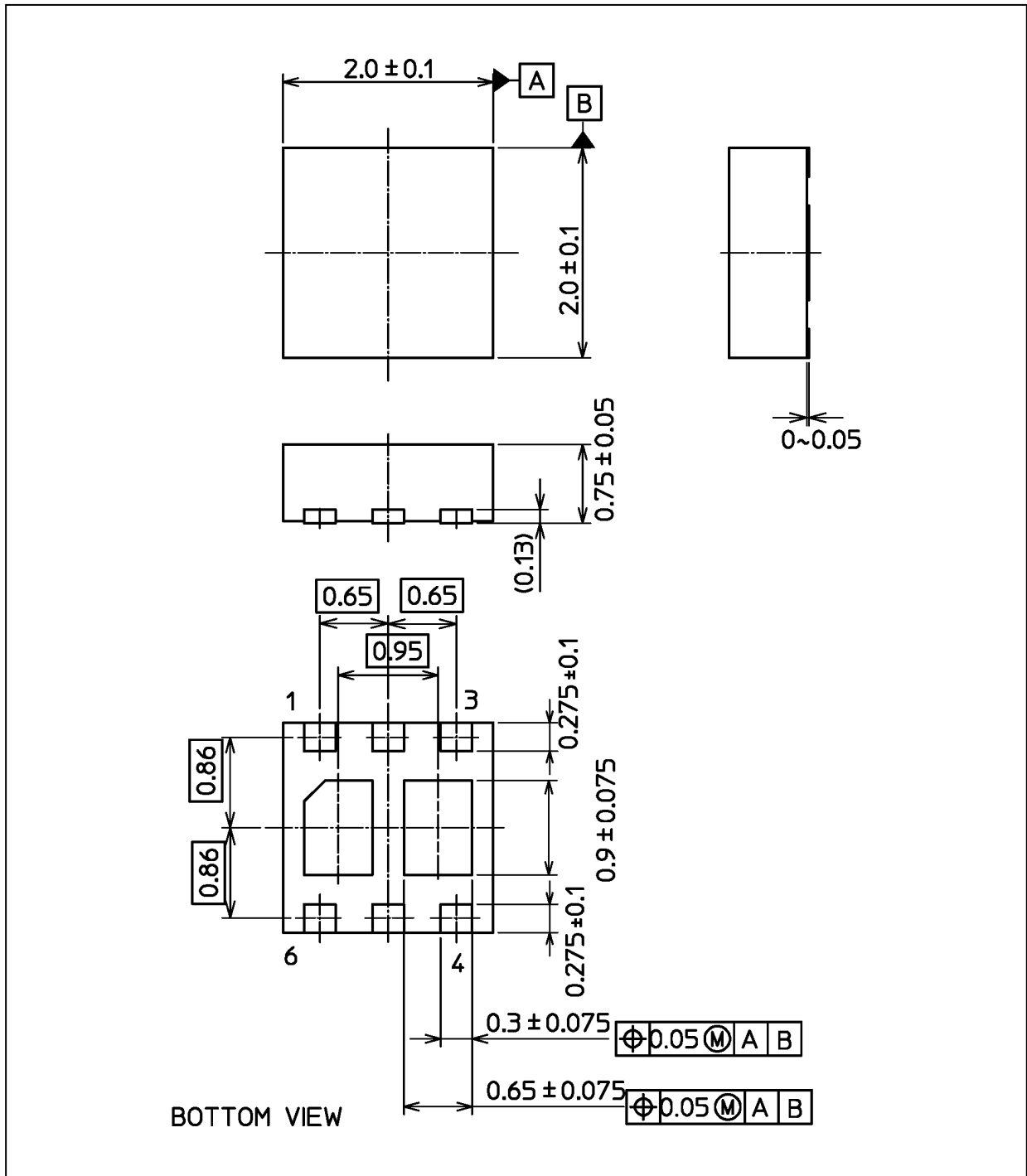


**Fig. 8.14**  $P_D - T_a$
