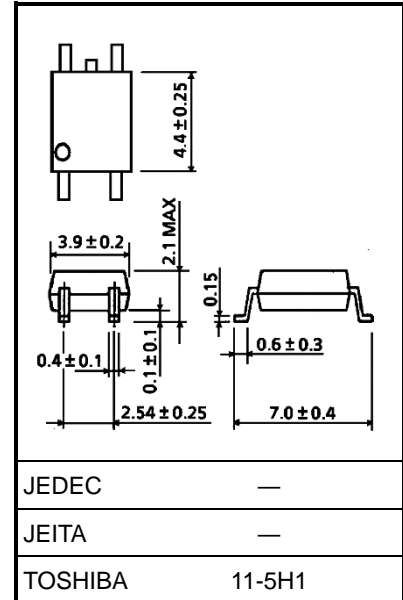

The TLP176D is suitable for modem and PBX applications which require space savings.

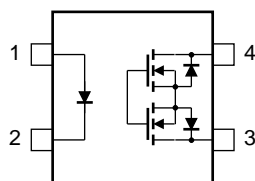

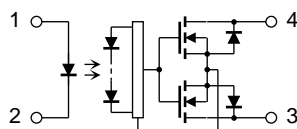
