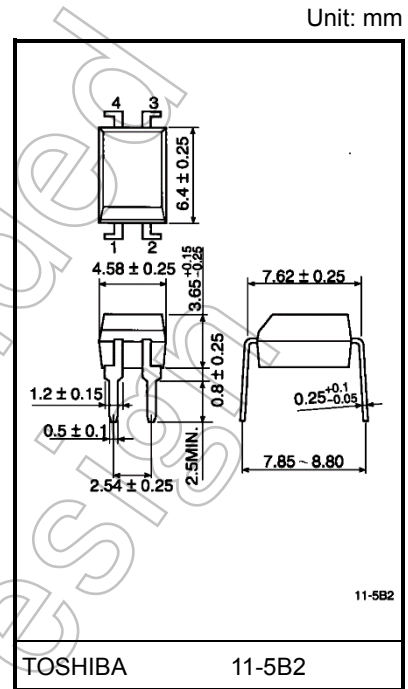

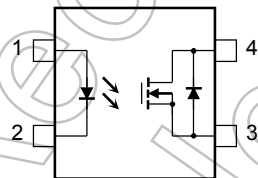
The TLP225A is MOSFET output and can control a current of 0.5 A which is suitable for DC output module.
