





#### Fig. 5.1 Device Mounted on a Glass-Epoxy Board (a)




Fig. 5.2 Device Mounted on a Glass-Epoxy Board (b)









Fig. 8.11 V<sub>(BR)DSS</sub> - T<sub>a</sub>






Fig. 8.14 Dynamic Input/Output Characteristics




Fig. 8.16 Test Circuit/Waveform






Fig. 8.15 EAS - Tch(Guaranteed Maximum)


